Influence of Aerobic Training and Combinations of Interventions on Cognition and Neuroplasticity after Stroke

Stroke often aggravated age-related cognitive impairments that strongly affect several 79 80 aspects of quality of life. However, few studies are, to date, focused on rehabilitation 81 strategies that could improve cognition. Among possible interventions, aerobic training 82 is well known to enhance cardiovascular and motor functions but may also induce 83 beneficial effects on cognitive functions. To assess the effectiveness of aerobic training 84 on cognition, it seems necessary to know whether training promotes the neuroplasticity 85 86 in brain areas involved in cognitive functions. In the present review, we first explore 87 in both human and animal how aerobic training could improve cognition after stroke 88 by highlighting the neuroplasticity mechanisms. Then, we address the potential effect 89 of combinations between aerobic training with other interventions, including resistance 90 exercises and pharmacological treatments. In addition, we postulate that classic 91 92 recommendations for aerobic training need to be reconsidered to target both cognition 97 and motor recovery because the current guidelines are only focused on cardiovascular 94 and motor recovery. Finally, methodological limitations of training programs and cognitive 95 function assessment are also developed in this review to clarify their effectiveness in 96 97 stroke patients. 98

INTRODUCTION

Sedentary older adults are prone to cardiovascular diseases, such as stroke (Bherer et al., 2013), 104 which occurs when blood flow is interrupted to a part of the brain. This trauma leads to severe 105 motor dysfunctions and it may also aggravate cognitive impairments resulting from normal aging 106 (Rafnsson et al., 2007, 2009; Deary et al., 2009; Waldstein and Wendell, 2010). Indeed, stroke 107 survivors have more than twice the risk of subsequently developing dementia compared with people 108 who have never had a stroke (Tatemichi et al., 1992; Patel et al., 2002). For instance, a stroke situated 109 on the left hemisphere might disturb language and comprehension, which reduce the ability to 110 communicate (Karbe et al., 1990; Pirmoradi et al., 2016). When the right hemisphere is affected, the 111 intuitive thinking, reasoning, solving problems as well as the perception, judgment and the visual-112 spatial functions could be impaired (Tatemichi et al., 1994; Patel et al., 2002; Cumming et al., 2012; 113 Sun et al., 2014b; Harris et al., 2015; Tiozzo et al., 2015; Save-Pédebos et al., 2016). It makes thus 114

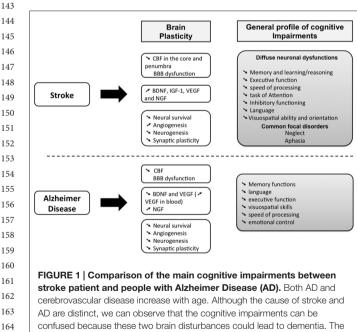

difficult for patients to locate objects, walk up or down stairs 115 or get dressed. Consequently, cognitive disorders are one of 116 the strongest predictor of the inability to return to work, that 117 contribute to the socioeconomic burden of stroke (Kauranen 118 et al., 2013). However, stroke-induced cognitive disorders are 119 120 often underestimated relative to motor impairments because they are confused with pre-existing symptoms of age-related mild 121 cognitive impairments or Alzheimer's Disease (AD; Figure 1; 122 Sun et al., 2014b; Corriveau et al., 2016). Furthermore, cognitive 123 impairments are frequently associated with poor motor recovery 124 (Patel et al., 2002; Lesniak et al., 2008; Rand et al., 2010). It 125 126 suggests that stroke-induced cognitive dysfunctions and brain 127 plasticity might also affect the stability, flexibility and learning of complex movements (e.g., locomotion, unimanual aiming, 128 bimanual coordination), in which cognitive resources are highly 129 involved as it was already observed in older adults (Temprado 130 et al., 1999, 2013; Sleimen-Malkoun et al., 2012, 2013; Cohen 131 et al., 2016). 132

It is thus of great importance to find effective interventions 133 to induce both motor and cognitive improvement after stroke. 134 In this respect, it is now widely established that aerobic training 135 enhances cardiorespiratory fitness, muscular endurance and 136 functional recovery of stroke patients resulting in a higher quality 137 of life (Ivey et al., 2005; Macko et al., 2005; Marsden et al., 138 2013). Over the past few years, few studies have also shown 139 that aerobic training could improve cognitive functions and 140 promotes neuroplasticity in stroke patients (Quaney et al., 2009; 141 142



AD are distinct, we can observe that the cognitive impairments can be confused because these two brain disturbances could lead to dementia. The hypothesis of vascular contributions to cognitive impairment and dementia (VCID) is that cognitive impairments result from cerebrovascular damages and thus cover the effect of AD, cerebrovascular diseases, including stroke, on cognition (Corriveau et al., 2016). It can be added that more stroke is severe, more the risk of dementia is high. Micro-infarct, silent stroke or small vessel insults are often related to mild cognitive impairments (see also McDonnell et al., 2011; Cumming et al., 2012). However, the outcomes on brain plasticity is specific to each brain disorders (Sopova et al., 2014).

Rand et al., 2010; Wogensen et al., 2015). In support of these 172 observations, animal studies have revealed that such training 173 effects on cognitive functions might be partially mediated by 174 the release of neurotrophic factors that promotes angiogenesis, 175 neurogenesis, synaptogenesis and synthesis of neurotransmitters 176 that could not be directly investigated at central level in humans 177 (Churchill et al., 2002; Cotman et al., 2007; Lövdén et al., 178 2010). However, despite firm evidence supporting the use of 179 aerobic exercise for stroke patients, the mechanisms underlying 180 neuroplasticity that is at origin of cognitive and motor recovery 181 in stroke patients remain unknown. 182

In the present review, we first examine how aerobic 183 training might play a beneficial role on cognition after 184 stroke. In particular, we highlight the influence of aerobic 185 training on neuroplasticity in both human and animal. We 186 also discuss whether additional rehabilitation strategies and/or 187 pharmacological treatments could accentuate neuroplasticity and 188 consequently, the recovery of cognitive functions. In addition, we 189 present the different exercise parameters that should be taken 190 into account in aerobic training, namely: intensity, duration, 191 frequency (number of session per week) and types of exercise as 192 well as timing of training initiation after stroke onset. Indeed, 193 they might differ in their effectiveness to improve cognition 194 and motor functions. Therefore, classic recommendations for 195 aerobic exercise are reconsidered to target cognition as well as 196 motor and cardiovascular functions. Finally, we discuss about the 197 methodological limitations that may hamper the understanding 198 of aerobic training effects on cognition both in human and 199 animal studies. 200

INFLUENCE OF AEROBIC TRAINING ON NEUROPLASTICITY AND COGNITIVE FUNCTIONS

Cognitive disorders (i.e., executive function and/or information 207 processing speed), motor dysfunctions (i.e., locomotion, 208 balance and strength impairments) and cardiorespiratory 209 fitness weakness are frequently observed in both elderly and 210 stroke people. However, the severity of these impairments is 211 212 exacerbated due to ischemia in older stroke patients (Gordon et al., 2008; Billinger et al., 2012; Cumming et al., 2013; Harada 213 et al., 2013). Moreover, some neural mechanisms involved 214 in cognitive disorders appear to be close between aging and 215 cerebral ischemia. Specifically, a decrease of neurotrophic factor 216 release (Ang et al., 2003; Silhol et al., 2005; Chae and Kim, 2009) 217 or an abnormal level of oxidative stress and inflammation in 218 hippocampus have been observed in both population (Joseph 219 et al., 2005; Wang et al., 2007). In addition, cerebral blood flow 220 decreases in ischemic region (Cupini et al., 2001; Zhang et al., 221 2013a) while the reduced vessel density in aging brain leads to 222 an overall reduced blood flow and oxygenation into the brain 223 (Petcu et al., 2010). Therefore, promoting angiogenesis might be 224 critical for these two populations. 225

In numerous studies, it was demonstrated that aerobic 226 training could induce beneficial effects on brain plasticity 227 and associated cognitive functions as well as motor and 228

cardiorespiratory functions in aging population (Patel et al., 229 2002; McAuley et al., 2004; Kramer and Erickson, 2007; Lesniak 230 et al., 2008; Erickson and Kramer, 2009). Thus, it can be 231 hypothesized that such training could lead to similar positive 232 effects on cognitive functions in stroke patients. In the following, 233 we present evidence supporting this hypothesis in both older 234 adults and animal studies. Then, on the basis of the few available 235 studies in the literature, we made an overview of the effects of 236 aerobic training on cognitive functions in people and animal with 237 cerebral ischemia. 238

240 Studies on Healthy Older Adults

241 It is now recognized that aerobic training stimulates the positive plasticity of the aging brain. Such exercise-related plasticity 242 mediates the maintenance, or even the increase, of cognitive 243 performance as indicated by the improvement of executive 244 245 functions and long-term memory. Such enhancements were observed in spite of the heterogeneity of methods, subject 246 characteristics, training parameters or cognitive tasks used in 247 the related studies (Colcombe and Kramer, 2003). Thanks to 248 the use of sophisticated brain imaging technologies, cerebral 249 250 modifications induced by aerobic training has been observed 251 at both structural (i.e., increase in white and gray matter volumes and changes in synaptic connections) and functional 252 (i.e., changes in brain activation patterns) levels (Churchill et al., 253 2002; Cotman and Berchtold, 2002; Colcombe and Kramer, 254 255 2003; Colcombe et al., 2004a,b, 2006; McAuley et al., 2004; 256 Erickson and Kramer, 2009; Greenwood and Parasuraman, 2010; 257 Voss et al., 2010a,b). For instance, using functional magnetic 258 resonance imagery (fMRI), it was shown that elderly people aerobically trained displayed a higher activation of brain areas 259 involved in attentional control and inhibitory functioning, 260 while a reduced activation is observed in brain areas involved 261 in behavioral conflict (Colcombe et al., 2004a). Additionally, 262 263 12-week of both bike and treadmill aerobic training increases the hippocampal and anterior cingulate cortex cerebral blood 264 flow and also an immediate and delayed verbal memory. Such 265 increase is closely related to neuroregeneration (Petcu et al., 266 2010; Chapman et al., 2013; Duzel et al., 2016). This result 267 268 was recently reinforced by showing with the use of gadoliniumbased perfusion imaging (3 Tesla MRI) that aerobic fitness 269 improvement in healthy older adults is correlated with changes in 270 hippocampal perfusion and volume that were positively related 271 272 to changes in recognition memory and early recall for complex 273 spatial objects (Maass et al., 2015).

274 Circulating neurotrophic factor measurements such as brain-275 derived neurotrophic factor (BDNF), insulin-like growth factor-1 (IGF-1) and vascular endothelial growth factor (VEGF; see 276 277 below for details) might also explain the influence of aerobic 278 training on neuroplasticity and cognition in Human but this point remains controversial (Cotman et al., 2007). In the one 279 hand, few studies have observed an increase in serum BDNF level 280 in older adults after 1-year of aerobic training that was correlated 281 282 with an increase in hippocampal volume and improvement in spatial memory performance as well as in executive function 283 284 (Erickson et al., 2012; Leckie et al., 2014). Specifically, Leckie et al. (2014), revealed that the oldest subjects exhibited the greatest 285

increase in circulating BDNF levels and improvement in task 286 performance after training. This observation suggests that age 287 affects BDNF serum levels (Leckie et al., 2014). On the other 288 hand, numerous studies did not provide robust evidence for 289 enhancement of these neurotrophic factors after several weeks 290 of training in aging people (Voss et al., 2013; Maass et al., 291 2015). For instance, serum BDNF, VEGF and IGF-1 level did 2.92 not increase after 12-month of aerobic or non-aerobic (stretching 293 exercises) training despite an increase of connectivity in the 294 temporal lobe between the bilateral parahippocampus and the 295 bilateral middle temporal gyrus (Voss et al., 2013). Recently, 296 Maass et al. (2015), confirmed these results by showing that no 297 difference in changes of circulating BDNF, VEGF and IGF-1 298 was observed after 3-month of treadmill (training group) or 299 progressive-muscle relaxation/stretching (control group) despite 300 an increase of hippocampal perfusion and volume (Maass et al., 301 2015). On the basis of these results, it was suggested that the 302 training-related improvement of cerebral perfusion could lead to 303 beneficial effects on neural function without any contribution of 304 growth factors. 305

These contradictory findings might result from limitations 306 associated with the circulating serum growth factor 307 measurements and training protocols. For instance, nutritional 308 status and changes in energy balance inducing by exercise 309 interventions might affect growth factor levels (Monteleone et al., 310 2004). Moreover, as it was previously mentioned (Coelho et al., 311 2013), studies presented different training durations and exercise 312 intensity and heterogeneous samples. Authors also included a 313 different proportion of females and/or males in their studies. 314 Such imbalance in gender composition of experimental groups 315 could have an effect of baseline serum BDNF that might hide 316 possible influence of aerobic training (Komulainen et al., 2008; 317 Driscoll et al., 2012). It has also been suggested that the variable 318 time-windows of circulating growth factor measurements and 319 the analysis techniques used for quantifying blood growth 320 factor levels could also affect the results and need to be clarified 321 (Maass et al., 2015). Finally, data from circulating growth factor 322 assessment should be interpreted with caution since no direct 323 relationships between circulating and brain growth factor levels 324 has been found in human. Studies on human only demonstrated 325 that peripheral BDNF was associated with cognitive performance 326 and cerebral structure integrity (Ventriglia et al., 2013). However, 327 it was also established in animal model that BDNF, VEGF and 328 IGF-1 might have the potential to cross the blood-brain barrier 329 (BBB) in both directions in the central nervous system (CNS; 330 Pan et al., 1998; Cotman et al., 2007). As an illustration, Karege 331 et al. (2002), demonstrated that serum BDNF was positively 332 correlated with cortical BDNF in rat model. In addition, 333 blocking the peripheral IGF-1 or VEGF access to the brain 334 impeded exercise-induced plasticity in the hippocampus (Karege 335 et al., 2002; Cotman et al., 2007). However, other studies have 336 shown in neurological disorders such as stroke and depression 337 that changes in regional brain BDNF levels are not associated 338 with changes of BDNF levels in peripheral blood (Elfving et al., 339 2010; Béjot et al., 2011). To date, it thus remains difficult to 340 clearly determine the real role of circulating growth factors on 341 cognitive function in older subjects. 342

Studies on Healthy Animals

Animal experiments could provide information about 344 neuroplasticity mechanisms at cellular level in brain areas 345 involved in cognitive functions. To date, three main 346 neurotrophic factors have been identified to contribute to 347 increase neuroplasticity after aerobic training: (i) the VEGF, 348 which is a protein whose main role is to stimulate angiogenesis; 349 (ii) the BDNF, which is a critical protein involved in brain 350 plasticity. Indeed, this neurotrophin mediates numerous 351 proteins expressions and molecular pathways, i.e., synapsin-I 352 and synpatophysin, both involved in synaptic transmission and 353 354 neurotransmitter release, C-AMP response element-binding 355 protein (CREB) and beta calcium/calmodulinedependent kinase II (β-CaMKII) both contributing in long-term potentiation 356 (LTP). BDNF thus promotes synaptic plasticity, neurogenesis 357 and neuronal survival within the hippocampus (Vaynman et al., 358 2004; Cassilhas et al., 2012); and (iii) the IGF-1, which is a 359 peptide that crosses the BBB and stimulates neurogenesis and 360 angiogenesis. These growth factors act together to promote 361 training-related benefits in brain plasticity and associated 362 cognitive functions. 363

It was found in adult rats that aerobic training induced-364 angiogenesis is associated with an increase in brain VEGF mRNA 365 and protein (Ding et al., 2006; Cotman et al., 2007). Moreover, 366 Swain et al. (2003), have proved that prolonged voluntary 367 exercise induced an increase of blood volume in the motor 368 cortex of 19% greater than control animals (Swain et al., 2003). 369 Angiogenesis needs to be promoted because some animal studies 370 371 have suggested that angiogenesis was closely linked to adult 372 neurogenesis and other neuroplasticity mechanisms (Pereira et al., 2007). 373

374 It was demonstrated that 8-week of aerobic training on treadmill induced an improvement in learning speed and 375 spatial learning. Authors suggested that these results could be 376 explained by an increase of hippocampal BDNF and IGF-1 377 and more precisely by the activation of BDNF/TrkB/β-CaMKII 378 pathway and to a lesser extent to IGF-1/IGF-1R/Akt pathway **O13** 379 (Cassilhas et al., 2012). Radák et al. (2001, 2006), indicated 380 that short- and long-term memory was improved after 8 381 weeks of regular swimming exercise in middle-aged rats (14-382 month-old). BDNF and nerve growth factor (NGF) expressions 383 were up-regulated as well as a reduction of accumulation 384 of reactive carbonyl derivatives that are known to damage 385 proteins, nucleic acids ad lipids (Radák et al., 2001, 2006). 386 Similarly, one study on aging rat model, induced by D-galactose 387 388 injection, has shown that 8-week of moderate aerobic training 389 treadmill could importantly increase both level of NGF and his receptor, the tyrosine kinase A (TrkA) in the hippocampus. 390 391 NGF/TrkA actives the phosphoinositide 3-kinase (PI3-K)/Akt 392 pathway that decreases apoptosis (Wiesmann and de Vos, 2001; Chae and Kim, 2009). Excessive reactive oxygen species (ROS) 393 production can also trigger apoptosis in brain areas such as 394 the hippocampus that contribute to neurodegenerative disorders 395 and cognitive function impairments in aging people. However, 396 397 moderate intensity training on treadmill (18 m/min, 30 min/day during 15 weeks) in middle-age female rats (12-month-old) 398 could enhance antioxidant defense system and thus induced a 399

neuroprotective effect in the hippocampus (Marosi et al., 2012). 400 Training also facilitated the release of metabolic proteins in 401 the hippocampus such as mitochondrial precursor of ornithine 402 aminotransferase and isocitrate deshydrogenase subunit alpha. 403 However, these results remain difficult to interpret because 404 authors suggested that alteration of mitochondrial proteins may 405 be either reflecting mitochondrial damage or adaptation to 406 mitochondrial dysfunction (Kirchner et al., 2008). 407

Studies on Stroke Patients

Only three studies investigated the role of aerobic training on 410 cognition in stroke patients (Table 1). Two of them indicated 411 that aerobic training might reduce cognitive disorders by 412 improving functional outcomes as well as motor learning by the 413 increase of information processing speed and implicit memory 414 while executive functions remain affected (Quaney et al., 2009; 415 El-Tamawy et al., 2014). However, patients did not preserve 416 long-term beneficial effects 8 weeks after the end of aerobic 417 training (Quaney et al., 2009). Contrary to what was observed in 418 healthy subject, an acute and short aerobic exercise on treadmill 419 (20 min; 70% of the heart rate reserve) did not induce cognitive 420 improvement in stroke patient while a slightly improvement of 421 the movement of upper-extremity was observed (Ploughman 422 et al., 2008). 423

Studies on Animal with Cerebral Ischemia

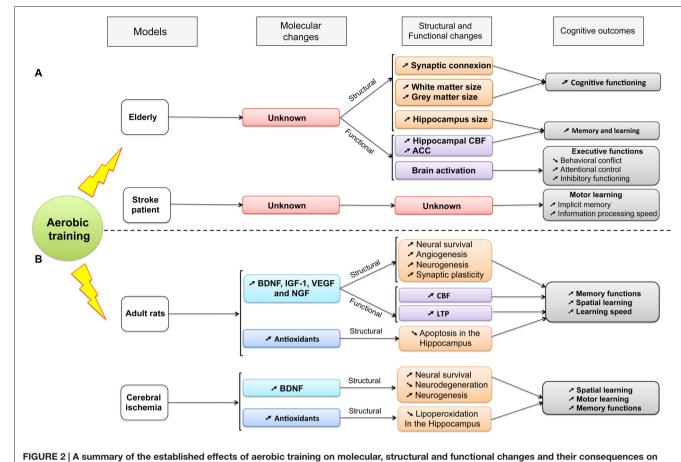


FIGURE 2 | A summary of the established effects of aerobic training on molecular, structural and functional changes and their consequences on cognitive functions (see details in the text). Different models are compared: aging and stroke in both (A) human and (B) animal populations. ACC, Anterior Cingulate Cortex; BDNF, Brain-Derived Neurotrophic Factor; CBF, Cerebral Blood Flow; IGF-1, Insulin Growth Factor-1; LTP, Long-term potentiation; NGF, Nerve Growth Factor; VEGF, Vascular Endothelial Growth Factor.

Consistent with healthy older animals, neuroplasticity can be 426 partially promoted by aerobic training through up-regulation 427 of the expression of BDNF, synapsin-I and post-synpatic 428 density protein 95 (PSD-95), also involved in LTP within 429 hippocampus (dentate gyrus, CA1 and CA3 areas) and by 430 increase of both CREB phosphorylation and newborn cell 431 survival (Luo et al., 2007; Shih et al., 2013). The beneficial 432 effect of training was reinforced when the activation of the 433 high affinity BDNF receptor, the TrkB, was blocked because 434 the function of BDNF was reduced and the exercise-induced 435 spatial learning enhancement was impeded (Griesbach et al., 2009). Thus, consistent with data collected within aging rodents, 437 it is supposed that BDNF-mediated pathway contributed to 438 explain the improvement of spatial memory performances after 439 cerebral ischemia. Furthermore, spatial memory performances 440 were positively correlated with an increase of both newborn 441 cell survival in bilateral dentate gyrus and restored microtubule-442 associated protein 2 (MAP2) density after cerebral ischemia 443 (Luo et al., 2007; Shimada et al., 2013). Treadmill training 444 might also protect against cognitive impairments in rats with 445 bilateral common carotid artery occlusion (CCAO) by reducing 446 the lipoperoxidation in the hippocampus through an increase 447 of antioxidant capacity and by improving the acquisition of a 448 spatial task as well as the performance for both retention and 449 working memory (Figure 2; Cechetti et al., 2012). In addition, 450 few weeks of treadmill training in rat with cerebral ischemia 451 increases the VEGF, and its regulatory protein, caveolin-1, and 452 improves the cerebral blood flow in ischemic region (Zhang et al., 453 2013a; Gao et al., 2014). However, no study has directly shown 454 that vascular changes could contribute to explaining the cognitive 455 disorders. 456

IS THE COMBINATION OF AEROBIC TRAINING WITH OTHER TYPES OF THERAPIES EFFECTIVE FOR IMPROVING COGNITION RECOVERY AFTER STROKE?

Combination with Other Rehabilitation Exercises

The question arises of whether different types of exercise could be combined to improve the effects that they could have separately. As reviewed by Chang et al. (2012), resistance exercise alone could positively impact selective cognitive functions in older adult such as information-processing speed, attention and several aspects of memory and executive functions (Chang et al., 2012). It was postulated that the main potential underlying mechanism for these benefits is based on resistance training-induced IGF-1 both in brain and blood circulation. Moreover, growing evidence have shown that the combination of aerobic and resistance training induced superior beneficial effect on cognition than aerobic exercise alone in aging population (Colcombe and Kramer, 2003). In this way, the association between resistance and aerobic training might be a potential strategy to further facilitate the

cognitive function recovery in stroke population. However, few studies have been conducted to test this attractive hypothesis (Rand et al., 2010; Kluding et al., 2011; Marzolini et al., 2013). Results indicated that combination of aerobic training and lower extremity muscle strengthening improved executive functions, attention and voluntary motor control (Kluding et al., 2011). This is consistent with the study carried out by Marzolini et al. (2013), in which 6 months of both aerobic training at moderate intensity associated with resistance exercises induced improvements in the Montreal Cognitive Assessment (MoCA) scores in subdomain of attention/concentration and visuospatial/executive functioning (Marzolini et al., 2013). Another study on chronic stroke patients combining aerobic training with stretching, balance and task-specific exercises as well as sessions of recreation time has shown an improvement in verbal memory and cognitive flexibility but did not promote executive function (Rand et al., 2010). However, since the isolated effects of resistance and aerobic training were not compared with the combination of both of them, it remains difficult to ensure that such combination induces superior beneficial effects on cognition than aerobic intervention alone after stroke. It should also be noticed that the neuroplasticity associated with cognition

recovery after combination of aerobic and other rehabilitation
strategies has not been investigated in both human and animal
stroke studies.

⁸⁰³ Combination of Aerobic Training ⁸⁰⁵ with Pharmacological Treatments

Currently, both aerobic and behavioral training have been 806 807 shown to improve cognition on stroke patient but it remains 808 insufficient to induce total recovery (Quaney et al., 2009; 809 Cherry et al., 2014). Thus, it seems crucial to find new 810 strategy combinations including aerobic exercise to amplify 811 the effects on cognition. Many pharmacological treatments are possible candidates to improve cognitive function after stroke by 812 stimulating brain plasticity. For instance, the drug memantine, 813 used for the treatment of moderate to severe dementia of the 814 815 Alzheimer's type, could increase synaptic plasticity and LTP and decrease overactivation of N-methyl-D-aspartate-type glutamate 816 receptors (NMDA-r) in order to limit excitotoxic neuronal 817 death (Martin and Wang, 2010; Berthier et al., 2011). Other 818 substances, like citicoline, an intermediate in the generation of 819 820 phosphatidylcholine from choline, could increase the level of 821 acetylcholine and dopamine as well as decrease infarct volume in animal model with cerebral ischemia (Alvarez-Sabín and Román, 822 2011). 823

824 To date, only the intravenous (IV) recombinant tissue 825 plasminogen activator (rt-PA) was approval by the USA Food 826 and Drug Administration for the treatment of acute ischemic stroke in human (Marshall, 2015). The rt-PA is focused on 827 828 thrombolytic events and could reduce the infarct volume (Nys et al., 2006) by restoring cerebral blood flow and oxygen supply to 829 830 ischemic brain tissue (Thompson and Ronaldson, 2014). When rt-PA is administrated within the first 3 h after stroke, it could 831 improve clinical outcomes and activities of daily life from 3, 832 6 and 12 months (Kwiatkowski et al., 1999; Nys et al., 2006; 833 Murao et al., 2014). However, the effects of rt-PA administration 834 during the first 24 h on cognitive functions are limited to aphasia 835 that is explained by the reperfusion of language areas (only 836 for one-third of patient; Nys et al., 2006; Hajjar et al., 2013; 837 838 Kremer et al., 2013). Only one study used rt-PA in combination with physical activity during leisure-time. Results showed that 839 combination of the 2 strategies did not accentuate the cognitive 840 and physical improvements compared to rt-PA alone after 841 842 3 months (Decourcelle et al., 2015).

843 In preclinical study, L-deprenyl is a pharmacological 844 treatment used to decrease ROS known to contribute to 845 neuronal cell death in the ischemic core following permanent middle cerebral artery occlusion in mice (Unal et al., 2001). 846 847 This substance has already shown the clinical effectiveness on cognitive functions in the elderly human with AD (Wilcock 848 et al., 2002). L-deprenyl generates an amphetamine-like effect 849 by acting on the release of dopamine and hampering its 850 reuptake that contribute to the modulation of both attention and 851 852 executive functions (Table 1; Bartolo et al., 2015). After stroke, 853 combination of both L-deprenyl and standard rehabilitation including physiotherapy, cycle arm-ergometer training and 854 occupational therapy during 6 weeks showed an improvement 855

of logical memory, visual selective attention and non-verbal 856 reasoning (Bartolo et al., 2015). However, this study did not 857 compare the effect of such combination with the L-deprenyl 858 treatment effect or the standard rehabilitation alone. Therefore, 859 it remains difficult to postulate that the combination of 860 these two strategies reinforced the cognitive recovery. In rat 861 model, D-amphetamine administration combined to locomotor 862 training enhances locomotor recovery after cortical injury 863 (Feeney et al., 1982; Ramic et al., 2006). Moreover, other 864 study assessed the effect of D-amphetamine administration 865 combined with functional rehabilitation and physical therapy 866 alone on cognitive memory performance and motor recovery 867 after embolic stroke. Results showed that D-amphetamine with 868 functional rehabilitation was more effective to improve cognitive 869 performance than training alone, especially for memory, but 870 the latter could improve fine motor performance (Rasmussen 871 et al., 2006). By contrast, it was found in stroke patient that the 872 combination of unique training session of-lower-extremity 873 stability platform task, upper-extremity simulated feeding 874 task and declarative learning—with D-cycloserine treatment 875 did not accentuate the effect of motor and cognitive training 876 (Cherry et al., 2014). This agent is already known to improve 877 both motor and cognitive functions through increasing LTP in 878 the hippocampus by regulating NMDA-r (Yaka et al., 2007). 879 Cherry et al. (2014) postulated that an unique training session 880 is not enough to amplify pharmacological treatment and that 881 D-cycloserine could not act on the reduced NMDA-r function, 882 and thus, on the motor task learning after stroke. 883

Finally, the review of literature suggests that no efficient 884 combination between pharmacological treatments and training 885 has yet found to improve recovery on cognitive functions. 886 However, several combinations of pharmacological treatments 887 and aerobic training have proven effectiveness on motor 888 recovery after cerebral ischemia (Pin-Barre and Laurin, 2015). 889 For example, the combination of both S-nitrosoglutathione 890 and training accentuated neuroplasticity (reduce excitotoxicity, 891 inflammation and protect BBB integrity) and motor recovery 892 (Sakakima et al., 2012). Future studies should investigate 893 the effects of these types of associations on cognitive 894 recovery. 895

MOTOR VS. COGNITIVE FUNCTION RECOVERY: CAN AEROBIC TRAINING SIMILARLY FACILITATE BOTH?

Currently, the recommendations for the use of aerobic 902 training after stroke were only established according to the 903 effectiveness of endurance programs on cardiovascular and 904 motor functions (Pang et al., 2013; Billinger et al., 2014). 905 The cognitive outcomes are thus not taken into account 906 for prescribing physical exercise. However, several findings 907 arising from rodent studies indicate that the most appropriate 908 intensity, the optimal timing to initiate training and the exercise 909 mode (type of exercise) for improving motor performance 910 might be different to improve cognitive function and motor 911 recovery. 912

⁹¹³ Cognitive Performance Improvement ⁹¹⁴ by Aerobic Training

915 916 Exercise Intensity

Low-intensity aerobic training seems to be more effective than 917 high-intensity training to promote cognitive health. Indeed, 918 animal studies have shown that low-intensity training induced 919 superior positive effects on spatial learning task in a water 920 maze test and on both object recognition and location tasks 921 than intense training (Shih et al., 2013; Shimada et al., 2013). 922 Such cognitive task improvements were concomitant with an 923 increase in plasticity-related proteins such as the increase of 924 hippocampal BDNF level, synapsin-I as well as the number of 925 dendritic spines and the number of neurons in the ipsilateral 926 dentate gyrus (Shen et al., 2013; Shih et al., 2013; Shimada 927 et al., 2013). It was mainly explained by the fact that, compared 928 to low-intensity exercise, the high-intensity exercise induced 929 higher levels of stress-hormone, which might downregulate 930 BDNF level in hippocampus (Schaaf et al., 1999; Soya et al., 931 2007). Nevertheless, caution is required concerning the chosen 932 running intensity. Indeed, the speed, fixed to 20-22 m/min, was 933 considered as "high" intensity in Shih and Shimada's studies 934 (Shih et al., 2013; Shimada et al., 2013) while others have 935 classified such range of speed as moderate intensity (Sun et al., 936 2008; Ni et al., 2012). Therefore, the real influence of exercise 937 intensity based on physiological parameters (for example, lactate 938 threshold or VO_{2peak}) on cognitive recovery remains to be further 939 investigated (see "Methodological Considerations" Section). 940

Timing of Training Initiation

Late exercise, beginning after the first week post-brain injury, 943 is more effective than early exercise (starting during the first 944 week) to improve cognitive functions. Indeed, spatial learning 945 and retention were better improved with the late training and 946 was associated with the upregulation of BDNF (Griesbach et al., 947 2004; Clark et al., 2008). Voluntary running wheel training, 948 starting 1 week after transient focal cerebral ischemia in mice, 949 promoted neurogenesis in the adult dentate gyrus and spatial 950 memory rebuilding (Luo et al., 2007). Interestingly, the Schmidt 951 meta-analysis indicated that a start of skilled forelimb training 952 from days 1 to 5 post-injury was more effective to improve 953 cognitive function compared to late training (Bland et al., 2000; 954 Wurm et al., 2007; Schmidt et al., 2014). It might be suggested 955 that motor skilled training might start before aerobic training to 956 improve cognitive functions. 957

959 Forced vs. Voluntary Training

The training mode might also influence the neuroplasticity 960 961 underlying cognitive performance. Some studies have recently 962 demonstrated that involuntary exercise (functional electrical stimulation), forced (treadmill) and voluntary (running wheel) 963 training have similar beneficial effects on cognitive function 964 after cerebral ischemia as indicated by improvement of both 965 object recognition and location tests (Lin et al., 2015). 966 967 Moreover, these three training regimens enhanced the levels of synapsin I, synaptophysin, PSD-95, MAP-2 and Tau protein 968 in the hippocampus. It was confirmed by a previous study on 969

healthy rats where 6 weeks of forced swimming or voluntary 970 running resulted in similar increase of hippocampal BDNF level 971 and in similar effect on learning capabilities and short/long 972 term memories (Alomari et al., 2013). Nevertheless, other 973 studies indicated divergent results. On one side, Haves et al. 974 (2008), demonstrated that, after 2-h of middle cerebral artery 975 occlusion, forced treadmill training reduced infarct volume and 976 increased the gene expression of heat shock proteins (Hsp), 977 in particular the 27 kDa Hsp and the 70 kDa Hsp mRNA 978 than voluntary exercise despite higher corticosterone level. 979 The Hsp acts in the brain as molecular chaper ones with 980 neuroprotective activities (Hayes et al., 2008). Other authors 981 indicated that 12 weeks of forced treadmill training could 982 protect against cognitive and biochemical impairments caused by 983 CCAO in rat (Cechetti et al., 2012). Similar results were found 984 after whole-brain irradiation where forced running training 985 reduced the neurocognitive deficits but also the hippocampal 986 neurogenesis impairments, i.e., the down-regulation of BDNF-987 mediated pathway (including TrkB receptors, protein kinase B 988 (Akt) and CREB, for example; Ji et al., 2014). On other side, some 989 authors indicated that voluntary exercise is the most effective 990 training in up-regulating the hippocampal BDNF level (Luo 991 et al., 2007; Ke et al., 2011). Indeed, Ke et al. (2011), compared 992 the effect of voluntary, involuntary and forced training after 993 cerebral ischemia in rat. Results indicated that 7-day intervention 994 of voluntary training induced higher level of BDNF in the 995 hippocampus than the other modes (Ke et al., 2011). Such 996 divergent results might be attributable to variable experimental 997 designs. 998

Motor Performance Improvement by Aerobic Training

Exercise Intensity

To date, post-stroke guidelines recommend moderate-intensity 1004 continuous aerobic training to improve aerobic capacity and 1005 motor recovery (40-80% of the maximum heart rate reserve; 1006 3-5 sessions/week; 20-60 min/session). However, it was 1007 demonstrated that high-intensity exercise could improve aerobic 1008 fitness by increasing the peak oxygen uptake (VO_{2peak}) and 1009 6-min walk performances, that remained higher 1 year after the 1010 end of training compared with baseline value (Globas et al., 1011 2012). In addition, it has been found that the high-intensity 1012 interval training (HIT) could promote superior beneficial 1013 cardiovascular and muscular adaptations among persons with 1014 different cardiorespiratory disorders (Rognmo et al., 2004; 1015 Wisløff et al., 2007). HIT is defined as repeated series of 1016 brief and intense exercise separated by active or passive rest 1017 periods. This type of intense training is also well known to 1018 be a time-efficient strategy to promote metabolic adaptations 1019 because the total session duration is strongly reduced compared 1020 to traditional moderate-intensity continuous aerobic training 1021 (Sun et al., 2014b). Such finding is important given that "lack of 1022 time" remains the most cited barrier to regular aerobic exercise 1023 1024 participation.

It was observed that HIT is well accepted for ambulatory 1025 chronic stroke and could induce encouraging improvements of 1026

quality of life as observed by improvements of VO_{2peak} and work 1027 economy (Gjellesvik et al., 2012; Boyne et al., 2013; Mattlage et al., 1028 2013). Recently, only one study has compared HIT (series of 30 s 1029 at maximum tolerated treadmill speed separated by 30-60 s rest 1030 periods) and traditional moderate-intensity continuous aerobic 1031 1032 training (Bovne et al., 2016). Authors indicated that no clear difference between HIT and moderate-intensity continuous 1033 aerobic training was observed because of a small sample size. 1034 Nevertheless, this type of training seems to be feasible and safe 1035 because no adverse events occurred. 1036

1038 Timing of Training Initiation

1039 It was postulated in human studies that starting rehabilitation program in the acute-subacute phase after stroke could 1040 prevent complications relating to prolonged inactivity (i.e., 1041 deconditioning period) and presented a low relative risk for 1042 adverse effects (Musicco et al., 2003). Numerous studies in 1043 rodents with cerebral ischemia have also observed that an early 1044 starting aerobic exercise (from days 1 to 5) was more effective 1045 to improve the running performance and to reduce the infarct 1046 volume compared to late training (Bland et al., 2000; Luo et al., 1047 2007; Schmidt et al., 2014). For example, Park et al. (2010), 1048 indicated that early treadmill training could better improve the 1049 motor performance, using the Rotarod test, than late treadmill 1050 training after hemorrhagic stroke (Park et al., 2010). Such early 1051 training did not increase the infarct volume or brain edema 1052 in accordance to other studies (Matsuda et al., 2011; Zhang 1053 1054 et al., 2013b). Likewise, an early treadmill exercise increased the 1055 cellular expression levels of some neurotrophic factors, promoted 1056 cell growth and reduced the expression of apoptosis markers (Mizutani et al., 2010; Matsuda et al., 2011). Moreover, an early 1057 endurance exercise improved blood flow in the ischemic region 1058 and promoted angiogenesis (Zhang et al., 2013b). We may also 1059 add that sensorimotor deficits and cortical infarct volume were 1060 aggravated on a longer-term when training started too soon i.e., 1061 before 24 h post-ischemia (Kozlowski et al., 1996; Risedal et al., 1062 1999; Bland et al., 2000; DeBow et al., 2004; Schmidt et al., 1063 2014). 1064

1066 Forced vs. Voluntary Training

Numerous studies highlighted that forced treadmill training is 1067 more effective than all the other types of exercise, included 1068 voluntary exercise, to improve running function, aerobic fitness 1069 and to reduce infarct volume (Takamatsu et al., 2010, 2016; 1070 Schmidt et al., 2014). However, some authors indicated that 1071 1072 voluntary exercise is more effective to improve motor recovery 1073 using the De Ryck's behavioral test (Ke et al., 2011). These controversial results might be explained by the use of different 1074 motor behavioral tests between studies as well as by a 1075 different training protocol (variable speed and timing of training 1076 initiation). 1077

1079 Concomitant Improvement of Cognitive and Motor1080 Functions Induced by Aerobic Exercise

Q15 1081 Interestingly, Sun et al. (2014), might find a compromise in rats 1082 by proving that training with gradually increased intensity on 1083 treadmill (from 5 to 26 m/min) could better improve motor

function and produce higher hippocampal BDNF with lower 1084 stress compared to both stably low and high intensity training 1085 (Sun et al., 2014a). These results were in accordance with 1086 Zhang et al. (2012), study in which both motor performance 1087 (forelimb placing, stepping coordination) and spatial memory 1088 in rats with middle cerebral artery occlusion-reperfusion were 1089 improved after progressive intensity aerobic training (Zhang 1090 et al., 2012). 1091

On the basis of these findings, it appears that training might 1092 alternate between high- and low-intensity sessions or might 1093 progressively reach high-intensity to accentuate improvement of 1094 either cognitive or motor performance. It also suggested that 1095 treadmill training might be appropriate for improving these two 1096 functions. However, it is more difficult to find a compromise 1097 for the timing of training initiation. Indeed, an early training 1098 seems to be more appropriate to promote motor recovery while 1099 cognitive performances were improved when aerobic training 1100 started later. Therefore, the influence of aerobic training on 1101 cognitive deficits might be considered to complete the actual 1102 exercise recommendations. 1103

METHODOLOGICAL CONSIDERATIONS

Although it is currently admitted that aerobic training 1107 1108 positively affects neuro-cognitive impairments, available 1109 studies reveal a great heterogeneity in the methods used 1110 and for some, weaknesses, which make results difficult to 1111 compare (Cumming et al., 2012). These methodological 1112 limitations, which are either specific or common to human 1113 and animal models, need to be considered before interpreting 1114 results. 1115

Methodological Considerations Concerning Exercise Parameters in both Animal and Human Studies

Available studies strongly differ in the parameters related to 1120 exercise during aerobic training: duration, intensity, frequency, 1121 mode and timing of rehabilitation initiation. In particular, 1122 exercise intensity, which is a critical parameter of aerobic 1123 1124 training effectiveness, deserves to be questioned (Pin-Barre and Laurin, 2015). For both human and animal models, intensity is 1125 frequently based on empirical speed/power (Ploughman et al., 1126 2008; Kluding et al., 2011; Påhlman et al., 2012; Shih et al., 2013; 1127 Shimada et al., 2013). In some human studies, the intensity was 1128 determined from subjective parameters such as level of exertion 1129 perceived by the patient (Ploughman et al., 2008; Kluding 1130 et al., 2011; Påhlman et al., 2012). In these conditions, exercise 1131 intensity (moderate, intense and severe) could not be precisely 1132 determined because no physiological markers were recorded (Xu 1133 and Rhodes, 1999). Therefore, a given absolute intensity was 1134 considered as moderate for some authors but as severe for others. 1135 When training intensity was based on physiological markers, 1136 percentages of maximal heart rate or the maximal oxygen uptake 1137 (VO_{2peak}) were the most frequently used parameters (Ploughman 1138 et al., 2008; Quaney et al., 2009; Kluding et al., 2011; El-Tamawy 1139 et al., 2014). However, these methods are insufficiently reliable 1140

as in human stroke studies.

Inter-individual differences in cerebral ischemia location and/or1204aerobic fitness level may affect, positively or negatively, cognitive1205impairments. However, they remain difficult to counteract (Tang1206et al., 2013; Sun et al., 2014b). For example, it was found that1207patients with infarction located within cortical regions, middle1208cerebral artery territory and/or on left hemisphere were more1209prone to cognitive impairments (Sun et al., 2014b).1210

Otherwise, using a cognitive test that did not detect the 1211 specific cognitive impairments of a patient might hide some 1212 potential effect of a training intervention (McDonnell et al., 2011; 1213 Cumming et al., 2012). For instance, cognitive measurements are 1214 frequently limited to clinical tests, as functional independence 1215 measures (FIM), that are not enough sensitive. Likewise, 1216 mini-mental state examination (MMSE) may underestimate 1217 stroke-related cognitive deficits because it presents a lack of 1218 sensitivity for identifying disorders of visual perception and of 1219 high-order executive functions (Nys et al., 2006; Pendlebury 1220 et al., 2010; Cumming et al., 2012). This might be problematic 1221 given that these latter cognitive functions are frequently affected 1222 by stroke (Sun et al., 2014b; Tiozzo et al., 2015). In this respect, 1223 the MoCA can assess numerous cognitive impairments such as 1224 executive function, attention and delayed recall disorders that 1225 appear to be more suitable for stroke patient (Pendlebury et al., 1226 2010). Some studies have also used specific neuropsychological 1227 tests such as Trail-making part A and B, Symbol digit test, Stroop 1228 test, Digit backward test, which allow to better detect cognitive 1229 deficits induced by stroke (Ploughman et al., 2008; Quaney et al., 1230 2009; Rand et al., 2010; Kluding et al., 2011). 1231

To ensure that cognitive performance improvements are 1232 related to aerobic training effectiveness, an increase of aerobic 1233 fitness needs to be observed at the end of the intervention. 1234 However, change in cardiorespiratory fitness after aerobic 1235 training is not systematically reported in the different studies. 1236 Thus, caution is often required when it is claimed that cognitive 1237 improvements are associated with aerobic training rather than 1238 other interventions or environmental factors. 1239

The issue of cognitive-motor interactions in stroke patients 1240 also deserves to be considered. Indeed, cognitive and motor 1241 processes are classically considered as functionally independent 1242 and then, explored separately in the literature. However, the 1243 control and learning of complex goal-directed movements 1244 require a close cooperation between sensorimotor control 1245 processes and higher cognitive functions. This is even more 1246 marked in older adults, for which cognitive and motor processes 1247 become less differentiated by virtue of functional reorganization 1248 of brain activation patterns. Thus, change in cognitive-motor 1249 interplay expresses an important facet of age-related intrinsic 1250 plasticity of brain and cognition. Strategic variations might 1251 be thus analyzed to assess behavioral adaptability in cognitive 1252 (Lemaire and Hinault, 2014) and sensorimotor tasks (Poletti 1253 et al., 2015, 2016). 1254

during an incremental test. Recently, submaximal parameters 1143 such as ventilatory or lactic threshold have been recognized 1144 to be more suitable than VO_{2peak} to induce a higher inter-1145 individual reproducibility in physiological response to exercise 1146 (Faude et al., 2009; Marzolini et al., 2013; Bosch et al., 2015). 1147 It is noticeable however that there is no consensus on the 1148 methods used to measure these physiological parameters from 1149 an incremental exercise test (Bentley et al., 2007). Indeed, 1150 depending on the type of incremental test, the performance 1151 1152 and the related physiological parameters could be altered. The 1153 chosen ergometer (ergocycle or treadmill), stage duration as well as the magnitude of intensity increment between each stage are 1154 known to affect the performance (for review see, Bentley et al., 1155 2007). Moreover, the progressive increase of exercise intensity 1156 on treadmill could be induced either by an elevation of speed 1157 (m/s) and/or inclination (percentage). The speed increment 1158 is not systematically reported in literature but some authors 1159 indicated that the grade increment was increased of 2% every 1160 2 min with a constant (high) walking speed (Voss et al., 2013). 1161 Increase in the slope of the treadmill needs to be considered to 1162 improve the validity and the relevance of the chosen incremental 1163 test on treadmill for aging subjects. Indeed, the increment 1164 of treadmill inclination seems to be more appropriate for 1165 aging people and/or for the individuals for whom running is 1166 1167 impossible or difficult. For instance, a lower running/walking 1168 speed on treadmill could reduce the perceived exertion of the 1169 exercise for some individuals and thus might reach highest 1170 intensities (Ehlen et al., 2011). Moreover, it was reported on obese persons that faster walking speeds might increase the risk 1171 of musculoskeletal injuries because of higher reaction forces and 1172 loading rates (Ehlen et al., 2011) in lower extremities tendons, 1173 joints and ligaments (Puga et al., 2012). Finally, most authors 1174 frequently used a stationary cycle ergometer for aging people 1175 (Maass et al., 2015) because measurements of physiological 1176 parameters during the test are more stable using this device 1177 compared to treadmill. The risk of falls is also lower on 1178 cycle ergometer. For the rodent model, some studies have 1179 proposed different treadmill protocol in order to reach the 1180 highest VO_{2peak} by modifying the treadmill inclination. It has 1181 been found in both rats and mice that the highest VO_{2peak} was 1182 reached at 25° because a distinct leveling-off of VO2 was mainly 1183 observed at this inclination (Wisløff et al., 2001; Kemi et al., 1184 1185 2002). 1186 In addition, among different studies, intensities are

to distinguish between high and moderate training intensities.

Indeed, patients barely reach their maximal aerobic capabilities

1187 rarely individualized, especially in rodents, while training individualization is one of the most important recommendations 1188 of stroke rehabilitation (Pang et al., 2013; Schmidt et al., 1189 2014). This limitation might attenuate the "real" effectiveness 1190 of aerobic training. Finally, it is commonly considered in 1191 exercise physiology studies that energy expenditure needs to 1192 be equivalent between exercise types in order to compare the 1193 different effects of a specific training parameter (such as intensity 1194 or duration). In this way, all the experimental groups have the 1195 same energy expenditure and thus only the influence of a tested 1196 exercise parameter is assessed (Rognmo et al., 2004; Wisløff 1197

1257 Animal experiments can provide information about underlying 1258 mechanisms of neuroplasticity that could not be investigated in 1259 human. However, several drawbacks are often observed in some 1260 studies. For instance, it is impossible to investigate the large 1261 range of cognitive functions identified in human, such as verbal 1262 learning and memory for example (Voss et al., 2013). Cognitive 1263 dysfunctions after cerebral ischemia are limited to spatial and 1264 working memory, recognition and motor learning skills (Morris 1265 water maze, passive avoidance test, object recognition or location 1266 test; Luo et al., 2007; Griesbach et al., 2009; Cechetti et al., 2012; 1267 Shih et al., 2013; Shimada et al., 2013).

1268 In addition, exercise-induced neuroplasticity are mainly 1269 explored within hippocampus (CA1 and CA3 areas and dentate 1270 gyrus), which is related to memory and learning (Vaynman et al., 1271 2003). However, other areas such as basal ganglia, prefrontal 1272 cortex, thalamus and cerebellum are also involved in learning 1273 and memory processes, executive functions and motor control 1274 (Graybiel, 1995; Doya, 2000; Johnson and Ojemann, 2000). 1275 Except the hippocampus, other regions, remote away from 1276 the lesion zone, are connected to the affected structures and 1277 thus might also be disturbed after stroke (i.e., diaschisis effect 1278 and synaptic inhibition). For example, inflammatory responses 1279 could be observed within thalamus or substantia nigra after 1280 cortical brain injury that might partially contribute to explain 1281 the cognitive deficits (Block et al., 2005). It could be relevant 1282 to investigate the effect of aerobic training on the cognitive 1283 functions of these cerebral areas (Carmichael et al., 2004). 1284

1285 CONCLUSION 1286

This present article provides an overview of the positive effect of aerobic training on cognitive functions. It seems that training could increase the release of the same neurotrophic 1290

factors (BDNF and VEGF) in both elderly and stroke 1312 people that mediate beneficial neuroplasticity in brain areas 1313 involved in cognitive functions. We also identify some 1314 methodological limitations in both human and animal studies 1315 such as the standardization procedure of aerobic exercise 1316 intensity and the chosen cognitive tests, depending on the 1317 target population, that remain one of the most important 1318 concerns. Moreover, our review article suggests that the 1319 combination of aerobic training with other exercises/therapies 1320 or treatments represent a promising strategy with strong clinical 1321 perspectives. Importantly, this review highlights the lack of a 1322 firm guideline for exercise recommendations targeting recovery 1323 of cognition in stroke patient. Therefore, no standard aerobic 1324 protocol has yet been established as a commonly accepted 1325 reference regarding intensity, timing of training initiation and 1326 exercise type. It also appears that investigating changes in 1327 cognitive-motor interplay are critical to develop appropriate 1328 rehabilitation to improve both cognition and motor control after 1329 stroke. 1330
