1 Litter of Mediterranean species as a source of volatile organic compounds

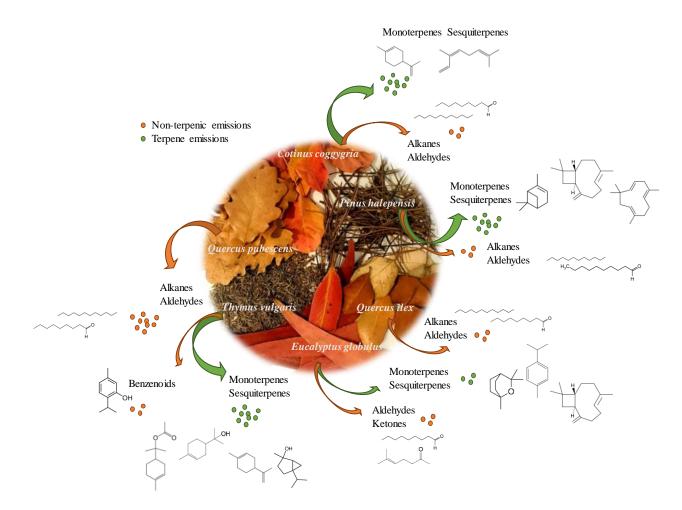

8 Abstract

Leaf litter, at the interface between the soil and the atmosphere, releases Biogenic Volatile 9 Organic Compounds (BVOC) which play an important role both in global atmospheric chemistry 10 11 and plant ecology. Litter is especially important in the Mediterranean region, where it is produced in high amounts and decomposes slowly. Only leaf litter emissions of two dominant species (Pinus 12 halepensis and Eucalyptus spp.) present in the Mediterranean region have been studied so far. The 13 aim of this study is to characterize (quantitatively and qualitatively) the BVOC emissions (C10-14 15 C15) from litter (freshly fallen and non-decomposed leaves) under laboratory conditions. Sixteen species frequently found in the Mediterranean region were considered, nine of which possess 16 17 terpene storage structures. Results show a large diversity of BVOC (87 compounds detected, terpenes, alkanes, alkenes, aldehydes, ketones, benzenoids), with terpene emission being higher 18 19 than non-terpenic emission in most of the cases. Species were classified within 3 categories: negligible emitters (e.g. Acer monspessulanum and Quercus ilex, $< 0.10 \,\mu g.g_{DM}^{-1}h^{-1}$), low emitters 20 (*Pinus pinea, Quercus pubescens*, $0.1 - 1.0 \,\mu g.g_{DM}^{-1}.h^{-1}$) and moderate emitters (*Thymus vulgaris*, 21 Cotinus coggygria and Pinus halepensis between 1.5 to 4.7 μ g.g_{DM}⁻¹.h⁻¹). Litter that possessed 22 23 terpene storage structures and known to store high terpene concentration did not always release the 24 highest terpene emission rates (e.g. Eucalyptus globulus, Rosmarinus officinalis). Species that do not possess such structures release only non terpenic emissions (e.g. alkanes, aldehydes). 25 Estimation of the potential contribution of P. halepensis and Q. pubescens litter to O_3 and 26 27 secondary organic aerosol (SOA) formation in the atmosphere showed that *P. halepensis* has a 28 larger potential impact on the global air quality than Q. pubescens. This study will contribute to 29 build future BVOC emissions inventories on leaf litter for their further integration in atmospheric chemistry models. 30

33 Highlights

- Litter emission rate ranges from < 0.1 to $4.7 \ \mu g.g_{DM}^{-1}.h^{-1}$
- The highest emitters are *Thymus vulgaris*, *Cotinus coggygria* and *Pinus halepensis*
- Terpene emission rates are most often higher than non-terpenic emissions
- Litter BVOC emissions of a species are not necessarily lower than green leaf BVOC
- Litter BVOC emissions contribute to air quality in a non-negligible way

Introduction

Living plant species are well known to release a vast bouquet of Biogenic Volatile Organic 40 Compounds (BVOC). Terrestrial living vegetation releases between 700 and 1000 TgC of BVOC 41 every year to the atmosphere, of which 40 to 65% are terpenes, mainly isoprene (309-706 TgC 42 yr⁻¹), followed by monoterpenes (26–156 TgC yr⁻¹) and sesquiterpenes (26 TgC yr⁻¹) (Navarro et 43 al., 2014). Higher BVOC emissions are probably released at the global scale since it has been 44 45 estimated that soil (bare soil + litter) contributes to 1-20 % of total BVOC emission in different ecosystems (Asensio et al., 2007; Kramshøj et al., 2016; Tang et al., 2019). Quantification of leaf 46 litter emissions at global or regional scales has not been performed using BVOC emission models 47 due to data scarcity (Peñuelas et al., 2014). BVOC emissions from litter are important in ecological-48 related processes as they modify plant growth and germination, acting as volatile allelochemicals 49 (Santonja et al., 2019) and in atmospheric chemistry by influencing the OH budget, O₃ and 50 secondary organic aerosol formation (Fehsenfeld et al., 1992; Spittler et al., 2006). As recently 51 reviewed (Tang et al., 2019), a missing OH sink would be due to incomplete characterization of 52 BVOC sources, particularly emissions from litter and soil. 53

54 Quantification of BVOC emissions at the ecosystem scale is not properly resolved with 55 available models (Peñuelas et al., 2013) where only BVOC emission from the canopy are considered. In order to integrate litter in BVOC emission models, the first step it is to list BVOC 56 emission rates of different plant species litter as previously carried out for living plants (Owen et 57 al., 1997, 2001). The few studies that have reported litter BVOC emissions seem to support that 58 59 litter is the second major source of BVOC after the canopy (Mäki et al., 2017; Tang et al., 2019) 60 and releases higher emissions than bare soil (Ramirez et al., 2010). BVOC litter-related studies refer either to the layer of dead plant material present on the soil surface (Schade and Goldstein, 61 62 2001; Gray et al., 2014) or dead plant material that is detached from a living plant (Isidorov et al., 2010; Isidorov et al., 2016), since ecologically the word litter has these two meanings (Krishna and 63 64 Mohan, 2017).

It is difficult to evaluate if leaf litter of a given species releases higher or lower emission rates compared to its green leaves. For example, litter emission rate of *Pinus sylvestris* L., measured with a static system and SPME (Solid Phase Micro-Extraction), is 7.5 μ g.g_{DM}⁻¹.h⁻¹ (Isidorov et al., 2010) in good agreement with emissions from green litter (maximal emission rate 6 μ g.g_{DM}⁻¹.h⁻¹; Vanhatalo et al., 2018). Emission rates of *Picea abies* (L.) H. Karst litter, also measured with a static system and SPME, is $1.3 \ \mu g.g_{DM}^{-1}.h^{-1}$ (Isidorov et al., 2010) contrast with green leaf emission (~0.1-0.4 $\ \mu g.g_{DM}^{-1}.h^{-1}$; Bourtsoukidis et al., 2014). Likewise, *Pinus taeda* L. litter showed an average emission rate of 117 $\ \mu g.g_{DM}^{-1}.h^{-1}$ (Ramirez et al., 2010) after litter conditioning (drying at 75 °C and incubation for 72 days), which is roughly 100 times higher compared to its green leaf emissions (Helmig et al., 2006). Litter conditioning and handling previous to measurements probably explain such differences. However, all these studies suggest that terpene emissions from litter are not negligible compared to green leaves.

Leaf litter emission varies according to decomposition stages (Gray et al., 2010; Isidorov et al., 2010) as terpenes volatilize from terpene pools and microbiota associated to litter releases and consumes BVOC. As a result, comparing leaf litter emission between species requires to consider litter from the same decomposition stage. Using fresh leaf litter that has not undergone microbial decomposition in soil allows to isolate BVOC emission from litter and is also the most accurate way to compare BVOC emission rates from green leaves and leaf litter.

83 Fresh litter could importantly contribute to BVOC emissions and the atmospheric chemistry in the Mediterranean region where climate is characterized by a long and hot summer period (2-5 84 months; Polade et al., 2014) which could favor BVOC emissions from litter (Greenberg et al., 85 2012). Moreover, litter decomposes slowly (Hart et al., 1992) and many Mediterranean plant 86 species including Pinus spp. and Quercus spp. produce important litter biomasses (e.g. Pinus pinea 87 L., Quercus coccifera L., Arianoutsou and Radea, 2000). The Mediterranean area is also highly 88 populated, leading to increases in anthropogenic pollutants, such as NO_x, necessary for 89 tropospheric O₃ formation, in the presence of BVOC and light (Atkinson and Arey, 2003). All 90 these interacting phenomena highlight the importance of focusing on other biogenic sources of 91 BVOC emission such as litter and not only living vegetation. 92

93 BVOC emissions from litter rely on both, soil microbial activity and specific BVOC reservoirs (such as glandular trichomes, secretory cavities) and cuticle where waxes are 94 accumulated (Bondada et al., 1996). BVOC reservoirs (present only in some species) allow to store 95 a high quantity of compounds resulting in toxic concentration for the other organisms (herbivore 96 97 or phytopathogenic microorganisms) (Lange, 2015). BVOC reservoirs mostly contain terpenic compounds (Wagner, 1991) (excepting isoprene which is produced de novo and never stored in 98 99 specific storing structures, Sharkey and Yeh, 2001), and are thus referred to as terpene storage structures. These structures can either be internal to the leaf such as the secretory cavities within 100

needles of resinous species or external to the leaf such as the glandular trichome (e.g. Lamiaceae 101 spp). Numerous Mediterranean plant species (Rosmarinus officinalis L., Pinus halepensis Mill., 102 103 *Pinus sylvestris, Pinus nigra* R. Legay) possess remarkable terpene amounts in these leaf reservoirs $(5-30 \text{ mg.g}_{DM}^{-1})$ presumably allowing these terpenes to be released in high amounts from leaf litter. 104 Other species (*Cistus* spp, *P. pinea*) only store small amounts of terpenes $(5-64.5 \mu g.g_{DM}^{-1})$ in these 105 structures (Ormeño et al., 2009). While terpene reservoirs are present in some species only, all 106 107 vascular species possess an upper cuticle layer which mainly stores low weight saturated and unsaturated aliphatic hydrocarbons (< C16) (Bondada et al., 1996; Barik et al., 2004) but also a 108 109 small fraction of terpene compounds in coniferous species (Joensuu et al., 2016). All these volatiles 110 could thereby plausibly be released by leaf litter cuticle.

111 The main goal of this study is to characterize BVOC emissions from litter of 16 Mediterranean species to identify those that could mostly contribute to biosphere-atmosphere 112 interactions. Species belonging to different Plant Functional Types (PFT) are considered, including 113 evergreen trees, deciduous trees and evergreen shrubs. This study considers fresh leaf litter 114 115 (senescent leaves) that has not undergone decomposition by soil microorganisms and focuses on 116 leaf terpene content (from literature data) to evaluate if this parameter could be an indicator of the potential of litter to release BVOC. Additionally, we aimed to estimate the potential impact of litter 117 BVOC emissions on air quality. For this purpose, we focused on two tree species (P. halepensis 118 and Q. pubescens) and calculated, for both plant species, three indicators of their influence on air 119 quality: regional litter BVOC emissions, photochemical ozone creation potential (POCP) and 120 secondary organic aerosol production (SOAP). These two plant species were chosen for this 121 122 modelling exercise since they are major species in the Sud-PACA region where they occupy 197 000 ha and 356 000 ha respectively (IGN – Inventory of 2014 to 2018). 123

124 2. Material and Methods

125 2.1. Plant material

Fresh leaf litter (hereafter referred to as litter) of 16 Mediterranean species was collected in 2017 and 2018 in Southern France (Sud-PACA region). Litter consisted of both senescent leaves previous to abscission and senescent leaves freshly fallen from the plant (within the first days following leaf abscission) collected by means of a fine-mesh net previously placed in the field to avoid litter contact with soil (Santonja et al., 2018). The studied species were chosen in order to select a significant number of the most abundant Mediterranean species. We paid a special attention

to integrate both, species with leaf terpenic reservoirs and species that do not possess such

structures, also species belonging to different plant functional types and finally taking into accompt
their litter production. For example, *P. halepensis* is an *Evergreen needle leaf tree*, possesses
terpene storage structures, occupies 231 000 ha in France and features a non-negligible litter
production (150-530 g.m⁻².y⁻¹,

Table 1). *Q. pubescens* is a *Deciduous broad leaf tree* free of terpene storage structure,
occupies 320 000 ha in the Sud-PACA region and features a moderate litter production (138 - 194
g.m⁻².y⁻¹,

144 carried out after rain events to avoid excess of humidity. Average litter humidity was 9.6 ± 1.2 % 145 (± standard error).

Seven of the studied species do not possess specific terpene storage structures (*Acer monspessulanum* L., *Erica arborea*, L., *Q. coccifera*, *Quercus ilex* L., *Quercus pubescens* Willd., *Quercus suber* L., *Ulex parviflorus* Pourr.). Nine species possess terpene storage structures internal
to the leaf (*Eucalyptus globulus* Labill., *Juniperus oxycedrus* L., *P. halepensis*, *P. pinea*) or external
to the leaf (*Cistus albidus* L., *Cistus salviifolius* L., *Cotinus coggygria* Scop., *R. officinalis*, *Thymus vulgaris* L.,

159 2.2. Collection of BVOC emissions from litter

A dynamic pull-push system was used to collect BVOC released by litter. This system is composed by 2 Pyrex® jars of 1.2 L each and a system that continuously flushes air inside these jars. The air flushed into each jar was previously filtered with both drierite (W.A. Hammond DrieriteTM Indicating Absorbents Mesh size 8, USA) to avoid the excess of humidity inside the system, and activated charcoal (Untreated, Mesh 4-8, Sigma Aldrich, USA) to remove VOC from ambient air. Finally, the air goes through a particle filter treated with sodium thiosulfate to remove the O₃ that could interact with BVOC emitted by litter.

167 Ten grams of freshly collected litter were placed inside a jar, leaving the other one empty to 168 check for the absence of VOC in the air flushed through the jars (blank measurement). We used 169 between 3 to 10 replicates per species, and emissions were collected once for each replicate. The emission factor of litter (standardized emission rate at 30 °C; Guenther et al., 2006) was measured 170 by placing the jars inside a stove at 30 °C. Temperature and air humidity were measured with an 171 172 iButton ® (Hygrochron, Maxim Integrated iButtons, USA) placed inside each jar. Before measurements took place, air inside the jars was renewed (1 L.min⁻¹ during 30 min) to avoid 173 sampling BVOC that would initially be inside the jar. During VOC sampling, flow inside and 174 outside the jar was set up to 0.2 L.min⁻¹ for 20 min. We used Mass Flow Controllers (MFC, EL-175 Flow select, Bronkhorst France, 0-1 L. min⁻¹) to control the flows. The air coming out of each jar 176 was collected onto glass cartridges (20 cm height; 10.5 mm external diameter, Gerstel®, Germany) 177 178 filled with two kind of adsorbents : Tenax TA (50 mg; Agilent technologies; 20 - 35 Mesh) and Carbotrap B (120 mg; Carbotrap Graphitized Carbon Black n°20287; Sigma Aldrich). Before use, 179 cartridges were conditioned at 300 °C for 3 h with a constant nitrogen flow (Nitrogen 4.5, purity 180 99.995 %) using a cartridge conditioner (TERA environment; RT-12-CN-3601-01). After BVOC 181 collection, cartridges were sealed and put inside a freezer at -4 °C until being analyzed by GC-MS 182 183 (see below).

Between samplings, the Pyrex jars were rinsed with water, then with ethanol (70 %) and finally put inside a muffle furnace for 4 h at 400 °C to ensure full VOC and plant debris removal that could influence the following samples. Blanks were performed for confirmation.

187 2.3. Chemical analysis

BVOC were analyzed using a Gas Chromatography (GC, 6890N, Agilent Technologies®) 188 coupled to a Mass Spectrometer Detector (MSD 5973, Agilent Technologies ®). BVOC trapped 189 in the cartridges were desorbed by a thermodesorber using a ramp of temperature from 50 °C to 190 250 °C at the rate of 3 °C.s⁻¹ for 15 min (TDS3/CIS4, Gerstel®), using helium as carrier gas (50 191 mL.min⁻¹). BVOC were then trapped in the Cooled Injection System (CIS) at 6.8 Psi pressure at 192 - 50 °C using liquid nitrogen. Then, the CIS was rapidly heated (25 s) from -50 °C to 250 °C 193 allowing molecule passage to the chromatographic column (HP5-MS, 30 m length, 0.25 mm 194 195 diameter, 0.25 µm film thickness, Agilent Technologies[®]). Molecules were separated using a ramp of temperature from 40 °C to 280 °C with a rate of 3 °C.min⁻¹ with a constant helium flow of 1.0 196 197 mL.min⁻¹. The method accuracy (101.27 %) and precision (4.7 %) were determined through replicate analyses (dodecane). The calibration linearity or coefficient of determination (R^2 = 198 199 0.9935, CV = 0.0019) and the limit of detection (LOD = 0.10 ng) were determined using standard calibrations. Molecule identification in chromatograms (Suppl. Figure 2) was achieved using 200 201 spectral libraries (NIST library), spectra from injected standards of high purity (> 99 %, Sigma Aldrich®, France, Suppl Table 1 & 2), and by comparison of our experimental and theoretical 202 Kovats index from Adams (2007). 203

204 2.4. Scanning electron microscopy

Since we did not find any data on the type of leaf terpene storage structures in *C. coggygria*, we explored its litter surface (abaxial side) using a Scanning Electron Microscopy (SEM, model XL30 ESEM from FEI). Small surfaces of leaf litter were fastened with adhesive tape on brass stubs and then gold coated in a metallizer using a Cressington 108 Sputter Coater.

209 2.5. Calculation of regional litter emission, global POCP and SOAP of P. halepensis and Q.
210 pubescens

In order to assess the impact of litter emission on air quality, we calculated three indicators. First, we estimated the regional litter BVOC emissions (t.y⁻¹) for the Sud-PACA region according to the following equation:

where, *ER* refers to emission rates ($\mu g.g_{DM}^{-1}.h^{-1}$) reported in this study, 8760 refers to the hours in one year, *Litter production* refers to annual litter production (g.m⁻²) noted in Table 1, the *Surface* refers to the forest area (m²) (IGN 2014-2018) occupied by each species in the Sud-PACA region and 10^9 is used to express results in ton. Second, for the two litter, we have calculated the photochemical ozone creation potential (POCP) and the potential secondary organic aerosol production (SOAP) using the following equations:

where, *contribution* (%)_{*i*} refers to the relative contribution of the BVOC i to the litter emission under study, *POCP_i* refers to the individual POCP of the BVOC *i* as reported in the Suppl. Table 6 and *SOAP_i* refers to individual SOAP of the BVOC *i* as reported in the Suppl. Table 6,

226 The POCP for individual VOC were reported from Dominutti et al. (2019). Unfortunately, POCP values were missing for monoterpenes and sesquiterpenes. Thus, as suggested by several 227 authors, the isoprene POCP value (109.2) was also used for monoterpenes, because of their 228 chemical similarity (Huang et al., 2017; Dominutti et al., 2019). The same reasoning was applied 229 230 in this work for sesquiterpenes for which the isoprene value was used. Likewise, the SOAP for 231 individual VOC were reported from Derwent et al., (2010) but SOAP values were available in literature for only two monoterpenes having similar values (α -pinene: 17.4 and β -pinene: 18.1). 232 233 They were missing for the other monoterpenes and sesquiterpenes. As suggested by Dominutti et al. (2019), the SOAP value of β -pinene was used in the present work for all the monoterpenes 234 because of their similar chemical properties. The SOAP values of individual sesquiterpenes were 235 estimated from their SOA Mass Yield, using SOAP and SOA Mass Yield of α -pinene and isoprene 236 237 as reference according to the following equation:

where, $SOAP_i$ and $SOA_M_Y_i$ are the SOAP and the SOA Mass Yield of the sesquiterpene *i* respectively, $SOAP_{ref}$ and $SOA_M_Y_{ref}$ are the SOAP and the SOA Mass Yield of the reference VOC. Because several SOA Mass Yields were available in literature for each sesquiterpene and reference VOC, the mean values were used (Suppl. Table 7). The calculated individual SOAP values obtained using the two reference VOC (isoprene and α -pinene) were close and the mean values were used in the present work (Suppl. Table 7)

245 2.6. Statistical analysis

Differences and similarities in the BVOC emission profile between litter from different plant species were assessed using a Principal Component Analysis (PCA). The statistical analysis of the data was performed with R software (version 3.4.X, R Core Team 2017) using ade4, factoextra packages.

250 **3. Results**

251 3.1. BVOC emissions from leaf litter

Regarding total emissions, we identified a remarkable diversity with a total of 87 compounds, 252 mainly terpenes (69 different compounds) followed by non-terpenic compounds (18 compounds) 253 254 including alkanes, alkenes, aldehydes, ketones and benzenoids. Within each species, the bouquet 255 of released compounds was also important for most species ranging from 4 emitted compounds in Q. ilex to 46 in J. oxycedrus (Suppl. Table 1 and 2). Terpene-storing species emitted an important 256 diversity of compounds (mean: 29 ± 4 compounds) with the most commonly emitted terpenes being 257 limonene, β -caryophyllene, α -pinene, α -humulene and α -terpinolene (Suppl. Table 1). By contrast, 258 the non-terpene storing species emitted on average 8 ± 1 compounds. Quantitatively, the studied 259 260 species could be classified in 3 different groups based on their total emissions: i) negligible emitters $(< 0.1 \,\mu g.g_{DM}^{-1}.h^{-1})$ including A. monspessulanum, Q. ilex, U. parviflorus, Q. suber and E. arborea, 261 *ii*) low emitters (0.1 < emissions < 1.0 μ g g_{DM}⁻¹.h⁻¹) including (in decreasing order) *R. officinalis*, 262 O. pubescens, P. pinea, O. coccifera, C. albidus, J. oxycedrus, C. salviifolius and E. globulus and 263 , *iii*) moderate emitters (1.0 < emissions < 5.0 μ g.g_{DM}⁻¹.h⁻¹) including (in decreasing order) *T*. 264 vulgaris, C. coggygria and P. halepensis (4.74; 3.37 and 1.52 µg.g_{DM}⁻¹.h⁻¹ respectively; Suppl. 265 266 Table 3).

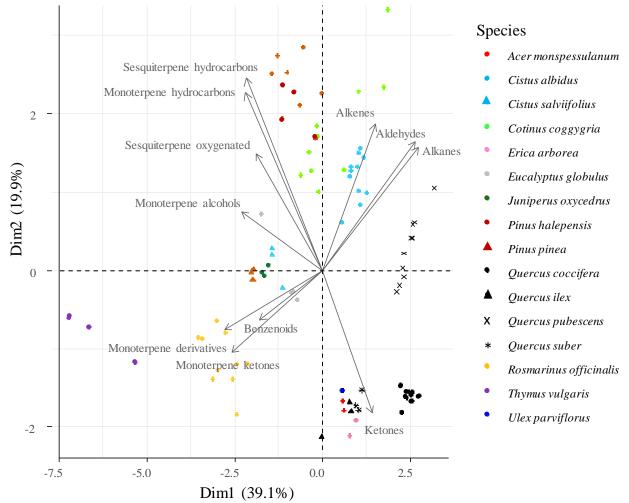
Terpene emissions only occurred from terpene-storing species. The highest terpene emitters 267 were also *T. vulgaris*, *C. coggygria* and *P. halepensis* (4.74; 3.37; 1.52 µg.g_{DM}⁻¹.h⁻¹ respectively) 268 whereas the remaining species emitted between 0.22 (E. globulus) and 0.71 μ g.g_{DM}⁻¹.h⁻¹ (R. 269 270 officinalis). Monoterpenes dominated emission from T. vulgaris (α -terpinyl acetate, α -terpineol, limonene, linalool and trans-4-thujanol) and *C. coggygria* (limonene, cis-β-ocimene and myrcene) 271 272 representing 98 % and 91 % respectively (Suppl. Table 1). By contrast, P. halepensis featured sesquiterpene emissions (61 % of total emissions), mainly β -caryophyllene and α -humulene 273 (Suppl. Table 1) and showed the highest sesquiterpene emission rates (0.92 μ g.g_{DM}⁻¹.h⁻¹) of all 274 species. Within each terpene emitter species, terpenes accounted for the major fraction in all 275

species, excepting *C. albidus* where terpene emissions $(0.18 \ \mu g.g_{DM}^{-1}.h^{-1})$ were close to nonterpenic emissions $(0.11 \ \mu g.g_{DM}^{-1}.h^{-1})$; Suppl. Table 3).

All species released non-terpenic emissions (Suppl. Table 3; Suppl. Table 4), saturated aliphatic alkanes ($C_{14}H_{30}$, $C_{13}H_{28}$), followed by aldehydes (nonanal, decanal), representing the major fraction in most species (Suppl. Table 1 and 2). The most remarkable non-terpenic emissions occurred in *Q. pubescens*> *Q. coccifera* > *C. coggygria* (0.61, 0.32 and 0.23 μ g.g_{DM}⁻¹.h⁻¹ respectively), followed by *P. halepensis* and *C. albidus* (0.16 and 0.11 μ g.g_{DM}⁻¹.h⁻¹, respectively).

Species that do not possess terpene storage structures showed lower total BVOC emission rates than terpene storing species, with two exceptions, *Q. pubescens* and *Q. coccifera*, with total non-terpenic emission (0.61 and $0.32 \ \mu g.g_{DM}^{-1}.h^{-1}$, respectively) higher than total emissions of the terpene-storing species *C. albidus*, *C. salviifolius* and *J. oxycedrus*. (0.30, 0.21 and 0.21 $\ \mu g.g_{DM}^{-1}.h^{-1}$ ¹, respectively).

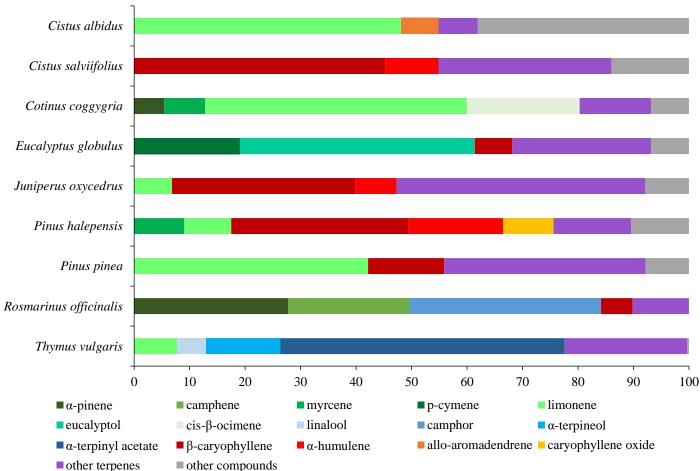
288 Clear differences occurred between species, even when they belong to the same genus (Figure 1). In *Pinus* spp, *P. halepensis* mainly emitted sesquiterpenes (60 % of total emission), 289 290 with a large diversity of volatiles (27 compounds) and a total emission rate 3-times higher (1.52 $\mu g.g_{DM}^{-1}.h^{-1}$) than *P. pinea* (0.54 $\mu g.g_{DM}^{-1}.h^{-1}$) which mainly released monoterpenes (60 % of total 291 292 emissions) with a higher diversity (43 compounds) (Suppl. Table 3). Quercus spp.- the main source 293 of non-terpenic emissions - showed a poorer diversity of BVOC (4-10 compounds) compared to *Pinus* spp. *Q. suber* and *Q. ilex* showed lower emission rates ($< 0.1 \ \mu g.g_{DM}^{-1}.h^{-1}$) compared to *Q.* 294 coccifera and Q. pubescens (0.32 and 0.61 μ g.g_{DM}⁻¹.h⁻¹) (Suppl. Table 4). C. albidus and C. 295 salviifolius emitted BVOC in similar rates (Suppl. Table 3), but C. albidus mostly released 296 monoterpenes (50 % of total emission) (mainly limonene, Suppl. Table 1), while C. salviifolius 297 298 mainly released sesquiterpenes (71 % of total emission, β -caryophyllene and α -humulene). Litter emission rates also exhibited some quantitative differences between samples of the same species, 299 300 up to 5-times different in samples of *E. globulus*.

The sum of the most emitted terpenes (representing individually at least 5 % of the total emission) contribute, at least, to half of the total emissions of a given species. For example, only two and three terpenes account for ~ 50 % of total emissions from *J. oxycedrus* and the remaining emissions were also characterized by terpene compounds, indicating that this species emits a large diversity of terpenes in small quantities. By contrast, only four terpenes represent 90 % of total emissions from *R. officinalis*, indicating few terpenes dominated emissions from this species (Figure 2).

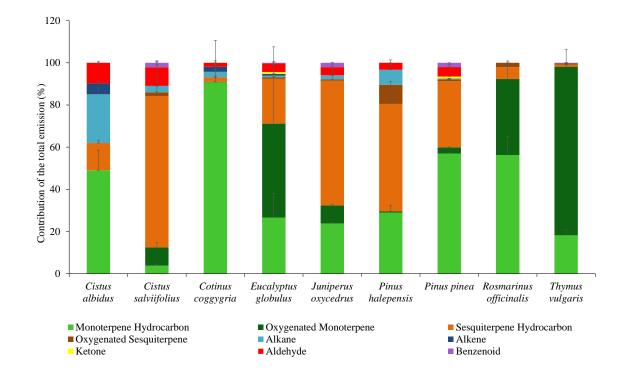
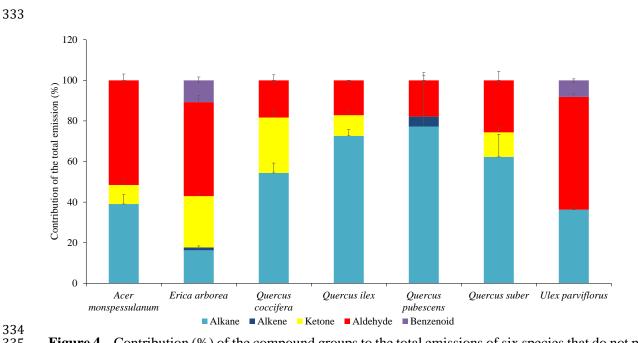


Figure 3 – Contribution (%) of the compound groups (terpene and non-terpenic groups) to the total emissions of nine species that possess terpene storage structures. Values are mean of n=3-10.

The contribution of each group of compounds to the total emission varied between species 319 320 (Figure 3 and Figure 4). Terpene emissions (monoterpene hydrocarbons, oxygenated monoterpenes, sesquiterpene hydrocarbons and oxygenated sesquiterpenes) represented most of 321 the emissions for the species that possess terpene storage structures (Figure 3). For example, they 322 represent 62 % to 100 % of the total emission (C. albidus and R. officinalis respectively). By 323 contrast, for species that do not possess terpene storage structures, non terpenic emissions are the 324 most emitted compounds with alkanes and aldehydes being the major BVOC. *Quercus* spp. showed 325 major alkane emissions (54 % to 77 % of total emission for Q. coccifera and Q. pubescens) while 326 A. monspessulanum, E. arborea and U. parviflorus mostly emitted aldehydes (52 %, 46 % and 327 56 % respectively; Figure 4). 328

337 3.2. Potential participation of P. halepensis and Q. pubescens litter BVOC to air quality at regional
 338 scale

The potential impact of the two main tree species in the Sud-PACA region on the regional air quality are assessed according to the three indicators previously described: their regional BVOC emissions $(t.y^{-1})$ and their potential to form SOA and O₃. *P. halepensis* regional emissions represent almost 3 times those of *Q. pubescens* (8919 and 3158 t.y⁻¹ respectively, Table 2) and its POCP is 2 times higher (96.2) than the POCP of *Q. pubescens* (47.7).

Despite the lower regional BVOC emissions from Q. pubescens litter, the SOAP calculated 344 for both species is similar (36.9 and 37.5 for P. halepensis and Q. pubescens respectively). Indeed, 345 on the one hand, Q. pubescens emissions are dominated by alkanes (pentadecane and tetradecane) 346 347 which have the highest individual SOAP (54.5, Suppl. Table 6) but this high values are compensated by the SOAP value (zero) of aldehydes (second major group of BVOC from O. 348 349 pubescens). On the other hand, P. halepensis emissions are mainly constituted by monoterpenes and sesquiterpenes which have a lower individual SOAP (18 and 51.1 respectively, Suppl. Table 350 351 6).

355 4. Discussion

This study shows that fresh leaf litter is a source of BVOC emissions with important differences between species but also within litter of a given species (up to 5-times). BVOC emissions from green leaves are indeed also characterized by an important variability within a species under the same environmental conditions. For example, the study from Genard-Zielinski et al. (2014) reported important inter-canopy differences (up to 4-times) for *Q. pubescens* under very similar conditions of light, temperature and air relative humidity in the field.

Results are discussed in the following subsections for all the species grouped according to 362 363 their PFT as used in BVOC emission models (Guenther et al., 2006; Messina et al., 2016). Before that, it is worth to mention that results in the present work were obtained at an averaged litter 364 365 humidity of 9.6 % which is close to previous published data for senescent leaves (8 % in Isidorov 2003, 5-7 % Romero et al., 2019). Different litter humidity values would have probably led to 366 367 higher emission rates considering the laboratory results from Greenberg et al (2012) on Pinus ponderosa needle litter (specific values not reported in their paper). Excluding Greenberg et al 368 369 (2012), all other litter BVOC-related studies in the laboratory have been performed using a single humidity (8 % litter humidity of Pinus sylvestris in Isidorov 2003, 0 % humidity in 12 species in 370 Gray et al., 2010). 371

4.1. BVOC emissions from litter of evergreen needle leaf tree species

P. halepensis showed one of the highest litter emission rates in the present study $(1.52 \,\mu g.g_{DM})$ 373 ¹.h⁻¹), in agreement with previous results on *P. sylvestris* non decomposed litter 1.96 μ g.g⁻¹.h⁻¹ 374 (Isidorov et al., 2010), and contrasting to P. pinea (~ 3-times less emission rates). This difference 375 could be partly explained by the terpene content within their leaf litter which is negligible in *P*. 376 *pinea* (0.064 mg.g_{DM}⁻¹) and high in *P. halepensis* (5 mg.g_{DM}⁻¹, Ormeño et al., 2009). The moderate 377 378 emission rates of *P. halepensis* litter could significantly contribute to BVOC emissions at the scale 379 of the Mediterranean region where it shows a rather important leaf litter production (150-530 $g.m^{-2}.y^{-1}$, 380

Southern France (PACA- Sud Region) were *P. halepensis* is especially present (231 000 ha,
(Fernandez et al., 2013). Considering all the Western Mediterranean area, *P. halepensis* is more
widespread (~3.5 million ha) than *P. pinea* (320 000 ha) (Quézel and Médail, 2003). Thereby, it is
likely that litter from *P. halepensis* contributes more importantly to BVOC emissions than *P. pinea*in the Mediterranean region. Contrasting to leaf litter, literature shows higher emission rates from

387 green leaves of *P. pinea* and *P. halepensis*, mainly represented by monoterpene compounds (

393 often used to produce essential oil. However, terpene emissions from litter contrast with literature on its needle essential oil content which is characterized by monoterpenes (41 % of total emission; 394 395 Dob et al., 2006) while its litter emits mostly sesquiterpenes (57 % of total emission; Figure 3). The green leaves of J. oxycedrus also emits different types of BVOC including isoprene, which 396 397 can not be produced by the litter, monoterpenes and sesquiterpenes, its emission can reach 2.3 $\mu g.g_{DM}^{-1}.h^{-1}$. The difference of emission between green leaves and litter might also be explained by 398 399 the thickness of the cuticle of this species (Vasic and Dubak, 2012) that could act as a barrier for the emission when still intact. 400

401 4.2. BVOC emissions from litter of evergreen broad leaf tree species

Litter of Q. ilex and Q. suber released non-terpenic compounds only such as fatty acids 402 derivatives (alkanes, alkenes) probably emitted by the cuticle present on top of the leaf litter 403 404 (Maffei, 1994). Green leaves of these Quercus spp. are known to release high monoterpene emission which require photosynthesis to occur, own to the absence of monoterpene reservoirs 405 within their foliage (Kesselmeier and Staudt, 1999). Such feature explains the absence of terpene 406 emissions from their freshly collected leaf litter. It can be concluded that evergreen forests of 407 408 Quercus ssp. are a remarkable source of terpene compounds from the canopy as shown in literature and a minor source of non-terpenic compounds from litter, although this could be moderated by 409 410 their abundance and litter production.

E. globulus litter showed a rather low emission rate $(0.20 \ \mu g.g_{DM}^{-1}.h^{-1})$ dominated by 411 412 monoterpenes. Contrastingly, Gray et al. (2010) showed that *Eucalyptus* litter released very high amounts of monoterpenes (0.4 μ mol.g_{DM}⁻¹.h⁻¹), which represents 54.4 μ g.g_{DM}⁻¹.h⁻¹. In their study, 413 litter had been previously oven-dried at 60 °C and litter leaves were cut into small pieces triggering 414 415 monoterpene emissions from litter and accumulation in the head space system they used (125 mL 416 jars). It is important to note that the authors explicitly indicate that they aimed to compare litter emission rates between species not to accurately quantify them. E. globulus canopy is a major 417 source of isoprene (38 μ g.g_{DM}⁻¹.h⁻¹; Keenan et al., 2009) with some monoterpene emissions too (2.7) 418 $\mu g.g_{DM}^{-1}.h^{-1}$). Moreover, terpene content of green leaves of *E. globulus* is very high (25 mg.g_{DM}^{-1}) 419 420 contrasting with the leaf litter emission we measured. Since several authors (Wilt et al., 1993; Romero et al., 2019) showed a good agreement between terpene content in leaf litter and green 421 leaves of numerous species, one can expect that terpene content in litter of *E. globulus* is also very 422 423 high. We argue that such discrepancy (between low emission rates found in this study and high terpene content in green leaves reported in literature) is maybe due to the thick cuticles of fully 424 expanded leaves of E. globulus (Johnson, 1926), since the cuticle limits BVOC diffusion from leaf 425 tissues to the atmosphere (Joensuu et al., 2016). 426

427 4.3 BVOC emissions from litter of deciduous tree species

Leaf litter from *Q. pubescens* showed a low emission rate $(0.61 \ \mu g.g_{DM}^{-1}.h^{-1})$ with only nonterpenic emissions, mostly low chain fatty acids derivatives (alkanes, alkenes). Contrastingly, green leaves of *Q. pubescens* are a remarkable source of isoprene emissions with emissions of fully expanded leaves ranging from 78.5 to 124.3 $\mu g.g_{DM}^{-1}.h^{-1}$ at 30 °C (Genard-Zielinski et al., 2014; Saunier et al., 2017a). According to the European inventory of BVOC emissions (Keenan et al.,

2009), O. pubescens is the second major isoprene emitting species. Isoprene requires de novo 433 formation to be produced (Sharkey and Yeh, 2001) since there is no specific storage of isoprene in 434 435 leaves (probably due to its very high vapor pressure) explaining that it is not released by leaf litter. However, isoprene can be synthesized from soil microorganisms (as shown in the data base mVOC 436 2.0; Lemfack et al., 2018) which probably explains why Warneke et al. (1999) showed isoprene 437 emission from oak, beech, spruce, grass litter (although the authors did not detail whether it was 438 439 fresh or decomposed litter). Despite the low non-terpenic emissions we reported for Q. pubescens, this species grows in highly widespread deciduous forests where litter production is moderate (153 440 g.m⁻².y⁻¹; Suppl. Table 3), suggesting that *Q. pubescens* litter could contribute to some extent to air 441 chemistry during the leaf abscission period (December-March in Mediterranean ecosystems). 442 443 Q. pubescens abundance is especially important in Southern France where it occupies more than 2 million ha only in the Sud-PACA (Saunier et al., 2017b). 444

Forests dominated by *A. monspessulanum* are probably a negligible source of BVOC emissions independently of the ecological compartment considered, since litter released the lowest emission rates (< $0.01 \ \mu g.g_{DM}^{-1}$. h⁻¹, all of them being non-terpenic) and green leaves release only negligible terpene emissions(< $0.5 \ \mu g.g_{DM}^{-1}$. h⁻¹; Ormeño et al., 2020; Genard-Zielinski et al., 2014).

449 4.4 BVOC emissions from litter of shrub species

450 *T. vulgaris* released the highest terpene emission rates $(4.72 \ \mu g.g_{DM}^{-1}.h^{-1})$ similar to green leaf 451 emissions (3.6 $\ \mu g.g_{DM}^{-1}.h^{-1}$; Parra et al., 2004). Accordingly, *T. vulgaris* contains remarkable 452 monoterpene concentrations in the glandular trichome of green leaves (22.0 mg.g_{DM}^{-1}; Nielsen et 453 al., 2015). This major aromatic plant species largely widespread in Mediterranean garrigues, is thus 454 probably an important source of BVOC in these ecosystems.

Interestingly, BVOC emissions from litter or green leaves of C. coggygria have never been 455 456 studied despite C. coggygria leaves have been largely used for medicinal purposes own to its essential oil (Matić et al., 2016). This species naturally coexists in the understory vegetation of 457 458 Mediterranean forests (Genard-Zielinski et al., 2014) and is highly used as ornamental plant in 459 urban vegetation. We observed, for the first time, the presence of a capitate sessile trichome, a type 460 glandular trichome, on the leaf abaxial (bottom) surface (Suppl. Fig 1) in agreement with other Anacardiaceae species (Metcalfe and Chalk, 1988). Despite the presence of these structures, C. 461 *coggygria* stores poor amounts of terpenes $(0.3 \text{ mg.g}_{DM}^{-1})$ both, in leaf litter (Santonja et al., 2018) 462 and green leaves (Romero et al., 2019). 463

R. officinalis appeared to be a low emitter $(0.71 \ \mu g.g_{DM}^{-1}.h^{-1})$ with numerous monoterpenes. Green leaves of *R. officinalis* release low to moderate terpene emission rates $(2.2 - 5.0 \ \mu g.g_{DM}^{-1}.h^{-1};$ Owen and Hewitt, 2000; Ormeño et al., 2007b) and store high amounts of terpenes (6.0 mg.g_{DM}^{-1}; Peñuelas and Llusià, 1997; Ormeño et al., 2007b). This result reveals that the presence of an important storage of terpenes does not necessarily implies a high emission rate from leaf litter although the underlying processes remain to be tested.

C. albidus and C. salviifolius showed low emission rates of both terpene and non-terpenic 470 compounds (0.30 and 0.21 µg.g_{DM}⁻¹.h⁻¹ each). Accordingly, terpene emissions from green leaves of 471 *Cistus spp.* are low to moderate $(0.5-5.0 \mu g.g_{DM}^{-1}.h^{-1}; Owen et al., 2001; Ormeño et al., 2007a), and$ 472 store low terpene amounts (0.8 mg.g_{DM}⁻¹; Ormeño et al., 2007b). Epicuticular wax coverage (very 473 long chained and saturated wax components) in leaves of C. albidus is very high (200 μ g.cm⁻²) 474 and represents about 3.5 % of the leaf dry weight (Hennig et al., 1988). Such coverage, which is a 475 476 mechanism to cope with the relative aridity that characterizes macchias and garigues, probably limits leaf litter terpene emissions too. Although litter from *Cistus* spp. releases low emission rates, 477 478 its contribution to BVOC emissions in Mediterranean garrigue ecosystems could be compensated by a high litter production (673 g.m⁻².yr⁻¹; 479

484 *parviflorus* and the *E. arborea* showed negligible BVOC emissions ($<0.04 \ \mu g.g_{DM}^{-1}$. h⁻¹), while 485 green leaves release high isoprene emissions (Owen and Hewitt, 2000). Since these species are not 486 the most commonly found in garrigues their litter is unlikely to contribute significantly to the whole 487 BVOC budget at the ecosystem scale.

488 4.5. Environmental implications of BVOC emissions from litter

According to our study, most emitted terpene compounds were limonene, β -caryophyllene, a-pinene and α -humulene, in agreement with Leff and Fierer, (2008) and emissions from green leaves (Owen et al., 2001). We note that highly volatile compounds such as methanol, acetaldehyde, acetic acid, formic acid and acetone, are also commonly released by leaf litter alone (Gray et al., 2010; Greenberg et al., 2012; Tang et al., 2019) or soil and litter together (Schade and Goldstein, 2001) but these highly volatile compounds were not screened in our study.

The influence of BVOC emissions from soil (litter included) on secondary air pollution and 495 496 the oxidizing capacity of the atmosphere are, by far, less well understood than their emission rates. Terpenes found in our study are known to take part of cloud condensation nuclei formation leading 497 498 to the production of SOA (Hartz et al., 2005). The SOA mass yield (%) varies according to the species: β -caryophyllene, α -humulene and α -pinene have a high SOA mass yield (respectively 499 500 45 %, 45 % and 41 %), while monoterpenes such as β -pinene or myrcene have a smaller SOA mass yield (17 % and 11 % respectively; Lee et al., 2006). It is important to highlight that BVOC from 501 502 litter extend the seasonal period where BVOC are emitted from the ecosystem and so participate to SOA formation (Faiola et al., 2014) since the canopy of deciduous broadleaf species do not 503 contribute to BVOC emissions through the entire seasonal cycle. 504

Although litter is a source of BVOC, part of the emission is adsorbed or assimilated through soil-related processes (Ramirez et al., 2010) and part readily reacts with atmospheric oxidants. For example, most commonly emitted terpenes in this study (limonene, β -caryophyllene, α -pinene and α -humulene) feature high reactivity with OH (Atkinson and Arey, 2003). Accordingly, studies on OH reactivity in the forests highlight a missing OH sink own to incomplete characterization of BVOC sources (Di Carlo et al., 2004) and several authors suggest the missing source is soil (including litter) (Praplan et al., 2019 and citations therein).

It is worth to note that BVOC emissions from litter are not only important in atmospheric chemistry but also in ecological-driven processes. For instance, Santonja et al. (2019) recently showed that β -caryophyllene emissions from *P. halepensis* litter negatively affected the development of neighboring herbaceous plants, eventually shaping the ecosystem diversity. Moreover, terpenes impact the soil food web and slow down the litter decomposition process (Chomel et al., 2016). It is important to highlight, that soil acts as a sink of BVOC (highly volatile compounds, isoprene and monoterpenes) through microbial uptake, dissolution in soil water and adsorption to soil particles (Misra et al., 1996; Ramirez et al., 2010). Independently of the underlying processes, several authors suggest that measuring BVOC emission from different compartments (litter alone, soil+litter, bare soil) can greatly benefit further model parametrization (Tang et al., 2019). Measuring BVOC emission rates from isolated leaf litter is thus necessary.

4.6. Potential participation of P. halepensis and Q. pubescens litter BVOC to air quality at regional scale

The regional emissions of *P. halepensis* and *Q. pubescens* litter (8.9 and 3.2 kt.y⁻¹) could contribute to global forest BVOC emissions in France, which are estimated to 457 kt.y⁻¹ of isoprene, 350 kt.y⁻¹ of monoterpenes and 129 kt.y⁻¹ of other BVOC considering only the canopy BVOC emissions (Simon et al., 2001). It should however be highlighted that our estimations are preliminary since litter BVOC emission are likely to vary over the decomposition process as later discussed.

Although the SOAP of *P. halepensis* and *Q. pubescens* were similar, it is likely that *P.* 532 halepensis litter contributes more than Q. pubescens to SOA formation at the regional scale since 533 the amount of BVOC emitted by P. halepensis was more than 2-times higher. Similar, SOAP of 534 the two tree species is explained by the emission chemical composition of their litter. While P. 535 halepensis mainly releases sesquiterpenes (~ 60 % of total emissions) which are considered to have 536 537 a high SOAP equal to 51.1, followed by monoterpenes with a SOAP equal to 18 (see Suppl Table 6), Q. pubescens features alkane emissions (77 % of total emissions) which have the highest SOAP 538 539 (54.5, Dominutti et al., 2019, Suppl Table 6). By contrast, litter emission of *P. halepensis* showed a 2-times higher POCP than Q. pubescens. This difference is due to the moderate POCP of alkanes 540 541 (44.5, Suppl Table 6) which accounted for the major emissions of Q. pubescens (Dominutti et al., 2019, Suppl Table 6) whereas the individual POCP of monoterpenes and sesquiterpenes released 542 543 by P. halepensis is much higher (109.2, Suppl Table 6). As described in material and methods, the 544 POCP of terpenes actually lacks in literature. As a result, the isoprene POCP was used in the present 545 study for all terpenes because of their similar chemical structure, thus further studies to calculate terpenes POCP would be useful to improve our estimates. With a moderate emission rate from the 546 547 litter of *P. halepensis* and a high POCP, the litter of this species could contribute to the formation of O₃ and SOA in a non-negligible way. 548

According to our results, species that mostly release sesquiterpenes such as *P. halepensis*, *C. salviifolius* and *J. oxycedrus* (60 %, 74 % and 60 % of the total emission respectively, Figure 3) could be of special importance in terms of SOA formation. Moreover, species that emit both, monoterpenes and sesquiterpenes would have a higher potential of ozone formation assuming that terpenes possess a POCP as high as isoprene. These preliminary estimations thereby require further modelling exercises using models such as CHIMERE and ORCHIDE but also BVOC emission algorithms able to calculate BVOC litter emissions.

556 **5. Conclusion**

557 The forest canopy is known to be the main source of BVOC emissions. This study shows that litter emission of Mediterranean tree and shrub species should not be neglected in biosphere-558 atmosphere interactions. We also suggest that leaf terpene content shown in literature is not 559 necessarily an indicator of the potential of litter to release BVOC. Of the three species known to 560 possess rich terpene concentrations (T. vulgaris, R. officinalis, E. globulus), only T. vulgaris 561 released high terpene amounts from litter. While litter of most species released low BVOC 562 emission rates with a few exceptions (T. vulgaris, C. coggygria, P. halepensis), literature shows 563 that litter is also a source of highly volatile compounds (methanol, ethanol, short-chained 564 aldehydes, acids, acetone), which were not investigated in this study (Gray et al., 2010; Tang et al., 565 2019). Consequently, emission rates would have been higher if a more exhaustive BVOC 566 567 screening had been carried out including compounds below C_{10} .

We suggest future in vitro and in situ research tackles BVOC emission variability according 568 569 to biotic (microorganisms) and abiotic factors (climatic conditions, soil). Since a couple of studies 570 have reported that litter BVOC emissions vary with decomposition degree (Gray et al., 2010; Isidorov et al., 2010), soil properties (Gray et al., 2014; Mancuso et al., 2015; Chaignaud et al., 571 2018), and climatic conditions (Derendorp et al., 2011, Greenberg et al., 2012), future research 572 573 should take into account these factors. For these purposes, BVOC from litter that has undergone 574 decomposition in the field (using for example litterbags, Isidorov et al., 2010, Santonja et al., 2015) could be collected over different decomposition times ranging from several months to years. BVOC 575 from these differently decomposed litter could be measured by combining in vitro measurements -576 577 using a controlled environment (at different temperatures and humidity) - and *in situ* measurements -using transparent dynamic enclosures equipped with temperature, humidity and light sensors as 578 described by Svendsen et al. (2016). Transparency of the enclosure system would allow to take 579

into account weather variability (e.g. sunny, cloudy and so light conditions). Additionally, for in 580 vitro measurements, BVOC emissions of litter free of microorganisms (using for example gamma 581 irradiation as sterilization technique) could be compared to natural litter in order to assess 582 microorganism-related BVOC and better estimate the contribution of litter itself. Characterization 583 of microbiota litter (Wilkinson et al., 2002; Isidorov et al., 2016), could also help to explain BVOC 584 emission variability over decomposition stages. These types of studies (combining decomposition 585 586 processes and contribution of microbiota to BVOC emissions) will be compared to BVOC emissions from non-decomposed litter (our study). We also suggest that both, in vitro and in situ 587 588 measurements are performed using litter plus soil, litter alone and soil alone to gain insight into soil capacity to act as a sink of BVOC as indicated by different authors (Isidorov et al., 1999; 589 590 Chaignaud et al., 2018; Rinnan and Albers, 2020). It is particularly important to perform such studies with a focus on BVOC emissions from P. halepensis litter since it features a high litter 591 592 production, occupies a high forest surface in the Mediterranean area and shows the highest litter BVOC emission rates among all tree species considered in this study. Results from this species 593 594 could serve as a model to other Pinus spp.

To conclude, although litter BVOC emissions are roughly lower compared to green leaf emissions, litter accumulates in soil so BVOC emissions could occur all year round. This could be particularly true in the Mediterranean region where litter production of numerous species is rather high and decomposes slowly due to relative water scarcity during most part of the year (Quézel and Médail, 2003). Litter could thereby importantly contribute to BVOC emissions, O₃ and SOA formation in this region.
