First whole genome sequence of Peanalcaligenes suwonensis bearing blavim-5 Metallo-B-

lactamase: a clinical isolate responsible for acute gastroenteritis

Abstract

Carbapenemase-producing *Alcaligenes* species has been described in only few studies, with none so far from the African continent. Here, we report the whole genome sequence of *Peanalcaligenes suwonensis* bearing *blav*_{IM-5} metallo-β-lactamase and first detection of carbapenemase producing *Alcaligenes faecalis* isolated from patients attending tertiary healthcare facilities in Nigeria. The isolates were identified by MALDI-TOF Mass Spectrometry. Antibiotic susceptibility assay, modified Carba NP test and genomic investigation revealed that two isolates of *Alcaligenes faecalis* and an isolate of *Peanalcaligenes suwonensis* harboured *blav*_{IM-5} gene. The genome sequence analysis of the *P. suwonensis* 191B isolate, responsible for acute gastroenteritis, reveal the presence of 18 antibiotic resistance genes coding for resistance to five different classes of antibiotics. Three of the genes (*blao*_{XA-368}, *blac*_{ARB-4} and *blav*_{IM-5}) codes for resistance to β-lactam antibiotics. To our best knowledge, we describe here the first genome sequence of *P. suwonensis* species and the first detection of class B carbapenemase *blav*_{IM-5} in a clinical isolate of *P. suwonensis* species and *Alcaligenes faecalis* in Nigeria. The finding of this study is of concern, as lateral dissemination of the genes into clinically important Gram-negative pathogens is highly likely.

Introduction

The *Alcaligenaceae* family comprises a large group of related bacteria species characterized by their ability to produce an alkaline reaction in certain medium (Austin, 2013). The most prominent member of the family is *Alcaligenes faecalis*, which are aerobic Gram-negative, non-fermentative, non-encapsulated, oxidase-positive bacterium (Hasan et al., 2019). *Alcaligenes faecalis* is an opportunistic pathogen occasionally implicated in infections in various anatomical sites particularly among the critically ill patients (Brady & Leber, 2018; Tena et al., 2014). Though, often referred to as environment contaminants, clinical infections by *A. faecalis* and even by pan-drug resistant strains are now increasingly reported (Hasan et al., 2019).

Few reports of infections by carbapenemase producing *A. faecalis* and its related species *Achromobacter* (formerly *Alcaligenes*) *xylosoxidans* have been documented in the literature (Kanellopoulou et al., 2004). Verona-integron encoded-metallo-β-lactamase (VIM) is the commonest carbapenemase enzymes in *A. faecalis* (Khajuria et al., 2013; Kreiswirth, 2017; Masseron et al., 2019; Riccio et al., 2001). To the best of our knowledges, only few studies have described *bla*_{VIM} producing *Alcaligenes* species with none from the African continent so far (**Suppl. Table S1**). Here, we report the whole genome sequence of *Peanalcaligenes suwonensis* bearing *bla*_{VIM-5} Metallo-β-lactamase and first detection of carbapenemase producing *Alcaligenes faecalis* isolated from patients attending tertiary healthcare facilities in Nigeria.

Materials and Methods

Clinical isolates of *A. faecalis* and an isolates of *Peanalcaligenes suwonensis* recovered during diagnostic investigations in the microbiological laboratories of the two

hospitals were collected between the months of January and July, 2019. The isolates were preserved and sent to Microbial Evolution and Phylogeny Infection, Institute Hospital University (IHU), Marseille, France for further characterization. The isolates were subcultured and purified, following the standard laboratory techniques. Well purified colonies of the isolates were identified by Matrix Assisted Laser Desorption-Ionization Time of Flight Mass Spectrometry (MALDI-TOF MS) according to the protocol described by the manufacturer (Bruker Daltonics GmbH, Germany). Antibiotic susceptibility test was then carried out on the isolates using the modified Kirby-Bauer disc diffusion method as outlined in the 2019 EUCAST guidelines (EUCAST, 2019). The third generation cephalosporin and carbapenem resistant isolates were tested phenotypically for ESBL and carbapenemase production by the double-disk synergy and modified Carba NP tests, respectively (Bakour et al., 2015; Olowo-okere, 2018). The genomic DNA of the isolates was extracted and purified using the EZ1 Advanced XL robot (Qiagen BioRobot EZ1, Tokyo, Japan), following instructions of the manufacturer. The isolates were screened for the presence of genes encoding ESBLs

(bla_{CTX-M}, bla_{TEM}, bla_{SHV}) and carbapenemases (bla_{OXA-48} like, bla_{VIM}, bla_{IMP}, bla_{NDM} and bla_{KPC}) using the real-time PCR as previously described (Lalaoui et al., 2018). Among the three VIM-5 positive isolates, one of them i.e. *P. suwonensis* 191B isolate which was obtained from a stool sample of a patient with acute gastroenteritis, for which no genome of this bacterial species is available in public sequence databases, was subjected to whole genome sequencing using Illumina MiSeq technology (Illumina, San Diego, CA, USA). The raw sequence was assembled using the Spades software and annotated by the Prokka bacterial genome annotation pipeline (Bankevich et al., 2012; Seemann, 2014). The Plasmid incompatibility (*Inc*) groups and acquired antibiotic resistance genes were determined using the PlasmidFinder 2.0 platform and ARG-ANNOT, respectively (Carattoli et al., 2014; Gupta

Result and Discussion

A total of 19 A. faecalis and one P. suwonensis isolates were obtained among the multidrug resistant (MDR) clinical isolates collected between January and July 2019. The antibiotics susceptibility testing results revealed that 3 (15 %) of the isolates were resistant to almost all tested antibiotics including to ertapenem and imipenem, but remained susceptible to amikacin, gentamycin, fosfomycin, nitrofurantoin, and colistin (**Table 1**). Phenotypic modified CarbaNP test showed that the three strains were carbapenemase producers. Realtime polymerase chain reaction (RT-PCR) and standard PCR for the detection of ESBL (blashy, blatem, blactx-m) and carbapenemase genes (blaoxA-23, blaoxA-24, blaoxA-48, blaoxA-58, bla_{NDM} , bla_{IMP} , and bla_{VIM}) revealed that the three isolates harboured only $bla_{\text{VIM-5}}$ gene. The sequenced genome of *P. suwonensis* was estimated to be 3'532'314-bp and assembled into 28 contigs with an average length of 126'521-bp and %GC content of 50.40 %. One complete and circular plasmid (named p191B) was identified with a size of 10'381-bp and 57.80%GC content. Genome annotation of the *P. suwonensis* 191B chromosome with Prokka pipeline resulted to 3'447 genes, 3'372 coding sequences (CDS), 2 rRNA operons, and 49 tRNA sequences. As shown on **Figure 1**, whole-proteome based phylogenetic tree analysis reveals that P. suwonensis 191B has a genome highly different with all compared genomes. The two Peanalcaligenes species (suwonensis and hominis), exhibiting the lowest genome size and %CG content, appear also highly distant and share only 68.54% of proteome similarity (fig. 1). BlastN analysis of three housekeeping genes of P. suwonensis 191B including rpoB, 16S rRNA, and 23S rRNA genes reveals respectively 81.68%, 96.61%, and 94.98% identity with best hit genomes including A. faecalis BDB4, A. faecalis AN70, and P. hominis strain 15S00501. As presented in **Table 2**, resistome analysis of the genome sequences reveals a

total of 18 antimicrobial resistance genes including 3 resistance genes to β-lactams (bla_{OXA} 368, bla_{CARB-4} , and bla_{VIM-5}), 4 aminoglycoside resistance genes (aadA14, ant(2")-Ia, aph(3)Ib, and aph(6)-Id), 3 resistance genes to trimethoprim/sulfamethoxazole (sul1, sul2/folP, dfrA22, and dfrE), a ermD macrolide resistance gene, 3 tetracyclines resistance genes (tetA, tetG, and tetR), and 3 multidrug efflux pumps (cat3, mexI, and mdtB). Some of these resistance determinants were located on the identified plasmid p191B (**fig. 2A**). Interestingly, as shown on **Figure 2B**, the genetic environment analysis of the bla_{VIM-5} gene shows that the gene is located on an integron inserted into a chromosomal hotspot (orfX gene) in which other described resistance genes in different bacterial species (e.g. $Shigella\ sonnei$, $Citrobacter\ freundii$, and $Escherichia\ coli$) are observed.

Conclusion

To our best knowledge, we describe here the first genome sequence of *P. suwonensis* species and the first detection of class B carbapenemase *bla*_{VIM-5} in a clinical isolate of *P. suwonensis* species. As compared to the literature, very few studies have reported *Alcaligenes* species-producing carbapenemases. Indeed, as shown on **suppl. Table S1**, to the best of our knowledge, only *bla*_{VIM-1}, *bla*_{VIM-4}, *bla*_{VIM-6}, and *bla*_{NDM} genes have been reported in *Alcaligenes* species so far. Thus, our finding is of concern, as lateral dissemination of the genes into clinically important Gram-negative pathogens is highly likely. It therefore highlights the need to improve laboratory capacity for surveillance and prevention of infection by MDR bacteria in our hospitals.

(**B**): Genetic environment of the *bla*VIM-5 of *P. suwonensis* 191B isolate compared to other genomic sequences from NCBI. The *bla*VIM-5 appears located into an integron integrated through a hotspot integration site (*ofrX* gene). The predicted functions of genes shown on the figure are given on the suppl. Table S2.
