## Chapter 12 The MBH Project and the Systematic Study of Late Mediaeval Hebrew Bibles: New Perspectives and 3D Experiments

### 1. The Manuscripta Bibliae Hebraicae (MBH) Project: Corpuses and Perspectives

The MBH Project funded by the French National Research Agency (ANR) focuses on one of the most important texts produced in medieval Western European culture: the Hebrew Bible, a common cultural monument to both Jewish and Christian cultures. It has been already underlined that an up-to-date systematic study of medieval Hebrew Bibles remains a *desideratum*.<sup>1</sup> This research represents a large, vast, and long-lasting work effort, itself part of the general study of medieval Bibles.<sup>2</sup> By focusing first on a limited corpus of Hebrew biblical manuscripts, all produced in Western Europe up to 1300, and by using renewed quantitative approaches,<sup>3</sup> the MBH project aims to better grasp and understand the materialization of the biblical text, i.e. forms and functions of biblical manuscripts,<sup>4</sup> their social and cultural meaning,

their Sitz Im Leben, as well as to help reassess a typology of medieval "Hebrew Bibles" by examining their different socio-cultural contexts of production.<sup>5</sup> In concrete terms, the project seeks first to systematically study and describe in great detail "biblical items" included in a dedicated online database: the MBH database. The MBH descriptions aim to gather codicological, palaeographical, as well as historical and socio-contextual information, together with, insofar as this is possible, textual aspects (vocalization, accentuation, variants, textual collations, order of texts, type of biblical texts and paratexts, set of notes, illustration types) pertaining to at least one hundred manuscripts, even if the potential corpus of research items is larger. By "manuscripts" we mean here either potential codices or scrolls-whether dated or undated, complete, lacunary, or fragmentary-that have been preserved to this day and were produced up to 1300 in England, northern France, Germany, and northern Italy, using mostly Hebrew Ashkenazic script type and subtypes. Sub-corpuses such as giant Bibles ("Atlantic Bibles"), small-sized Bibles ("Pocket Bibles"), or partial Bibles resulting from a process of selection can be subject to a specific qualitative study too.<sup>6</sup> The aim of gathering data about all the material forms of Hebrew biblical manuscripts in circulation in Ashkenaz before 1300 affords us a better understanding of the socio-cultural meanings of these texts, their contexts of production and uses, and a more accurate definition of geographical and subregional cultural areas of the Ashkenazic World.<sup>7</sup> The MBH Project intends to encourage the description of so far "little-described" items, especially undated Ashkenazic Bibles that make up the majority of the corpus. By means of future co-operations, it could sustain interoperable research between corpuses of data sets concerning biblical manuscripts from antiquity to early modern times, which will eventually extend to separate tools for Hebrew sources but also biblical manuscripts written in other characters, such as Latin, Greek, Arabic.

The time limit (the end of the thirteenth century) has been set as the number of Hebrew codices seems to grow exponentially after 1280. Nevertheless, a specific preliminary study of manuscripts from the first decade of the fourteenth century (dated, undated, fragmentary) is planned to discern any typological changes of structure and features of biblical manuscripts at the turn of the fourteenth century, in meaningful complementarity with the work carried out by our colleague Javier del Barco as part of the Legarad Project (CSIC Madrid).<sup>8</sup>

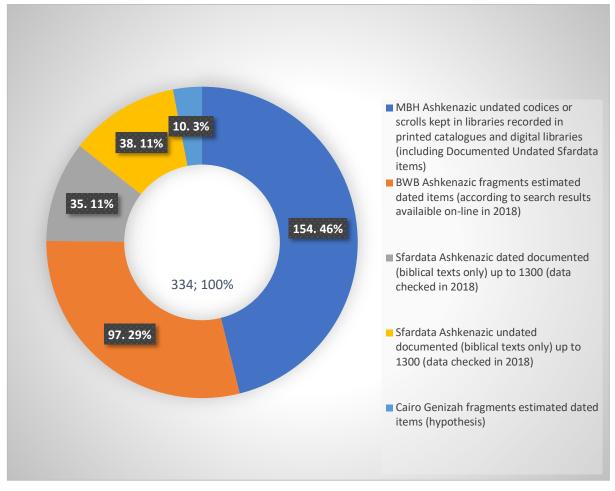


FIGURE 12.1 ESTIMATED CORPUS OF ASHKENAZIC BIBLICAL ITEMS. NUMBER OF ITEMS AND RATIO OF ASHKENAZIC BIBLICAL CODICES AND SCROLLS DATED OR ESTIMATED-DATED UP TO 1300 TO BE DESCRIBED IN THE MBH DATABASE

So far, our preliminary estimations of biblical Ashkenazic items produced up to (strictly) 1300 lead us to around 334 items of dated or estimated-dated codices and scrolls, in a fragmentary state or complete (See Figure 12.1).

According to the Sfardata database<sup>9</sup> only 35 biblical items (Key starting with 0A-0T) produced before the fourteenth century are dated precisely, meaning that Bibles are not especially more dated than other codices.<sup>10</sup> Concerning undated (complete) codices or scrolls that are kept in libraries, our general preliminary survey of (online or paper) catalogues allows us to estimate them, for now, to around 154 items.<sup>11</sup> To this we should add 38 undated documented items

(Key starting with ZA-ZT) recorded in Sfardata where a one-page questionnaire description is given; at least 97 fragments are recorded in the Books within Books (BWB) database; some Ashkenazic fragments may be identified in the Cairo Genizah.<sup>12</sup> The MBH Project presents an opportunity to create technical conditions in order to compare and correlate, when necessary, undated items with dated items, fragments with complete (potentially similar) Bibles, using both micro-history and macro-history perspectives.

More specifically, concerning dated codices, to the best of our knowledge, as of March 2018 the Sfardata database contains around 360 dated documented biblical text items (featuring "Biblical text only") dating up to 1540 (which represents about 11 per cent of the dated documented items described in Sfardata),<sup>13</sup> around 70 of which are Ashkenazic (i.e. about 20 per cent). Among dated Ashkenazic biblical texts recorded, 35 are dated and documented explicitly before 1300, which represents half. These 35 manuscripts are not enough to draw any conclusions on the main features of biblical Ashkenazic manuscripts before 1300 and, consequently, the study needs to be extended to at least the undated biblical items (i.e. the 154 and 38 items in Figure 12.1).<sup>14</sup>

The BWB database<sup>15</sup> contained, in March 2018, 435 fragments of biblical codices and 44 fragments of scrolls belonging to the Middle Ages; of these, only 94 codices and 3 scroll fragments are being described as "estimated-dated" to the thirteenth century, which needs to be treated with caution.<sup>16</sup>

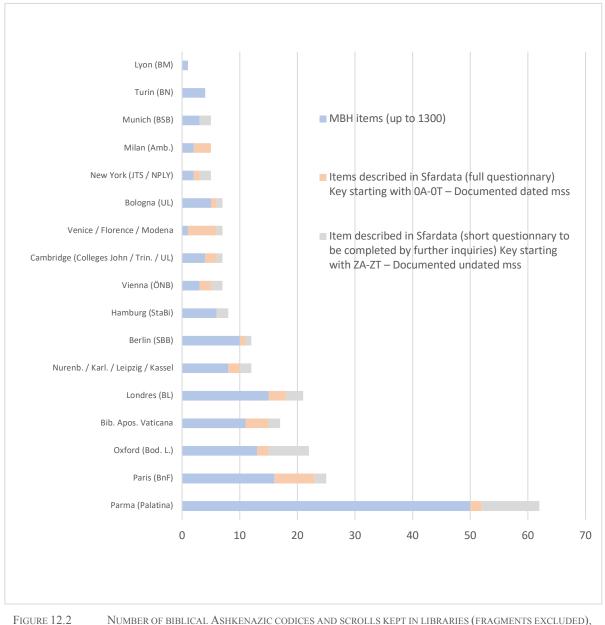
In the Cairo Genizah Fragments collections (described by the Friedberg Genizah Project),<sup>17</sup> even if the vast majority of the items are of Middle Eastern provenance, some of them bearing non-Oriental scripts may not have been identified properly.<sup>18</sup>

In conclusion, we estimate to circa 334 the number of biblical codices or scrolls (dated or undated, complete or fragmentary) which were produced in Ashkenaz up to 1300. Now, excluding fragments from the BWB database or Cairo Genizah, 227 items (i.e. 68 per cent) are of particular interest to the MBH Project and should be taken into account and described as a priority. The items' distribution in libraries is shown in Figure 12.2, where three libraries hold almost half of all the items, namely those in Parma, Paris, and Oxford.<sup>19</sup> Figure 12.2 shows the proportion of new data brought by the MBH Project, following in the footsteps of pioneer predecessors.

### 2. Studying Manuscripts Online and the Impetus for Examining Them In Situ

Any systematic study of medieval biblical codices or scrolls can count now on the accessibility of a great number of online colour 2D images and online tools, and should feel encouraged by the exponential increase of efforts made by leading libraries to provide digital images of ancient books in the last decade. In this context, the new International Collection of Digital Hebrew Manuscripts KTIV (National Library of Israel) appears as a helpful tool.<sup>20</sup>

As a first step, the consultation of a 2D digitized manuscript or microfilm is always required, especially for preservation reasons and to reduce the length of time such valuable items are handled where they are stored. For studying the text, a 2D digital object is often even better than the original item because the images available are themselves made and improved to be readable (and can be then different from the original).<sup>21</sup>

Nevertheless, when studying materialization, it is still a requirement to seek (and fight for) data verified *in situ* by directly examining the physical manuscripts because the frequent use of 2D digitized images has only simplified the access to their contents but not really to their materiality. While gathering data for MBH descriptions of manuscripts, online examinations allow us to extract, depending on each case, only 50 to 80 per cent<sup>22</sup> of the data required for a description, including material, structural information in addition to textual information. In practice, we must stress that other difficulties have also appeared: the number and quality of the data extracted from digitized codices or scrolls also depend on the state of preservation of the items themselves, on the kind and quality of the digitization displayed, and on the technical choices made to display the images themselves.<sup>23</sup> One must note here that photographic digitization protocols are definitely different for each library. As yet, there are no set "standards" and the results depend on the budget and technical choices of each library, and whether the latter is a national, regional, or municipal institution. Consequently, the "online availability" of digitized medieval manuscripts is far from being equal from one library to another, and the risk is then of collecting more data than in a traditional *in situ* scientific campaign but which are also more heterogeneous. One example and problematic aspect is the general absence of scale in images. Apart from IIIF now growing, we generally deal with images without scale,<sup>24</sup> or with a scale indicated directly on the top of the manuscript page,<sup>25</sup> or a scale added at the very end of the images without any connection with the rest of the

images,<sup>26</sup> or a scale mentioned in a picture schematically.<sup>27</sup> Last but not least, some digital libraries do not enable the correct browsing of leaves for Hebrew manuscripts from right to left, in contradiction with the natural reading of the real object.<sup>28</sup>

To counterbalance the effects of a too frequent (heterogenous) use of 2D images, examinations *in situ* of each artefact would remain the best option, especially when it is undated. This also remains an imperative because one should keep in mind how paradoxical it is to build an entire search about "materialization" only from virtual objects. In some ways, materialization implies experiencing an "object that works in our hands," in "the real life" of a past time so difficult to grasp. In order to learn from and about "materialization" we need precisely a "physical impression," even emotions, as we sit in front of an object, something a repeated sanitized online examination cannot provide. As Colette Sirat used to say, we need to "meet" a manuscript as we would meet a person.<sup>29</sup> The archaeology of the book, then, seeks a dialogue with the object in order to learn from it and not only construct hypotheses. But while the Covid-19 pandemic is still wreaking havoc, the use of virtual codices and virtual relationships is stronger than ever, reinforcing the difficulties in grasping real codices.<sup>30</sup> In conclusion, paradoxically, in our digital age the more the objects become virtual and accessible online, the more difficult it becomes to remember them as material and real objects in a concrete context.<sup>31</sup> It is why "archaeological perspectives" should be further invited into manuscript studies, and 3D images of manuscripts would be of great help.

# **3.** How Do We Learn to Read a Medieval Manuscript? Archaeological Approaches Completing Philological Approaches

In other words, the wide spread of 2D digitized images has reinforced specific ways of reading manuscripts and made it harder for codicologists to consult originals.<sup>32</sup> Consequently, because of the (presupposed) great ease of consulting these images, the latter are now perceived—incautiously—as the "normal way" of consulting medieval manuscripts outside the concrete reality of a manuscript room in a library, which is a specific *lieu de savoir*. This effect is simple but should again be stressed: 2D images are helpful but interfere with the process of understanding those objects in their material aspects, actually reducing them to 2D flat unscaled objects that lose most of their other "dimensions" such as real scale, thickness, weight,<sup>33</sup> quality of the parchment and its surface, the way the ink adheres to the parchment surface (important in the case of identifying several scribes),<sup>34</sup> real colours,<sup>35</sup> smell, the sound of the folios turning (or crackling)—all material features pertaining to very old and rare objects such as a thirteenth-century medieval manuscript.<sup>36</sup>

Thus, on the one hand, 2D online images foster the idea that the material aspects are less important than the artefact (the object itself) and that the main aim is still to display a written text to a vast audience. In medieval Hebrew manuscript studies we know—since the works by Colette Sirat—that material approaches to texts bring important evidence about the context in which they were produced and used, helping us to understand "archaeologically" their meaning and social and reading context.<sup>37</sup> Consequently, while experiencing this paradoxical research reality of our twenty-first century, I decided to steer the MBH project towards an experiment on 3D digitized manuscript objects, with the help of Léo Pascal. 3D images are not perceived

here as replacements of 2D objects but as probable future necessary complements to current 2D images, especially if pandemics become more frequent due to global warming.

# 4. The MBH 3D Digitization Experiment: Preliminary Steps for a Virtual Online Manuscript Room

As shown for instance by our colleagues at the Centre Camille Jullian (CCJ), at the Institut de Recherche sur l'Architecture Antique (IRAA), and at the Laboratoire méditerranéen de préhistoire Europe Afrique (LAMPEA), Research Centres at the MMSH, Aix-Marseille University,<sup>38</sup> archaeologists are currently involved in using 3D visualization techniques for artefacts and archaeological objects and sites. One of the techniques currently being used is photogrammetry.<sup>39</sup> As far as manuscripts are concerned, this field is still relatively new even if potential uses have already been identified since 2012.<sup>40</sup> Recently, one must, in the field of the Dead Sea Scrolls, quote the interesting digitization of the En-Gedi Leviticus Scroll (dated to 300 CE) which has allowed discovering the text of a very damaged item without opening it by using a virtual unwrapping process involving 3D techniques.<sup>41</sup> To the best of my knowledge, photogrammetry techniques are mainly used on Hebrew ancient items, such as the En-Gedi Leviticus Scroll, but are still rarely applied to Hebrew mediaeval items (either codices or scrolls or even fragments). As an example, 3D technique could be of great help for studying some of the biblical manuscripts of the National Library of Turin, especially the Ms. A I 3 which was damaged by both fire and water (see pictures).<sup>42</sup> The manuscript is an Ashkenazic Bible dated

to 5065 (1305 CE) known through the former catalogue written in 1880 by Peyron.<sup>43</sup> This actual item, which we had the possibility to examine in 2019 in situ, has been damaged by fire and the waters of the Po river. This item is astonishingly solidified like a heavy "brick," the folios are stiff and fixed and impossible to leaf through. No doubt these techniques could be very promising concerning this kind of valuable objects.

So far, the application of 3D techniques to medieval manuscripts has been considered of minor interest, especially if only philological interests have determined the scientific approach whereby the 2D digitization of manuscripts is supposed to be the perfect and common solution. Nevertheless, the potential of 3D digitization should be considered within an archaeological integrated approach (combining material approach and history of the texts). As Bernard Cerquiligny reminds us in a short article published twenty years after his French essay, translated in *In Praise of the Variant: A Critical History of Philology* (1999):

Égarée dans la quête illusoire d'un *Ur-text*, la philologie a curieusement minoré, ignoré voire méprisé l'objet matériel qui s'offrait à son étude. Or le codex est dans tous les cas un objet coûteux, préparé avec soin, selon un plan d'ensemble et réalisé de

façon collective; rien n'y est désinvolte. Il constitue un objet signifiant dont il nous faut réapprendre la lecture, comme il convient d'approcher sans a priori téléonomique la spécificité d'un dossier avant-textuel contemporain.<sup>44</sup>

### 4.1 The Technical Process<sup>45</sup>

The MBH 3D experiment involves photogrammetry scanning techniques, the non open-source Agisoft software, and the Autodesk Maya software. It is a low-cost non-invasive method widely used in archaeology. With this technology it is possible to digitize a single object or an entire archaeological excavation site. Photogrammetry is a particular application of stereoscopic vision, that is to say the interpretation of the disparities between several images of an object and the calculation of the depth of the scene by triangulation. It allows finding the position in space of each point on the visible surface of an object, based on the analysis of photographs taken from several different viewing angles. We use Agisoft Photoscan, a photogrammetric type of software, to digitize our manuscripts. It is a complete tool, commonly used by archaeologists, which allows us to carry out all the stages in the construction of a 3D model.

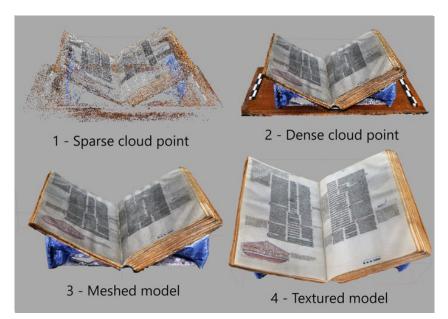


FIGURE 12.4 STEPS OF THE 3D DIGITZATION F A MANUSCRIPT, A GLOSSED LATIN BIBLE (ESTIMATED FOURTEENTH CENTURY) (C) MARSEILLE, BMVR, MS. 11, F. 31V-32R; IMAGES PREPARED BY LÉO PASCAL. WE ALSO THANK THE CURATOR OF THE BMVR ALCAZAR LIBRARY OF MARSEILLES, SOPHIE ASTIER.

Once the object to be digitized has been shot from different angles with a digital photo camera,<sup>46</sup> the first stage (see Figure 12.4) is camera alignment. The software searches for common points in photographs and matches them. This allows knowing the position of the camera for each picture and creating a sparse point cloud. The next stage is generating a dense point cloud based on the estimated camera positions and the pictures themselves. The third stage is the generation of a surface. The 3D polygonal mesh model represents the object surface based on the dense or sparse point cloud. Once the surface has been reconstructed, the model can be textured.

The acquisition protocol was developed by Léo Pascal during his MA studies in archaeozoology at the LAMPEA Research Centre (MMSH, Aix-Marseille University).<sup>47</sup> He applied the same method as with animal bones. These 3D models are very useful in the field of comparative anatomy, which is the study of similarities and differences in the anatomy of different species. This technique makes it possible, for example, to build large reference collections of bones which can be consulted anywhere in the world. This is very convenient for field researchers as they can look up the database and determine which species a bone belongs to. At Aix-Marseille University photogrammetry has been increasingly used in terrestrial, aerial, or underwater archaeology. This method allows, for example, saving huge amounts of time in field surveys and provides highly accurate results with a precision better than 1 per 1,000, for example, 1 mm for 1m, or 1 cm for 10 m. It is important to note that the quality of the photos determines the quality of the 3D models: there must be good lighting and pictures have to be sharp.<sup>48</sup>

In our case, in addition to making the objects accessible to a greater number of people, the point of these 3D models is to be able to compare different manuscripts in virtual rooms, to scale. Indeed, medieval manuscripts come in a wide range of forms and sizes and these 3D

displays could give us an idea of this variety. It is also an appropriate complement to 2D scans where the scale is not necessarily clearly stated.<sup>49</sup> 3D digitization is also interesting in terms of heritage conservation. 3D models represent a snapshot of the state of the manuscript and should be further developed especially for the study of old bindings, the history of the book, and the historical reconstruction of medieval libraries.<sup>50</sup>

In our experience, photogrammetry is a very suitable technique for the 3D digitization of manuscripts or any other fragile object. It provides high-quality models at relatively low costs. This technique produces new virtual manuscripts that are not meant to replace 2D digitization, nor examination *in situ*. One or two views of a manuscript in 3D would be another way of completing the material approach, making it possible to apprehend its scale in a virtual room, its depth, and the general aspect of the book, in a word, "a bit of its flavour." As for bookbinding studies, it can really become a way to restore ancient items that are also worth studying.<sup>51</sup> Furthermore, it would allow us to create "virtual meetings" with manuscripts preserved in different places, something which, apart from exceptional exhibitions, would not be possible in real life for preservation reasons and could improve on the general audience for these kinds of research.<sup>52</sup> While 2D images make philological studies possible, 3D objects, like examinations *in situ*, help remind us (albeit virtually) of the real form of a text, its "ways of working."

### 4.2 Items Concerned by the 3D Experiment: Latin and Hebrew Bibles

In 2018, with the collaboration of the LA3M Research Centre, several libraries from southern France such as the *Bibliothèque Municipale Méjanes* of Aix-en-Provence, the BMVR Marseille, and the BM of Lyons were enthusiastic partners in the conduct of some tests for the 3D digitization of Hebrew and Latin biblical manuscripts. Subsequently we were also able to do some tests at the Bibliothèque Nationale de France with the help of Laurent Héricher. Again, the main point to be reminded here is that photogrammetry-based 3D digitization of codices or scrolls is not meant to replace 2D digitization but express in a different, virtual way the original object and support the call for more archaeological reconstitutions of various kinds of material

(fragments, codices, scrolls, but also places such as scriptoria or copyists' workshops). The former remains a complement to the latter, especially because of some attendant technical problems: shooting an entire manuscript in 3D requires a lot of time but, most of all, since every image is a single 3D file, it would represent a very large amount of bytes.<sup>53</sup> Consequently, the MBH 3D shots are always of the book closed (namely the binding—front, back, as well as spine), from which we can reconstruct virtually the entire binding, plus one or two interesting views of the opened book.

The items we were able to shoot in 3D from December 2017 to July 2018 are listed in the table below. They will be gradually put online and integrated in the MBH portal, while waiting for a virtual room to be specially developed.

## 4.3 The Future Development of a Specific 3D Manuscript Virtual Room Project for Western Medieval Bibles

All these 3D images are available online on the MBH Project's web portal, at first as isolated objects.<sup>60</sup> They do not represent a huge amount of objects but helped us to imagine a prototype of an MBH 3D manuscript virtual room as it is certain that the main point of interest in these 3D images is being able to relate one to another, in a virtual "room/place/library/scriptorium"

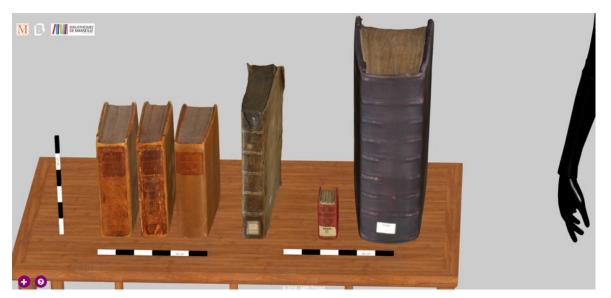


FIGURE 12.5 SCREENSHOT OF HEBREW BIBLES (SPINES) IN THE EXPERIMENTAL MBH VIRTUAL MANUSCRIPT ROOM FOR MEDIEVAL BIBLES. FROM LEFT TO RIGHT: MARSEILLE, BMVR ALCAZAR, MS. 1626/I, II, AND III; LYONS, BM, MS. 5; PARIS, BNF, MS. HÉBREU 33 (COMPLETE BIBLE, ESTIMATED-DATED 13TH C.); PARIS, BNF, MS. HÉBREU 4 (COMPLETE MONUMENTAL ASHKENAZIC BIBLE, 1286).

(?) on the right scale (see Figures 12.4 and 12.5 below). Consequently, the MBH Manuscript Room is one of the first prototype of its kind, a transdisciplinary virtual manuscript room for consulting, at first, Latin and Hebrew medieval biblical items that were probably circulating in the same regions at the same time.

Seeing and comparing Latin and Hebrew manuscripts together in the same place is not something that can occur so easily in reality, *even within the same library* during a research consultation appointment, unless this is for the purpose of an exhibition project. For instance, an authorization for Hebrew biblical manuscripts to be consulted by a Hebrew specialist will not allow the latter to order easily any kind of Latin books due to disciplinary and administrative divisions. Thus, the MBH Manuscript Room should be further developed as part of another specific project. A 3D Virtual Manuscript Room for Western Medieval Bibles combined with a database comprising material features such as, for instance, the weight and thickness of the books would show the diversity of the medieval biblical manuscripts in circulation in Western Europe and their richness from a philological as well as material and cultural point of view.

#### Conclusion

To conclude, the MBH Project, if not the first to underline the interests of 3D Visualisation applied to documents, rare books and manuscripts, was an opportunity to test preliminary technical conditions in order to compare and correlate, when necessary, undated items with dated items, fragments with complete (potentially similar) Bibles. This chance to get a general view of the material production, forms, functions, and uses of biblical manuscripts is necessary for those willing to interpret sources by using both micro-history and macro-history perspectives. As for 3D digitization, it is for the moment ignored as a tool for studying or understanding manuscripts, for both cultural and inertia reasons. In our opinion, it is not meant to replace the current 2D digitized images but represents an interesting and necessary complement to 2D scanned objects for the purpose of research that goes beyond the text and of archaeological approaches. The main effect of the extensive use of 2D digitized manuscripts is a loss of perception of the relation with the human-body scale, something that is never the case with other archaeological objects. As Cubaud - Hass - Topol remind, the traditionnal 2D approach is wellknown to be judged insufficiant as far as "the Book-Object" itself is concerned"<sup>61</sup>. Paradoxically, these 3D objects-books encourage us to consider them not only as "texts" but as archaeological items that need to be placed within a "real-life" material context:

which table or *presentoir* would they have been laid on, in which coffer or armoire would they have been kept protected, which bags would they have been carried in, on which shelf would they have been hosted in northern French houses? What was the actual economic value of these objects during their time? What functions did they fulfil? What symbolic values did they endorse through the centuries? The development of a virtual manuscript room, in parallel with a database dedicated to Bibles, would help—as the MBH experiment has shown—to construct a place where different 3D biblical items could be seen, measured, displayed, and compared on the same scale, and their context of use reconstructed (even if only hypothetically) such as in a medieval synagogue or scriptorium. The archaeological reconstruction of medieval public or private libraries should also benefit from asking where precisely giant Bibles or Torah scrolls were kept. 3D manuscript research sustains a dialogue between philology, the archaeology of the book, and socio-history; it should therefore receive more attention and could be of great help in disseminating science and allowing the wider and younger audiences to test the flavour of the Book.
