26 Abstract

Scope: We addressed the effect of vitamin A deficiency on vitamin A and lipid postprandial 28 metabolism in young rats, considering the effect of sex. Methods and results: Sprague-29 Dawley rats were fed either 400 UI/Kg vitamin A diet (vitamin A-deficient diet: VAD diet) or 30 2300 UI/Kg vitamin A (control diet), before being mated. Mothers received the same VAD or 31 control diet during gestation and lactation. Offspring received the same diet than mothers until 32 8 weeks of age. VAD diet-fed female and male offspring displayed a severe vitamin A 33 deficiency with no body weight or glucose tolerance defects. Fasting plasma triglyceride 34 concentrations were decreased in VAD diet-fed animals compared to controls (p<0.05). 35 36 Retinyl ester postprandial responses after vitamin A gavage, expressed as area under the curves, were not different in VAD diet-fed and control animals, although retinyl ester 37 postprandial peak was significantly delayed (p<0.05) in VAD diet-fed rats. Lipids also 38 accumulated in the distal part of the intestine after gavage and  $[1-^{13}C]$ -oleate postprandial 39 response was decreased in VAD diet-fed males. Conclusion: Vitamin A deficiency modulates 40 both vitamin A absorption rate and lipid postprandial metabolism, which can partly explain 41 the altered fasting lipid status observed in VAD diet-fed offspring. 42

47 Vitamin A refers to a group of unsaturated organic compounds that includes retinol, retinyl 48 esters and retinal. In the human diet, vitamin A is found in animal-based foods as retinyl 49 esters (mainly retinyl palmitate). In plant-based food, it occurs as provitamin A carotenoids 50 (mainly β-carotene, α-carotene and β-cryptoxanthin), which can be cleaved and metabolized 51 into retinol after absorption by the intestinal cells <sup>[1]</sup>.

Vitamin A is essential in many physiological processes including embryo development,
 immune system differentiation and function, vision and energy metabolism <sup>[2]</sup>.

Vitamin A deficiency is a serious and widespread public health problem <sup>[3]</sup>. The requirements 54 of vitamin A are increased during pregnancy and a daily intake of 800 µg retinol equivalents 55 is recommended as a safe level of vitamin A for pregnant women<sup>[4]</sup>. According to the World 56 57 Health Organization (WHO), about 8% of pregnant women in Africa display vitamin A deficiency symptoms (i.e. night blindness) and about 15% present low serum retinol 58 concentrations<sup>[5]</sup>. Vitamin A deficiency during pregnancy is associated with increased mother 59 and infant mortality rates <sup>[6]</sup>. After birth, vitamin A deficiency affects 1 in every 2 children in 60 sub-Saharan Africa and south Asia<sup>[7]</sup>, and is the leading cause of preventable blindness in 61 children<sup>[3]</sup>. Vitamin A deficiency also increases susceptibility to infections due to impaired 62 immune function<sup>[8]</sup>. 63

The transcriptionally active form of vitamin A is retinoic acid. Retinoic acid modulates the expression of numerous genes via retinoic acid receptor (RAR) and retinoid receptor (RXR) binding. Among these genes, several play essential roles in energy and lipid metabolism <sup>[9]</sup>. The aim of the present study was thus to characterize the effect of a vitamin A deficiency during pregnancy, lactation and the first weeks of life on both vitamin A and lipid absorption and postprandial metabolism after an oral gavage in rats.

#### 70 **2.** Material and methods

## 2.1.Animal study (Flowchart, Figure 1)

72 Animals

All experimental procedures were approved by the ethics committee of Marseille (agreement 73 number D 13-055-20). Two groups of 10-week-old Sprague Dawley rats (Janvier, Le Genest 74 St Isle, France, n = 8 males and n = 12 females) were housed under standard conditions of 75 light (12-h light/dark cycle; lights on at 08h00) and temperature (22-24°C) with free access to 76 tap water and breeding pellet diet. Diet was supplemented either with 2300 IU/kg of vitamin 77 A (control diet) or 400 IU/kg vitamin A (vitamin A-deficient [VAD] diet). These diets were 78 developed by Test Diet Limited (London, UK). After 8 weeks virgin females were mated. In 79 order to avoid a diet-induced post-natal programming <sup>[10]</sup> litters were culled to 10-12 pups at 80 postnatal day 3 (P3). Rats were weaned at day 21 and fed as follows: 81

offspring rats from control breeders were fed control diet (control group, n = 14 males and
13 females)

offspring rats from VAD diet-fed breeders were fed VAD diet (VAD diet-fed group, n = 12
males and 11 females).

At week 6, young rats were weighted and an intraperitoneal glucose tolerance test was
performed at week 7 (1.5 g glucose/ kg) as previously published <sup>[10,11]</sup>

## 88 Organ collection at fast

At week 8, a group of offspring rats (control group, n = 7 males and 6 females and VAD dietfed group n = 6 males and 5 females) were fasted overnight before a plasma sample was taken at the tail under light isoflurane anesthesia. Animals were then euthanized, and organs including intestine, liver, white (omental) and brown adipose tissues were promptly harvested. Intestines were carefully rinsed with ice-cold PBS before being cut in fragments. All samples were stored in liquid nitrogen until lipid/vitamin extraction.

### 95 **Postprandial experiments**

At week 8, another group of offspring rats (control group, n = 7 males and 7 females and 96 VAD diet-fed group n = 6 males and 6 females) were fasted overnight and each animal was 97 forced-fed with 1 mL of an oily emulsion (triolein:water, 1:2, v:v) containing 3 mg of retinyl 98 palmitate and 2 mg of  $[1,1,1^{-13}C_3]$ -triolein (Sigma Aldrich, Saint-Quentin-Fallavier, France). 99 The mixture was vigorously mixed in ice-cold water in a sonication bath (Branson 3510, 100 Branson, Danbury, CO, USA) for 15 min and used for force-feeding within 10 min. Blood 101 102 sample were obtained before force feeding and every 90 min for 6 h from a tail nick under light isoflurane anesthesia and collected into tubes containing 50 µL of a 0.109 M sodium 103 citrate solution. Blood was immediately centrifuged at 1400 g for 20 min at 4°C and the 104 resulting plasma was immediately frozen at  $-80^{\circ}$ C. 105

106 At t = 6 h, animals were euthanized, and their intestine and organs (liver, white and brown 107 adipose tissues) were promptly harvested. Intestines were carefully rinsed with ice-cold PBS 108 before being cut in different fragments. All samples were stored in liquid nitrogen until 109 lipid/vitamin extraction.

111 **2.2. Tissue lipid content** 

Tissue samples (~100 mg) obtained at fast were homogenized in 800 µL of PBS with two 3 mm-diameter stainless steel balls in 2 ml Eppendorf tubes using a MM301 ball mill (Retsch, Haan, Germany). Lipids were first extracted following the Bligh and Dyer method <sup>[12]</sup>, and samples were resuspended in isopropanol. Total cholesterol, phospholipid and triglyceride plasma and tissue concentrations were then assessed in triplicate using kits from Biolabo (Maisy, France) according to the manufacturer's instructions.

#### 119 **2.3.** Vitamin A extraction and analysis

Vitamin A (in the form of retinol or retinyl esters) from plasma (100 µL) and organ samples 120 (~ 20 mg for the liver and 40 mg for the intestine in suspension in PBS) were extracted from 121 122 aqueous phases as follows (when necessary, distilled water was added to samples to reach a final volume of 500 µL): internal standard (5-apo-8'-carotenal) was added to the samples in 123 500 µL of ethanol, and the mixture was extracted twice with two volume of hexane. The 124 125 hexane phase obtained after centrifugation (1200 x g, 10 min, 4 °C) was evaporated to dryness under nitrogen. All dried extracts were dissolved in 200 µL acetonitrile: 126 dichloromethane: methanol (70:20:10; v:v:v). A volume of 50-180 µL was used for HPLC 127 128 analysis. 129 All the HPLC analyses were realized using a 250 x 4.6 nm RP C18, 5 µm Zorbax column (Agilent) maintained at a constant temperature (35°C) and a guard column. Analysis was 130 performed with a 70% acetonitrile, 20% dichloromethane and 10% methanol mobile phase 131 (flow rate = 1.8 mL/min). The HPLC system comprised a Shimadzu separation module (LC-132 20ADSP HPLC Pumps and SIL-20CHT Autosampler; Shimadzu, Champs-sur-Marne, 133 France), and a SPD-M20A Shimadzu photodiode array detector (PDA, vitamin A detection at 134 325 nm and 5-apo-8'-carotenal detection at 450 nm). Retinol and retinyl palmitate were 135 identified by retention time compared with pure (>95%) standards. Quantification was 136 137 performed using Chromeleon software (version 6.8) comparing peak area with standard reference curves. Retinyl linoleate, retinyl oleate, retinyl stearate were identified by retention 138 time and spectral analysis and quantified regarding their molecular extinction coefficient ratio 139 compared to retinyl palmitate. 140

141 Vitamin A postprandial response was expressed as area under the curve (AUC) of retinyl ester142 plasma concentrations.

# 2.4. [1-<sup>13</sup>C]-oleate analysis by Gas Chromatography-Combustion-Isotope Ratio Mass Spectrometry (GC-C-IRMS)

Glyceryl triheptadecanoate (C17:0, Sigma Aldrich) was added to the samples as an internal standard to quantify the oleic acid occurring in total lipids of plasma (250 ng of C17:0 /  $\mu$ L) and tissues (5 µg for liver and 5 µg for duodenum, 0.5 to 12 µg for ileum and 5 to 11 µg / mg of tissue for jejunum).

150 Plasma samples (50  $\mu$ L) were submitted to direct methylation as described previously <sup>[13]</sup>.

151 Briefly, plasma was dissolved in 2 mL of a solvent mixture of methanol:hexane (4:1, v:v) and

152  $200 \ \mu L$  of acetyl chloride were added. The tubes were tightly closed and subjected to

methanolysis at 100 °C for 1 h. After cooling the tubes in ice, 640  $\mu$ L of a solution of K<sub>2</sub>CO<sub>3</sub>

154 11% solution was added and the phases were mixed by vortexing. Then 1.25 mL of hexane

155 were added and after separation the organic layer was isolated. The Fatty Acid Methyl Esters

156 (FAMEs) of the total lipids were then dried and reconstituted in hexane.

157 Aliquots (50 to 300 mg) of homogenized different tissue samples (duodenum, jejunum, ileum,

liver, adipose tissues) were weighed exactly before proceeding to the total lipid extraction

using 6 to 7 mL of a mixture of chloroform:methanol (2:1, v:v) according to the Folch method

160 <sup>[14]</sup>. Particular attention was paid to maintaining the ratio of 20 mL CHCl<sub>3</sub>:MeOH (2:1, v:v)

161 /mg of tissue. Sometimes it was necessary to add PBS to keep a ratio of 0.2 between aqueous

162 phase and CHCl<sub>3</sub>: MeOH solvent phase. The total lipids were then submitted after drying to

163 direct methylation as for the plasma samples.

164 The amounts and isotopic enrichments of oleic acid in plasma, and in different tissues were

determined using GC-C-IRMS (Isoprime Ltd; Elementar)<sup>[13]</sup>. The capillary column was a

166 SP2380, 30 m× 0.25 mm× 0.20  $\mu$ m film thickness (Supelco, Sigma-Aldrich). Injection (1  $\mu$ L)

was performed in splitless mode at 240 °C, with a splitless time of 1 min. The FAMEs were separated at constant flow (1.2 mL.min–1) with the following oven program: (a) 50°C for 1 min; (b) increase at a rate of 11°C.min-1 up to 175°C and hold for 5.64 min; (c) increase at a rate of 5°C.min-1 up to 220°C. <sup>13</sup>C isotopic enrichment was expressed in  $\delta$  ‰ against Pee Dee Belemnite <sup>13</sup>C international standard (PDB).

173  $[1-^{13}C]$ -oleate postprandial response was expressed as area under the curve (AUC) of  $[1-^{13}C]$ -174 oleate plasma concentrations.

## 176 **2.5.Statistical analysis**

177Results are expressed as means  $\pm$  SEM (standard error of the mean). The trapezoidal178approximation method was used to calculate the AUC of the postprandial plasma retinyl ester179and lipid concentration over 6 h. Differences in the postprandial concentrations over time180were tested by repeated-measures ANOVA. Differences between only two groups were181analysed by Student's t test. Values of p < 0.05 were considered significant. All statistical182analyses were performed using Prism (GraphPad Prism version 8.4.3).

#### 184 **3. Results**

185

### 186 **3.1.** Characteristics of rat offspring

187 VAD diet-fed young rats display a body weight non-significantly different from that of

188 control young rats (Figure 2A and 2E). However, heart and liver were smaller (p<0.05) in

189 VAD diet-fed females than in control females, while kidney and heart were smaller (p < 0.05)

190 in VAD diet-fed males than in control males (**Table 1**).

191 In VAD diet-fed rats, fasting glycemia was lower than in control animals (p<0.05; Figures 2B

and 2F), while glucose tolerance was improved, especially in male rats (p<0.05; Figures 2C-

193 **D** and 2G-H). However, when expressed as delta value with fasting glycemia, glycemia AUC

194 was significantly lower in VAD-diet-fed males compared to control males only  $(49.2 \pm 8.1)$ 

195 mg.h/dL vs  $52.7 \pm 9.5$  mg.h/dL in control females vs VAD diet-fed females;  $51.5 \pm 6.8$ 

mg.h/dL vs 22.1 ± 9.4 mg.h/dL in control males vs VAD diet-fed males, p < 0.05; graphs not</li>
shown).

### 199 **3.2. Rat offspring from** VAD diet-fed group **displays vitamin A deficiency**

200 Both female and male young rats from VAD diet-fed group showed a significant decrease in

fasting plasma retinol concentrations compared to control animals (-67  $\pm$  1.8% and -77  $\pm$ 

202 2.8%, in females and males, p<0.05, respectively; Figure 3A and 3C).

Additionally, both female and male young rats from VAD diet-fed group exhibited almost no

vitamin A stock in the form of retinyl esters at the hepatic level (Figure 3B and 3D).

Interestingly, in control animals, retinolemia was significantly lower in female than in male young rats (-  $47 \pm 1.2 \%$ , p<0.05), while retinyl ester content was higher in female liver than in male liver (+156% ± 19.8 %, p<0.05).

### 209 3.3. Rat offspring from VAD diet-fed group displays lipid abnormalities at fast

- 210 Female young rats from VAD diet-fed group had lower plasma triglyceride, phospholipid and
- cholesterol concentrations than control animals (-26  $\pm$  5.4%, -18  $\pm$  2.6% and -31  $\pm$  3.6%,
- 212 p<0.05, respectively; Figure 4A, 4B and 4C). Male young rats from VAD diet-fed group had
- lower plasma triglyceride concentrations than control animals (-34  $\pm$  5.6%, p<0;05; **Figure**
- 4G). Male fasting plasma phospholipid and cholesterol concentrations remained unchanged

### 215 (**Figure 4H,4I**).

Liver triglyceride concentration was reduced in VAD diet-fed female young rats compared to control females (-25  $\pm$  18%; **Figure 4D**), but the difference remained non-significant. Female liver phospholipid and cholesterol concentrations remained unchanged (**Figure 4E, 4F**). Male young rats from VAD diet-fed group displayed a non-significant (p= 0.10) lower triglyceride

- 220 concentration compared to control animals (-57  $\pm$  17%; **Figure 4J**), while phospholipid
- concentration was significantly higher (+63  $\pm$  10%, p<0.05; Figure 4K). Male cholesterol
- concentration was not modified (Figure 4L).

# 3.4. Postprandial retinyl ester kinetics of appearance in plasma is modified in VAD dietfed young rats compared to controls

226 Dietary vitamin A is absorbed by the enterocytes in its free form. Once absorbed, vitamin A is

227 re-esterified and secreted to bloodstream packed into chylomicrons. Postprandial plasma

retinyl ester concentrations after an oral vitamin A load were lower in both VAD diet-fed 228 male and female young rats compared to controls during the first 3 h (-48  $\pm$  7.9% in females 229 at t=1h30;  $-24 \pm 12.2$  % in females at 3h;  $-55 \pm 6.8$ % in males at 1h30,  $-49 \pm 2.4$ % in males at 230 231 3h), although these differences remained non-significant due to interindividual variability. Then, the postprandial plasma concentrations in retinyl esters increased in VAD diet-fed 232 young rats compared with control animals 4h30 after gavage (+192  $\pm$  144% in females and 233  $+158 \pm 40\%$  in males (p<0.05), respectively) (Figure 5A and 5E). Retinyl ester peak was 234 delayed in both VAD diet-fed groups (maximum peak at 4h30 in VAD diet-fed groups vs 1.5-235 3h in control groups). Overall, no difference in total dietary vitamin A absorption, expressed 236 237 as area under the postprandial plasma concentration of retinyl esters, between young rats from VAD diet-fed group compared to control animals was observed (Figure 5B and 5F). 238 After being released in the bloodstream, retinyl esters are taken up by the liver, where they 239 can be either stored or secreted back to the bloodstream in the form of free-retinol. Retinol 240 postprandial plasma concentrations were significantly increased in both VAD diet-fed female 241

and male young rats compared with control animals 4h30 after gavage (+116 ± 54% and +303
± 39%, p<0.05, respectively) (Figure 5C and 5G), leading to an increase in retinol</li>
postprandial response (expressed as a delta value with fasting retinol concentration, Figure

245 **5D and 5H**).

In the ileum, decreases in retinyl ester and total vitamin A concentrations were observed in VAD diet-fed females compared to controls ( $-70 \pm 8.4\%$  for retinyl esters, p<0.05), while increases in retinyl esters and retinol were observed in VAD diet-fed males compared to controls (+81 ± 76% for retinyl esters, p<0.05; **Figure 6A and 6B**).

# 3.5. VAD diet-fed young rats accumulate lipids in their intestine during the postprandial period compared to controls

- Table 2 showed that VAD diet-fed animals display significantly higher lipid concentrations in
- their intestines at fast than control animals:  $+474 \pm 32.0$  % ileal triglycerides,  $+182 \pm 37.0$  %
- duodenal cholesterol,  $282 \pm 65.2\%$  ileal cholesterol,  $+114 \pm 18.4\%$  ileal phospholipids in
- females; +144  $\pm$  43.9 % of duodenal triglycerides, +243  $\pm$  21.1 % jejunal triglycerides in
- 257 males (p<0.05). VAD diet-fed males also displayed a significant decrease in duodenal
- 258 phospholipids concentration compared to controls (-49  $\pm$  3.4%, (p<0.05).
- 259 This observation was exacerbated during the postprandial period for triglycerides in males.
- Indeed, **Figure 7** shows that VAD diet-fed animals also accumulated lipids in their intestine during the postprandial period, compared to control animals:  $+88 \pm 8.3\%$  of ileal triglycerides (**Figure 7A**),  $+152 \pm 35\%$  ileal cholesterol (**Figure 7B**) and  $+73 \pm 7\%$  ileal phospholipids in females (**Figure 7C**);  $+162 \pm 31\%$  of jejunal and  $+3614 \pm 558\%$  of ileal triglycerides (**Figure 7D**),  $+70 \pm 16\%$  jejunal and  $+109 \pm 11\%$  ileal phospholipids in males (**Figure 7F**) (p<0.05).

# 3.6. [1-<sup>13</sup>C]-oleate postprandial response is decreased in VAD diet-fed male young rats compared to controls

As triglyceride postprandial accumulation was higher in male intestines than in female intestines (Figures 7A and 7D),  $[1^{-13}C]$ -oleate postprandial metabolism was further explored in male offspring. For both VAD diet-fed young males and control males, the maximum absorption peak of  $[1^{-13}C]$ -oleate was at 3h post-ingestion of the emulsion containing the labelled triacylglycerol  $[1,1,1^{-13}C]$ -triolein (**Figure 8A**). However, the postprandial plasma response in  $[1^{-13}C]$ -oleate was decreased in VAD diet-fed young male rats between 0-6h: -27  $\pm 4.7\%$ , p<0.05, **Figure 8B**). Concomitantly,  $[1^{-13}C]$ -oleate concentration in the ileum was

- higher in VAD diet-fed young rats than in control animals (+428  $\pm$  215%, p<0.05; Figure **8C**).
- Interestingly,  $[1^{-13}C]$ -oleate concentrations in the liver and in the white adipose tissues at t =
- 6h post gavage were also higher in VAD diet-fed young rats than in control animals (Figure
- **8D and 8E**). Conversely,  $[1-^{13}C]$ -oleate concentrations in the brown adipose tissues at t = 6h
- 280 post gavage remained unchanged (**Figure 8F**).

### 282 **Discussion**

283

Our aim was to study the effect of vitamin A deficiency during pregnancy, lactation and the first weeks of life in young rats on vitamin A and lipid postprandial metabolism. This period corresponds to the perinatal and childhood/beginning of adolescence period in humans <sup>[15]</sup>,

which is critical for both a healthy development and a future healthy life  $^{[16]}$ .

288 Real vitamin A deficiency is usually difficult to reach when performing animal study. Indeed, vitamin A is stored in high amounts in rodent liver <sup>[17]</sup>, which allows the organism to go 289 290 through mid- to long-term vitamin A deprivation without phenotypic incidence. In this study, we fed rats with either a VAD diet or a control diet 6 weeks before mating them. The females 291 also received these diets during the gestation/lactation period. Vitamin A amount in the 292 deficient diet was chosen according to previous work performed in rats <sup>[18]</sup>, and can be 293 considered as moderate compared to other studies <sup>[19]</sup>. As expected, the offspring born from 294 mothers fed the VAD diet showed a significant vitamin A deficiency proven by the lack of 295 retinyl esters in the liver associated with a low retinolemia as compared to control rats. It is 296 noteworthy that liver was almost totally deprived of vitamin A, likely to maintain the 297 circulating vitamin A concentration as high as possible. Interestingly, retinolemia was lower 298 in female than in male young rats, which is in agreement with data obtained in humans <sup>[20]</sup>. As 299 females stored higher amounts of vitamin A in their liver compared to males, this may be a 300 301 different regulation of hepatic vitamin A mobilization between females and males. Food intake was not monitored in this study, but no major body weight or brain weight 302 alterations were measured in offspring. Liver and/or kidney and/or heart could be smaller in 303 the VAD diet-fed groups, as previously observed <sup>[21]</sup>. The reduction in fasting glycemia and 304

305 increase in glucose tolerance in both female and male VAD diet-fed rats indicated an

improvement of glucose homeostasis. We hypothesize that the VAD diet-induced decrease in 306 triglyceride concentrations in plasma and liver (see below) explains this improved glucose 307 homeostasis. Indeed, excess of circulating triglycerides is known to result in their 308 309 accumulation in peripheral tissues, including liver and skeletal muscle. Both tissues are implicated in glucose homeostasis and an increase in triglyceride concentration in these 310 tissues renders them less sensitive to insulin, which results in an increased production of 311 glucose by the liver and a reduced uptake of glucose by muscle, both contributing to a 312 deterioration of glucose homeostasis <sup>[22]</sup>. In our study, the decrease in fasting triglyceride 313 concentrations in plasma and liver (and possibly also in muscle) in VAD diet-fed rats 314 315 probably led to an improvement of insulin action. However, this improvement is likely transient, as adult VAD diet-fed rodents have been reported to display glucose homeostasis 316 impairment <sup>[23]</sup> together with increased adiposity <sup>[24]</sup> compared with control animals. 317 Both VAD diet-fed female and male young rats displayed plasma lipid abnormalities 318 compared to control animals. In particular, fasting plasma triglycerides were lower in VAD 319 diet-fed animals compared to controls. Fasting cholesterol and phospholipid levels in plasma 320 of VAD diet-fed females were also lower than in control females. These data are consistent 321 with a recent study showing that retinoic acid reduced hepatic lipoprotein secretion <sup>[25]</sup>. These 322 323 data also confirm an alteration of lipid metabolism in rats as a symptom of vitamin A deficiency, in agreement with previous published data <sup>[26,27]</sup>. In particular, Oliveros and 324 colleagues showed that vitamin A deficiency induced a hypolipidemic effect by decreasing 325 both serum triglyceride and cholesterol levels in male rats <sup>[27]</sup>. Authors also observed a 326 significant decrease in phospholipid hepatic contents, while our results highlighted an 327 328 increase in total phospholipid contents. Further investigations are needed to explain this discrepancy. However, authors showed that the de novo synthesis of fatty acids was decreased 329 330 in the liver of VAD diet-fed rats compared to controls, which may explain the non-significant

- but relatively important - decrease in hepatic triglyceride contents observed in our study (25% in females and -57% in males).

333

Previous studies have evaluated the effect of vitamin A status on provitamin A carotenoid intestinal absorption and cleavage efficiency <sup>[28–30]</sup>. However, there was no study dedicated to assessing whether vitamin A status also modulates the intestinal absorption efficiency of preformed vitamin A so far. We thus explored the ability of the young rats to absorb retinyl palmitate from an oil-in-water emulsion.

339 After ingestion, retinyl palmitate is hydrolyzed into retinol in the lumen under the action of pancreatic lipases. Retinol is incorporated into mixed micelles to be taken up by enterocytes. 340 Once in the cytosol of the intestinal cells, the majority of the retinol is re-esterified into retinyl 341 palmitate, retinyl oleate, retinyl stearate and retinyl linoleate. These esters are packed into 342 chylomicrons and then secreted in the bloodstream (see for review<sup>[1]</sup>). Finally, these esters 343 are taken up by the tissues, and mainly by the liver. The liver then secreted retinol back to the 344 bloodstream associated with its carrier proteins RBP (retinol binding protein) and 345 transthyretin<sup>[31]</sup>. Postprandial retinyl ester response, i.e. AUC, to a vitamin A load thus 346 constitutes a good marker of vitamin A secretion to the blood. Overall, postprandial plasma 347 retinyl ester responses did not differ between VAD diet-fed and control groups. However, a 348 close look at the plasma retinyl ester kinetics showed marked differences between VAD diet-349 fed and control animals. Indeed, in both females and males, plasma retinyl ester 350 concentrations were lower during the first 3 h after force-feeding, and a sudden increase of 351 retinyl esters occurred at 4.5 h, compensating the initial reduced concentrations. The 352 mechanism underlaying such compensation is not known but may be linked to either a delay 353 of lipid intestinal absorption/secretion, or a modification of retinyl ester clearance (see next 354 paragraph). Interestingly, our data also highlight an increase in postprandial plasma retinol 355

concentration in the VAD diet-fed groups compared to controls at 4.5 h post force-feeding. 356 Such increase in retinolemia after an oral charge in vitamin A is expected in VAD diet-fed 357 individuals. It actually corresponds to the relative dose response (RDR) test that was 358 developed to evaluate vitamin A status in humans suspected to be vitamin A deficient. Serum 359 retinol concentrations are determined before and 5 hours after an oral dose of vitamin A. In 360 VAD diet-fed adults and children, the retinolemia is expected to increase significantly at 5 h 361 as compared to the fasting value due to the mobilization of a stock of apo-RBP accumulated 362 in the liver <sup>[32,33]</sup>. Our results are consistent with these data, and further highlight that our 363 VAD diet-fed groups present a real vitamin A deficiency. Besides this release in hepatic RBP, 364 365 we suggest that another unknown intestinal mechanism leading to a concomitant release of retinyl esters also occur, leading to a simultaneous peak of retinyl esters. 366

At the intestinal level, our data showed a decrease of vitamin A in female ileum, while vitamin A ileal content was increased in males. This difference may be due to difference in either the rate or the efficiency of vitamin A secretion to the bloodstream. The effect of sex on chylomicron secretion rate has not been specifically assessed yet. However, it is acknowledged that vitamin A response is often lower in women than in men, due to a more efficient chylomicron-remnant clearance <sup>[34]</sup>.

373 Interestingly, lipids (triglycerides and cholesterol for females, triglycerides only for males) were shown to accumulate in the distal intestine of VAD diet-fed animals compared to control 374 during the postprandial period. This was confirmed by the analysis of the fatty acid  $[1-^{13}C]$ -375 oleate coming from the triacylglycerol [1,1,1-13C] triolein incorporated into the oil-in-water 376 emulsion used for the force-feeding. Indeed,  $[1-^{13}C]$  oleate also accumulated in the ileum at 377 6h in male intestine. Such accumulation can be either due to an increased absorption by ileal 378 enterocytes, or due to a defect in secretion from ileal enterocytes to the bloodstream. This 379 accumulation of  $[1^{-13}C]$ -oleate was accompanied by a decrease in  $[1^{-13}C]$ -oleate postprandial 380

response in the VAD diet-fed group compared to the control group. A first hypothesis is thus 381 that VAD-diet-fed animals display abnormal lipid secretion to the bloodstream compared to 382 control animal. This may explain the alteration of plasma and hepatic lipids measured at fast 383 in the VAD groups. It may also explain the decrease of retinyl ester appearance in plasma 384 during the initial phase of the postprandial period. However, as the intestine is able to store 385 fat-soluble compounds from a first meal to secrete them to the bloodstream following a 386 subsequent meal<sup>[35]</sup>, further investigations are needed to assess the fate of both vitamin A and 387 lipids accumulated in VAD diet-fed rat intestine. A second hypothesis that could explain the 388 decrease lipid postprandial response in VAD diet-fed rats is that these animals display 389 increased lipid clearance during the postprandial period. To this aim, we measured  $[1-^{13}C]$ -390 oleate accumulation in the liver, white and brown adipose tissues of male young rats. The 391 uptake of  $[1-^{13}C]$ -oleate by the liver and the white adipose tissue was significantly increased 392 393 in VAD diet-fed rats compared to controls. The reduced postprandial oleate response in VAD animals can thus also be due to an increased fatty acid uptake by some peripheric tissues, in 394 395 relation with an increased chylomicron clearance.

The molecular mechanisms underlying such modulation of lipid postprandial metabolism are 396 not known yet. However, several hypotheses can be done. First, the effect of vitamin A 397 deficiency, via retinoid signaling, on intestinal lipid transporter such as SR-BI has previously 398 been described <sup>[29]</sup>, although lipid intestinal absorption was not fully characterized in this 399 work. The authors showed that i) retinoic acid via retinoic acid receptors induced expression 400 of the intestinal transcription factor ISX and ii) ISX then repressed the expression of SR-B1. 401 In another study, Vega and colleagues explored the effect of dietary vitamin A deprivation on 402 403 lipid composition and mRNA expression of regulatory enzymes involved in rat heart energetic lipid metabolism. Authors showed that lipid metabolism was significantly modified 404 405 in heart of vitamin A-deficient rats, and that alteration of mitochondrial energetic processes

was associated with a high PPARα and β expression induced by vitamin A deprivation <sup>[36]</sup>. At
the intestinal level, the activation of PPARα has been associated with a decrease in
hyperlipidemia in mice <sup>[37]</sup>, and more specifically with a decrease in cholesterol absorption in
mice <sup>[38]</sup> and a decrease in lipid uptake and secretion to the basolateral medium in Caco-2
cells <sup>[39]</sup>. Intestinal PPARα activation in our VAD diet-fed group may have contributed to the
decrease in lipid absorption in these animals compared to controls.

Finally, another study have showed that vitamin A deficiency altered host and gut microbial
metabolism leading to altered energy homeostasis in mice <sup>[40]</sup>. As modifications of gut
microbiota are likely linked to modulations of intestinal lipid metabolism <sup>[41]</sup>, vitamin A
deficiency may have indirectly impacted lipid absorption in the VAD diet-fed groups.
Possible interactions between lipid and vitamin A postprandial metabolism should be
addressed in a specific postprandial study, using a control condition with an oil-in-water
emulsion without retinyl palmitate.

419

Overall, we showed for the first time that in rats, vitamin A deficiency delays the peak of 420 421 retinyl esters in plasma after an oral vitamin A load, although total vitamin A postprandial response remains unchanged compared to control animals. We also showed that vitamin A 422 deficiency modulates lipid postprandial metabolism, which can partly explain the altered lipid 423 status in the plasma and the liver of VAD diet-fed rats observed at fast. Further research is 424 needed to evaluate whether such modifications in vitamin A and lipid postprandial 425 426 metabolism are due to differential gene/protein regulations and/or to gut microbiota modulation. Furthermore, in connection to vitamin A deficiency, the impact of 427 supplementation studies is currently under investigation in our laboratory. 428

### Figure 4: Young rat lipid concentrations in plasma and liver at fast

Plasma sample was taken at the tail of each young rat fasted overnight. After euthanasia, liver was promptly harvested and stored in liquid nitrogen. Total cholesterol, phospholipid and triglyceride plasma and tissue content were then assessed.

A-F: Female rats. G-L: Male rats.

### Figure 5: Postprandial plasma vitamin A responses in young rats

Young rats were forced-fed with an oily emulsion containing retinyl palmitate and <sup>13</sup>Ctriolein. Blood sample were obtained before force feeding and every 90 min from a tail nick. Retinol and retinyl esters were extracted with two volumes of hexane and analyzed by HPLC.

A, E: Postprandial plasma retinyl ester concentrations in females and males, respectively.

**B**, **F**: Postprandial plasma retinyl ester response expressed as area under the curve (AUC), in females and males, respectively.

# Figure 6: Vitamin A concentrations in the intestinal mucosa at the end of the postprandial experiment

Figure 8: Postprandial plasma and intestinal mucosa [1-<sup>13</sup>C]-oleate concentrations in male young rats

Young rats were forced-fed with an oily emulsion containing retinyl palmitate and  $[1,1,1^{-13}C_3]$ -triolein. Blood sample were obtained before force feeding and every 90 min from a tail nick. Young rats were euthanized at 6 h min. Duodenal, jejunal and ileal samples were promptly harvested and stored in liquid nitrogen.  $[1^{-13}C]$ -oleate coming from the labelled triolein ingested was assessed by GC-C-IRMS analysis.
