Variation in Pyrethroid Resistance Phenotypes in Anopheles darlingi in an Area with Residual Malaria Transmission: Warning of Suspected Resistance in French Guiana

Abstract. Anopheles darlingi is the main vector of malaria in South America. In French Guiana, malaria transmission occurs inland and along the rivers with a regular reemergence in the lower Oyapock area. Control against malaria vectors includes indoor residual spraying of deltamethrin and the distribution of long-lasting impregnated bednets. In this context, the level of resistance to pyrethroids was monitored for 4 years using CDC bottle tests in An. darlingi populations. A loss of susceptibility to pyrethroids was recorded with 30-minute knock-down measured as low as 81%. However, no pyrethroid molecular resistance was found by sequencing a 170 base pair fragment of the S6 segment of domain II of the voltage-gated sodium channel gene. Fluctuation of resistance phenotypes may be influenced by the reintroduction of susceptible alleles from sylvatic populations or by other mechanisms of metabolic resistance.

Anopheles darlingi is the main vector of malaria in South America. For decades, this species has been targeted by vector control program using indoor residual spraying (IRS) and bednet distribution. Anopheles darlingi has the ability to adapt its behavior across its distribution.¹⁻³ Known as a sylvatic mosquito, its density drastically increases in the presence of human settlements. However, little evidence of insecticide resistance exists in this species.^{4,5}

In French Guiana, a French overseas territory, An. darlingi is found across the territory and remains strongly associated with malaria outbreaks that occur along the rivers and inland close to goldmine settlements.^{6–9} A drastic decrease of malaria incidence has been observed the last 20 years, but the area of Saint Georges de l'Oyapock (STG), at the border with Amapa state (Brazil), remains impacted.¹⁰ In riverine areas with high malaria transmission, deltamethrin-based control has been implemented. It is noteworthy that only molecules from the pyrethroid family are authorized for killing of adult mosquitoes under French regulation. In the context of malaria control, chemical methods to reduce vector populations must be carefully monitored.

Two populations of An. darlingi from French Guiana were studied. The first one was located at La Césarée (LC) farm $(5^{\circ}0^{\prime}$ 54.59 $^{\prime}$ N; 52 $^{\circ}32^{\prime}$ 2.35 $^{\prime}$ O), a malaria-free location located 45-minute drive west from Cayenne, the capital town. This equine and bovine farm is surrounded by humid savannah. No insecticidal treatment is performed in this area; the population at LC was considered a reference for this study. The second site was situated in Blondin (BL) hamlet $(3°52'$ $31.2[']N$; $51°53'$ 12.9[']O), accessible by 5-minute boat ride from STG and located on the Brazilian border.

Mosquito collections were performed in 2014, 2015, 2016, and 2018 using either supervised human landing collection (HLC) or, because of a malaria outbreak in 2018 in BL, mosquito magnet (MM) trap was used (Table 1). Local volunteer residents were trained on HLC and informed of the associated risks. Malaria prophylaxis was proposed and information on the medication was provided. Collectors who participated in the HLC activities gave their free, express, and informed consent. Mosquito magnet collections were performed by retrieving the nets every 30 minutes to 1 hour and storing the samples in cups to prevent mosquito deterioration. At the reference LC site, female mosquitoes were stored in $cups^{11}$ and transported by car to our Cayenne main laboratory within 2 hours, where test conditions were controlled at 28° C and 90% relative humidity. Those collected in BL were stored in cups of approximatively 25 mosquitoes and transported to our field laboratory in STG within 4 hours of collection. This laboratory room maintained field temperature and humidity (approx. 28° C and above 80% humidity) throughout the day. Samples collected by either method from two field populations were subject to CDC bottle tests.¹² Groups of female mosquitoes were exposed to one of the four insecticides for each time point and site with a minimum of four replicates each. Control bottles coated with solvent contained 10–25 field-collected female mosquitoes for each time point and site (Table 1). Insecticide resistance was evaluated at the diagnostic dosages recommended by the CDC for deltamethrin $(12.5 \mu g/bottle)$, permethrin (21.5 μ g/bottle), and alpha-cypermethrin (12.5 μ g/bottle). In addition, malathion (50 μ g/bottle) was tested for BL collections in 2014 and 2015 (Table 1). For the three pyrethroids (deltamethrin, permethrin, and alpha-cypermethrin), the number of knocked-down mosquitoes, both dead and unable to fly, was recorded every 5 minutes in the pyrethroid-impregnated bottles for a minimum of 30 minutes (diagnostic time, 30 KD) or until 100% of the mosquitoes were knocked down (Table 1). The number of dead mosquitoes in the malathion-impregnated

bottles was recorded at 30 minutes (Table 1). Morphological species identification was performed after the test according to keys specific to the region.

Raw data were corrected by Abbott's formula when needed.¹³ KT50 values, the theoretical time to knock down/kill 50% of mosquitoes exposed to pyrethroids, was calculated based on 30 KD with a minimum of four time points producing from 0% to 100% of KD at 30 minutes of exposure. The probit regression of the knock-down response over time was performed in BioRssays (Montpelier, France)¹⁴ in the R environment, which produces P value for the logistic regression significance. In addition, ratios of KT50 usually calculated with the KT values divided by the same values for reference strain (population from LC) were calculated for each insecticide by dividing the obtained values by the minimal KT in the panel.

All mosquitoes were identified as An. darlingi. All populations with a 30[']KD above 98% were diagnosed as susceptible. Tests performed with malathion in BL mosquito collections revealed susceptibility to that molecule with 100% of mosquitoes dead at 30 minutes in 2014 and 2015. As expected, the LC population was susceptible to all pyrethroids at all collection times (Table 1). However, we observed that pyrethroid 30 KD values varied and some were below the 90% threshold for resistance in BL (Table 1). In 2014 and 2016, when samples were collected and tested for multiple time points in the same season, susceptibility varied from one collection to the next. In 2015 and 2018, susceptibility was recorded for only 1 week of collection samples.

To further investigate the fluctuation of KD response with pyrethroids, KT50 and associated ratio (RKT) were obtained. First, they confirmed the trends observed for the end-point measures at 30 minutes. La Césarée population had the lowest KTs overall, whereas KT from BL-2016-38 were the highest recorded in BL for all insecticides tested. The lowest values at LC were used to calculate RKT50 for each insecticide (Table 2). The ratio calculated with those values highlighted that the population of BL-2014-38 exposed to deltamethrin and that of BL-2016-38 exposed to any pyrethroids had a resistance ratio (RKT50) above 2, demonstrating incipient resistance, as it takes twice as much time to knock down mosquitoes in BL than in LC. Second, we observed that the slope of regression was lower in BL than in LC populations, suggesting that even if the data do not support full resistance, knock down takes longer in BL than in LC.

To understand the mechanisms underlying the suspected resistance, the voltage-gated sodium channels (vgsc) gene was amplified and sequenced from individualized surviving $(N = 16)$ and dead $(N = 32)$ mosquitoes exposed to permethrin from BL in 2014. Both strands of 170 base pairs fragment of the vgsc was sequenced as described in Orjuela (2019).¹⁵ The codons 1010, 1013, and 1014 at the S6 segment of domain II is used to identify point mutations, which have been associated with insecticide resistance in different species of Anopheles malaria vectors. No mutation on the vgsc fragment was detected. The sequences obtained showed 100% identity with amino acid sequences already published¹⁵ (GenBank accession number MN053065). The observations described here, made over multiple years, raise the concern of insecticide resistance development in An. darlingi population in places where the use of

pyrethroids is widespread.¹⁶ The population living in STG along the Oyapock River suffers from recurrent malaria transmission (between 30% and 50% Plasmodium vivax malaria prevalence depending on the year¹⁶). In recent years, IRS was only conducted together with spatial spraying to control outbreaks, while the distribution of LLINs occurred in 2021 with deltamethrin-impregnated nets and in 2016 with alpha-cypermethrin-impregnated nets. In BL, LLIN usage reached 95.7% .¹⁶ Deltamethrin is also used for IRS and occasionally for Aedes control. Communities use household insecticides containing pyrethroids for several domestic pest control purposes.

In 2014, BL was the epicenter of malaria transmission in STG. After several years without any large outbreaks, a drastic resurgence appeared in Trois Palétuviers in 2017. This hamlet is situated downstream of STG on the Oyapock river. At the same time, the French Guiana population suffered from chikungunya and Zika outbreaks against which pyrethroid-based control was performed. None of these insecticidal applications are implemented in LC. Despite this frequent and regular use of insecticides, An. darlingi-resistant populations are rare across its distribution, unlike Aedes aegypti, which have shown a drastic increase of resistance.17 In fact, reliable efficacy of chemical control methods against An. darlingi is observed, in contrast to Ae. aegypti populations that became resistant. The hypothesis formulated at that time was that populations of An. darlingi remained susceptible because of the continuous introduction of naive mosquitoes with susceptible alleles from forested areas to urbanized ones. Population genetic studies tend to support this hypothesis.¹⁸ Anopheles darlingi resistance development seems to be slowed down or nullified by this dilution effect. This factor may partially explain the variation in pyrethroid susceptibility in our monitoring data.

Resistance to pyrethroids is a crucial issue in French Guiana. As a European territory, the use of mosquito adulticides is restricted to pyrethroids. The resulting monotherapy creates pressure on mosquito populations to develop resistance.

Insecticide resistance surveillance should be sustained in areas that experience malaria transmission with regular monitoring of resistance and associated molecular markers to detect resistance early and develop an appropriate management plan. In our small sample set mutations in the voltage-gated sodium channel, gene were not seen, but resistance to pyrethroids can be mediated by other mechanisms, as previously studied in Colombia.¹⁵ The An. darlingi populations from Colombia exhibit metabolic resistance involving oxidases and esterases.¹⁹ Further investigation on mechanisms of metabolic resistance is required to maintain an effective toolbox of molecules for vector control and reduce malaria transmission in the region.
