# What do Lateglacial and Holocene land snail communities tell us about the palaeoenvironments of Mediterranean France?

Southeastern France occupies a key biogeographical position on the lower Rhone corridor, at the interface between southern and northern Europe. It is also at the heart of long-standing ecological debates about the respective roles of natural and human drivers in shaping the Mediterranean landscape. Molluscan analysis may represent a valuable contribution to this issue. In this paper, land snail assemblages from three calcareous tufa deposits in the Luberon mountain were used to reconstruct Lateglacial and Holocene palaeoenvironments. The Lateglacial communities only differ from the Pleniglacial ones by the development of hygrophilic snails. We note a high moisture budget at the end of the Lateglacial Interstadial (LGI). A patchy, steppe landscape is attested. A time lag in recolonization by woodland species during the LGI is conceivable. The postglacial woodland assemblages then trace a laborious reassembly of forest snail communities. It takes place mainly between c. 8000 and c. 6600 cal. a BP with spatial disparities and delayed recruitments. The French Mediterranean region has not benefitted from the macrorefugia that it would have sheltered or with which it would have been close. Woodlands, however, appear progressively more closed and complex c. 8000 cal. a BP. They reached their optimum c. 7500 to 7400 cal. a BP although their canopy seems to have stayed quite open. Anthropization remained weak during the Early Neolithic. A significant woodland opening is observed in the Early-Middle Neolithic. Human impact becomes clear from the Late Neolithic. Nevertheless, there are substantial differences compared with Basse-Provence, where a more marked openness of the landscape from 7000 cal. a BP was accompanied by the development of Mediterranean synanthropic snails. The molluscan successions of the Luberon mountain should be a reference for the development of the Lateglacial and Holocene malacofauna in the SE of France, at the northern boundary of the western Mediterranean domain.

Mediterranean France is a key region to study the postglacial recolonization by terrestrial molluscs in a fragile geosystem progressively shaped by a fluctuating climate and a long history of human land use. The relevance of this region lies in its properties as an ecotone between Mediterranean and temperate Europe and as a complex crossroads of recolonization routes from glacial refugia, of colonization and exchanges by human groups and of natural as well as human-mediated dispersal of snails (Germain 1930; Blondel *et al.* 2010; Binder *et al.* 2017; Battentier *et al.* 2018).

The terrestrial malacofauna between the eastern Pyrenees and the Ligurian Alps presents a high level of endemism (Falkner *et al.* 2002; Gargominy *et al.* 2011). Holyoak (1989) suggested that the modern ranges of extremely localized woodland species in this area could indicate the likely location of glacial refugia. Médail and Diadema (2009) have located there three putative glacial refugia for cold-sensitive plants. The French Mediterranean region is also at the crossroads of recolonization routes from two major refugia, i.e. the Iberian and Italian peninsulas, which contributed to the repopulation of

northern parts of Europe by various organisms (Huntley 1988; Hewitt 1996, 1999; Preece 1997; Taberlet et al. 1998; Michaux et al. 2003; Limondin-Lozouet & Preece 2014). Although there is accumulating evidence for the existence of scattered cryptic refugia or microrefugia (Ant 1966; Bilton et al. 1998; Stewart & Lister 2001; Pfenninger et al. 2003; Schmitt & Varga 2012; Salvi et al. 2013; Juřičková et al. 2014; Fiorentino et al. 2016; Kühne et al. 2017), the paradigm of postglacial recolonizations from southern macrorefugia remains well established (Vialatte et al. 2008). It is therefore essential to seek fossil evidence in favour of one or the other of these recolonization processes (Horsák et al. 2019).

In the Mediterranean region, it quickly becomes difficult to distinguish the respective impacts of climate and human activities (Roberts *et al.* 2011), as in the case of interpreting Holocene molluscan assemblages (Martin 2004; Magnin & Martin 2008; Magnin *et al.* 2022). The settlement of the first agropastoral societies in SE France is dated between 5826 and 5470 cal. a BCE (Binder *et al.* 2017). The Neolithic Culture first




Fig. 1. Maps showing the location of the Luberon mountain (A) and of the three study sites (B): La Thomassine, MIR-1 La Stèle and MIR-5 Le Verger.

concerned the coast before spreading into the hinterland. Although the various stages of anthropogenic alterations regarding the composition of the vegetation are well documented, the consequences of human impact in terms of stand and landscape structures still are in debate (Battentier 2022). Molluscs may represent a useful independent source as a proxy for past forest structure (Mitchell 2005). They are reliable indicators of the structure of both current plant stands and the landscape (Magnin *et al.* 1995; Magnin & Tatoni 1995; Labaune & Magnin 2001).

In the Mediterranean lowlands of Languedoc and western Provence, actual woodland snail assemblages are rare during the Holocene (Magnin 1991; Martin 2004; Magnin *et al.* 2022). Anthropization not only has altered landscape and snail habitats, but snail communities have

also been deeply modified by human-mediated dispersal of species (Aubry et al. 2005; Magnin & Martin 2012; Magnin et al. 2022). It is, however, essential to investigate the extent to which the intensity and precocity of the anthropization, so far revealed by malacological analyses, are not geographically circumscribed. Anthracological analysis indeed has highlighted significant regional disparities in vegetation dynamics during the Holocene (Battentier et al. 2018; Battentier 2022).




Fig. 2. Stratigraphy of the three studied sections (uncalibrated radiocarbon ages).

The present study on the Luberon aims to extend malacological investigations towards the border of the Mediterranean lowlands. Located at the boundary between Basse-Provence and Southern Alps (Fig. 1), this mountain offers a mixture of Alpine and Mediterranean characteristics (Ollivier *et al.* 2014). Quaternary deposits are abundant, including thick postglacial

calcareous tufas (Ollivier 2006). This type of sediment is sections (Fig. 2). Where possible, radiocarbon dates were measured on charcoal. Otherwise, they were measured either on minute shells, selecting species as much as possible to avoid the limestone effect (Brennan & Quade 1997; Pigati et al. 2004, 2010, 2013, 2015), or on earthworm granules (Moine et al. 2017). Radiocarbon dating was conducted by Poznan Radiocarbon Laboratory, Poznan, Poland, by Beta Analytic laboratory, Miami, USA, and by Centre de datation par le radiocarbone. Lvon, France. The dates were calibrated using the IntCal20 calibration curve (Reimer et al. 2020) and the program PAST 4.13 (Hammer et al. 2001). Several dates are not satisfactory. That of MIR-1 (8), measured on Jaminia quadridens for want of a better alternative, is affected by a significant limestone effect. The date obtained for MIR-1 (5c) on Succinella oblonga appears to be too young, for no obvious reason. The their habitats. amount of carbon available for MIR-1 (6d2) was small but the date is not significantly impacted. No age-depth model was proposed owing to the heterogeneous deposits studied, with variable and unpredictable sedimentation rates and undetectable hiatuses.

considered as one of the most suitable for palaeoecological investigations owing to the many proxies it preserves, including shells of continental molluscs (Alexandrowicz 2004; Granai et al. 2020). Furthermore, molluscs appear to be avaluable data source in this region where most of the pollen sequences are difficult to interpret, mainly on account of bad pollen preservation (Beaulieu et al. 2005). This is why the present work is based on snail assemblages contained in tufa deposits with the aims (i) to define Lateglacial and Postglacial snail communities and their environmental significance, (ii) to reconstruct the postglacial reassembly of woodland snail communities and compare it with that of temperate Europe, (iii) to question the structure and nature of Holocene woodlands and (iv) to look for the imprint of human activities on snail communities and

#### Regional setting and study sites

The three studied successions are located in the Luberon Regional Natural Park (Fig. 1). The Luberon is a calcareous mid-mountain which stretches from west to east for more than 60 km. It marks the boundary between Basse-Provence to the south Haute-Provence to the north. Our study focuses on the Grand Luberon and its eastern end, the Luberon de Manosque. The altitude of Grand Luberon Mountain (1125 m a.s.l.) is sufficient to produce a bioclimatic layering from the meso-Mediterranean to the supra-Mediterranean level (CNRS, ER 30 1975; Dumas 2013). Its southern foothills extend widely to the Durance River. The Luberon de Manosque is lower (790 m a.s.l.).

Two of the three sections analysed (Fig. 1) are located in the Mirail valley, on the southern foothills of the Grand Luberon, next to La Motte d'Aigues (Vaucluse). Situated on the right bank of the river, at c. 400 m a.s.l., MIR-1 La Stèle (43.755922°N, 5.547115°E) represents the oldest Lateglacial part of Le Mirail tufas (Ollivier 2006). Located downstream from the Mirail karstic source and upstream from the previous section, MIR-5 Le Verger (43.787462°N, 5.541658°E) is a thick Lateglacial and Holocene deposit. The third section is located near Manosque (Alpes-de-Haute-Provence), in the eastern part of the Luberon: La Thomassine (43.849887°N, 5.753327E°). This Holocene section is situated at ~500 m a.s.l. in a ravine that cuts deeply into marl formations.

#### Material and methods

#### Radiocarbon dating

Data on radiocarbon dating are listed in Table 1. Dates judged admissible are plotted on the stratigraphic

#### Molluscan analysis

Samples of sediment of 10 L each were collected at non-equidistant intervals according to the sedimentary characteristics of the deposits. Each corresponds to a thickness of about 10 cm. Consolidated tufas and excessively stony sediments were generally not sampled. The samples were processed following standard methods (Evans 1972; Puisségur 1976). For each taxon of each assemblage, the minimum number of individuals includes the number of unbroken shells augmented by the greatest number of identifiable fragments, either apical or apertural. We listed the species for which a minimum number of individuals could not be determined. In the case of *Pisidium*, the number of valves was reduced by half. The taxonomic nomenclature follows that of Welter-Schultes (2012), occasionally revised (Tables S1-S3). We have given up on identifying the Euconulus (Euconulus fulvus and Euconulus alderi). The same applies to two Vitriniids (Vitrina pellucida and *Phenacolimax major* = Vitrinidae sp. indet.) while a third, Oligolimax annularis, is easier to distinguish. In 2015, we reported the presence of Vitrea cf. etrusca (Paulucci 1878) in the Thomassine tufa. This snail has since been described as Vitrea luberonensis (Magnin 2023a, b).

The Holocene portion of the MIR-5 section was first studied by Martin (2004). The data were revised and supplemented with the Lateglacial part of the section. The Thomassine section had been the subject of a preliminary study (Ollivier et al. 2015). Sampling was completed and malacofauna revised. All the results are presented in diagrams showing for each assemblage the frequency of each species expressed as a percentage

of the total shells. This total excludes Cecilioides acicula, a burrowing species (Welter-Schultes 2012; Horsák et al. 2013). Species are arranged according to a combination of their ecological preferenda and their order of appearance in the stratigraphy. For each section there is also a diagram showing the main characteristics of the assemblages and their composition by ecological groups. This approach by ecological groups should be seen as an approximation of the ecological reality intended to facilitate the communication of the results (Table S4). Although widely used, the method has never been found to be perfectly satisfactory (Cameron 1978; Evans 1991; Meyrick & Karrow 2007; Juřičková et al. 2014; Magnin et al. 2022), for species rarely fit strictly into any classification of that kind. It is necessary to discuss the meaning of certain species on a caseby-case basis, even if this flexibility may seem less rigorous. Mollusc assemblage zones have been indicated on the diagrams. The aim of this zonation is to facilitate the description of the stratigraphic distribution of assemblages in each succession. The zone boundaries were defined at first by eye (Meyrick & Karrow 2007; Magnin et al. 2022) and then using the CONISS algorithm with the help of Tilia software version 3.0.1 (Grimm 2011). The two methods yielded comparable results. We have sometimes preferred zonation by eye for rare points of detail. Zones are noted in Roman numerals following the name of the site, e.g. THOM VI. Multivariate analysis, e.g. indirect ordination, is an interesting improvement because the assemblages are ordered only according to their taxonomic content, without *a priori* ecological knowledge. Correspondence analysis (CA; Greenacre 1984; Jongman *et al.* 1995; Legendre & Legendre 1998) is useful for exploring the structure of data tables. The CANOCO 4.5 package was used for computing CA and DCA (Ter Braak & Smilauer 2002). The results of these CAs are presented in Data S1, Figs S1–S3.

#### Results and interpretations

#### MIR-1 La Stèle

Stratigraphy. – The stratigraphy begins with a hydromorphic sediment containing charcoals, and nodules related to secondary carbonation (Fig. 2). This set has more visible soil features in its upper part (level 2, 15 242 to 14 677 cal. a BP). A thick complex of tufa lays unconformably on the preceding ensemble. It starts before 15 075 to 14 364 cal. a BP. It shows oxidation

spots and pedomorphic traits. Two stony layers are interspersed in the tufa, the youngest (level 7) marking a significant break before a final level of tufa. The tufa formation corresponds, up to 6d, 12 725 to 12 625 cal. a BP, to the Lateglacial Interstadial (LGI). The upper stony layer (7) and the last tufa layer (8) are not satisfactorily dated.




Fig. 3. Mir-1 La Stèle molluscan succession. Assemblage characteristics and ecological groups. Plus signs = values less than 1.3%.




Fig. 4. Mir-1 La Stèle molluscan succession. Percentage histogram. Low abundance assemblages in dark grey. Dots = values less than 1.3%.

Stratigraphic distribution of mollusc assemblages. – A total of 16 samples were taken (Fig. 2). The great poverty of samples 1a, 3a and 4 does not seem to be explained by weathering. The shells are not very abundant in general but there are considerable fluctuations (Table S1, Figs 3, 4).

Zone MIR-1 I (assemblages 1a and 1b). Assemblage 1b is dominated by Xerocrassa geyeri, Vallonia pulchella and Galba truncatula. We also find Pupilla muscorum f. bigranata, Granaria variabilis and Abida secale (Clausilia rugosa was present in 1a). This indicates a temporarily waterlogged grassland within a steppe landscape.

Zone MIR-1 II (2–3c). Galba truncatula indicates intermittent flooding. Hygrophilous snails are abundant

(V. pulchella, S. oblonga, small slugs). Clausilia rugosa, X. geyeri and A. secale form the second dominant group, which nowadays is found in grasslands and scrublands from the supra-Mediterranean level and above (Magnin 1989, 1991; Labaune & Magnin 2001, 2002). Malacofauna still indicates a juxtaposition of wet and dry grasslands in a cold environment.

Zone MIR-1 III (3d–5b). Species richness increases gradually. Aquatic (G. truncatula, Pisidium spp.) and marsh species (Vertigo antivertigo, Oxyloma elegans) are developing. Vallonia pulchella is regressing but other hygrophilous species are present (S. oblonga, Cochlicopa lubrica, Vertigo pygmaea). The part of the trio C. rugosa, X. geyeri and A. secale is reduced, but G. variabilis and Punctum pygmaeum are better represented. Jaminia quadridens and Vallonia costata have appeared. This zone is marked by the beginning of a significant development of open wetlands. The context probably is more temperate.

Zone MIR-1 IV (5c–6d). Aquatic and marsh species reach their maximum (G. truncatula, Zonitoides nitidus, O. elegans, V. antivertigo, Vertigo moulinsiana, Vallonia

enniensis and Carychium minimum). The wet meadow species V. pulchella suddenly shows considerable numbers. It is accompanied by S. oblonga and C. lubrica. A new xerophilous species (Truncatellina callicratis) and Cepaea nemoralis have appeared. The marsh has grown considerably. However, there are dry grasslands nearby. Signs of a warmer climate appear to be confirmed.

Zone MIR-1 V (8). The change is dramatic. There are almost no more wetland molluscs. The assemblage is




Fig. 5. Mir-5 Le Verger molluscan succession. Assemblage characteristics and ecological groups.

dominated by T. callicratis, J. quadridens and V. costata. In addition to these three species, there are G. variabilis and X. geyeri. Rare fragments attributable to the cold sensitive species Backeljaia gigaxii give this xerophilic assemblage a temperate climate nature.

Sketch of environmental changes at Le Mirail MIR-1 La Stèle. – At the base of the succession, the local environment is a wet grassland intermittently water-logged (assemblages 1a–3c, between c. 15 000 and c. 14 800 cal. a BP). There are a number of species common in western Provence, both in Pleniglacial deposits and nowadays in open landscapes from the supra-Mediterranean level and above (Magnin 1989, 1991; Labaune & Magnin 2001). The onset of travertine facies (from 3a) does not coincide with a notable change in malacological assemblages. A transition (3d to 5b) then shows the development of wetlands and the coexistence of dry grasslands sheltering more xerophilic species (J. quadridens). Signs of a bioclimatic

improvement appear from level 5c (whose  $^{14}$ C dating to c. 11 200 cal. a BP is too young) to level 6d (12 725 to 12 625 cal. a BP). Nevertheless, the extension of the swamp prevents any more general perception of the landscape. Tufa of level 8 provides without transition a xerophilic and more thermophilic assemblage that indicates an open habitat. This change is commensurate with the strength of the detrital deposit that precedes it (level 7). The  $^{14}$ C dating obtained for this abrupt event is not satisfactory.

#### MIR-5 Le Verger

Stratigraphy. – The lower part of the formation was investigated by backhoe drilling to a depth of 4 m, but its base was not reached (Fig. 2). A first sedimentary ensemble begins with tufa alternating with stony layers (levels –12 to –1b). It is dated to the LGI. A second ensemble probably starts with level 2a. Level 2b is dated to the end of the Boreal period (8760 to 8425 cal. a BP).




Fig. 6. Mir-5 Le Verger molluscan succession. Percentage histogram: terrestrial taxa. Dots = values less than 1%.

This layer stands out with its grey colour and pedomorphic traits. The sedimentation then changes abruptly. Chalky again, it is sometimes interrupted by hints of hydromorphic soils or coarse detrital layers (levels 3–7). From level 8a to level 11a, the sediment is chalky and detrital layers are rare. Structured tufas then develop. They alternate with chalky facies and silty detrital layers, sometimes displaying pedomorphic traits. Only radiocarbon datings reveal a major discontinuity between level 1b and level 2a or 2b, i.e. between 10 960±30 and 7775±65 uncal, a BP.

In the upper part of the section, levels 12b, 12d and 12e contained Late Neolithic sherds. Numerous pottery sherds, flint shards and charcoals in level 14 then testify to a Late Neolithic settlement (5421 to 4989 cal. a BP). The last level of the section (16d) includes sherds dated to Late Antiquity.

Stratigraphic distribution of mollusc assemblages. – Thirtynine samples were analysed (Table S2; Figs 2, 5, 6, S2).

Zone MIR-5 I (assemblages –9 to 1b). The share of aquatic molluscs is extremely low. The same applies to marsh species (V. antivertigo and O. elegans). Wet meadow snails are abundant (up to 40% of assemblage 1b). The two dominant ecological groups are mesophilic species of various habitats and xerophilic species of open habitats. The first group consists of V. costata and P. pygmaeum. There is a relative consensus that

P. pygmaeum is included among the species of varied habitats (Davies & Griffiths 2005; Davies 2008), although it may be attributed to greater preferences for treed ones (Evans 1972: Magnin et al. 2022). The case of V. costata is thornier. This species is classically assigned to the open country or open ground group (Ložek 1964; Evans 1972; Puisségur 1976; Juřičková et al. 2014), but it can be found in open woodlands (Evans 1972; Thomas et al. 1982; Magnin 1991; Martin 2004; Davies & Griffiths 2005; Magnin et al. 2022) and even in marshes (Evans 1972; Davies 2008). It therefore must be given a greater ecological tolerance. Granaria variabilis predominate the second group, accompanied by Pupilla triplicata, J. quadridens and T. callicratis, with also X. geveri, O. annularis and Urticicola sp. Xerocrassa geyeri and O. annularis are currently more montane (Magnin 1989, 1991, 1993b). Among the species of open environments, however, we note the appearance of Candidula unifasciata from level -2, then more thermophilic species from level -1 (*Xerosecta cespitum* and *Monacha cartusiana*). Finally, there are rare fragments of shells and opercula of *Pomatias elegans*, a semi-forest and thermophilic snail.

Zone MIR-5 II (2a, 2b and 3). Aquatic and marsh malacofauna is almost absent and the marsh share is extremely low. Hygrophilous species and P. pygmaeum are poorly represented. We note the importance of dry open habitat taxa and the very relative abundance of the woodland component. The proportion of xerophilic

open ground molluscs is steadily increasing by 44–65%, mainly thanks to G. variabilis which is accompanied by species present from the Lateglacial (X. geveri. P. triplicata, J. quadridens and T. callicratis) and more thermophilic species sometimes reported in the latest assemblages of zone MIR-5 I (X. cespitum, M. cartusiana. Granopupa granum). woodland-dwelling malacofauna is not diverse. With P. elegans (200 shells in 2b), we can find Vitrea contracta (mesophilic species sometimes considered to be woodland; Evans 1972) and V. costata, which appears to be promoted in this case by the development of an open woodland. Zone MIR-5 III (4-8b). A marsh is established from

assemblage 4. It will reach its maximum in zone MIR-5 VI, with a switchback trend, before regressing. In MIR-5 III, the aquatic component increases from 5 to 22%. It is mainly the amphibious snail G. truncatula. Marsh malacofauna fluctuates between 10 and 34%, with C. minimum, V. enniensis and V. antivertigo. \Vallonia pulchella, a damp meadow species, accounts for up to one-third of the malacofauna. The dry open ground and woodland components are reduced. Dry open-ground species (G. variabilis) have low values, except for sample 7, which shows a brief retraction of the marsh. Woodland snails are anecdotal but, for the first time, strictly woodland species occur (Acanthinula aculeata and Merdigera obscura). Punctum pygmaeum, V. contracta and V. costata may be added to this woodland component. The persistence of the last specimens of X. geyeri, P. triplicata and A. secale, three species among the most characteristic of Lateglacial assemblages, is noticeable.

Zone MIR-5 IV (8c and 8d). This zone is characterized by a decrease in abundance and species richness, and a preponderance of marshland snails. In 8c, the small-sized slug plates make up 50% of an impoverished assemblage. In 8d, the aquatic (G. truncatula), marsh (V. enniensis, C. minimum and V. antivertigo) and hygrophilous (C. lubrica) species predominate. In this zone and the previous one, the marsh in which the tufa formed is the most visible environment. Phragmites sp. indet. is abundant within charcoal assemblages (Beauvais & Cazorla *in* Martin 2004). This kind of *Phragmites* meadow acts as a filter so that it is no longer possible to perceive the landscape around the wetland.

Zone MIR-5 V (9). This zone shows the expansion of V. costata and a brief decline in aquatic and marsh components, V. enniensis excepted.

Zone MIR-5 VI (10abc and 10d). The marsh component reaches its maximum before a final switchback regression. Zone MIR-5 VI is roughly the same as the pattern of

zone MIR-5 III. However, the composition of the marsh fauna is changing slightly. Carychium minimum and V. enniensis are downgraded to the benefit of Z. nitidus and V. antivertig. Meadow species V. pulchella is dropping dramatically. The proportion of molluscs from dry open ground is low (G. granum and G. variabilis). Forest dwelling species are absent.

Zone MIR-5 VII (10e and 11a). The aquatic malacofauna is more diverse, with three stygobionts species, molluscs of temporary waters (G. truncatula) and more demanding species (Radix balthica, Ancylus fluviatilis). There is a peak in the marsh species V. enniensis and the return of meadow species (V. pygmaea, V. pulchella). Truncatellina callicratis is among the dry open ground snails. For the first time, the presence of Oxychilus clarus (very abundant) and M. cantiana is observed as potentially woodland species. On the other hand, there are only three shells of P. elegans in 11a.

Zone MIR-5 VIII (11b). The swamp had begun to withdraw as early as zone MIR-5 VI, but there is now a short-lived but particularly marked decline in aquatic, marsh and hygrophilous molluscs. Assemblage 11b is dominated by P. elegans (685 shells) and C. unifasciata (261 shells), which are accompanied by V. costata, T. callicratis and M. cantiana. Stenotopic woodland species are almost absent (two M. obscura shells). This kind of assemblage is currently characteristic of open and immature downy oak stands developed on loose and deep soils. *Granaria variabilis* definitively loses the place it has occupied since the Lateglacial.

Zone MIR-5 IX (12a–12e'). After a short recovery, the swamp resumes its gradual decline. Among aquatic species, only stygobionts remain well represented, especially Fissuria boui. Their presence is linked to the karstic source. The retraction of the marsh temporarily benefits V. pulchella (wet meadow) and C. lubrica (hygrophilous, varied habitats). Pomatias elegans is present but without the overabundant numbers it had in zone MIR-5 V. It is still accompanied by V. costata and M. cantiana, but the strictly forest species are now better represented (A. aculeata, M. obscura, Lauria cylindracea). Carychium tridentatum and O. clarus can be added to this pool despite their larger tolerance.

Zone MIR-5 X (12"-13c). The local environment is unstable, and three phases can be distinguished. The first is Phase a, a peak in dry open ground taxa, particularly C. unifasciata (37% in 12") with V. costata and G. variabilis. Dry herbaceous habitats are therefore expanding significantly in a heterogeneous landscape. This opening may be connected to a nearby Neolithic settlement revealed by a few sherds in levels 12c and 12d. The second is Phase b – in assemblage 13b, the number of V. costata is

impressive (67% of the assemblage). It is likely that this species of varied habitats benefits from the presence of tree cover. Among the woodland species sensu lato, P. elegans does not reach the overabundance observed in zones MIR-5 II and MIR-5 V. It is quite abundant, however, and it is accompanied by notable populations of A. aculeata and M. obscura. Added to this trio is a group of snails often living in woodland habitats: C. rugosa, V. contracta, C. tridentatum, O. clarus, M. cantiana and Nesovitrea hammonis (first occurrence). The malacofauna of dry open habitats is represented almost only by a few C. unifasciata. A marshy biotope is still present, although limited (Z. nitidus, V. antivertigo and C. minimum). Such an assemblage could characterize a fairly closed riparian forest. Third is Phase c – finally, assemblage 13c shows a new incursion of a marshy grassland (Z. nitidus, C. minimum, O. elegans, V. pulchella) and a withdrawal or displacement of the riparian woodland.

Zone MIR-5 XI (14–16c). This last zone shows a strong retraction of wetlands species despite their brief return in level 15. Species of dry open environments are rising strongly (28-79% of the malacofauna, except for assemblage 15). The opening up of vegetation is evident with C. unifasciata whose progression from zone MIR-5 VIII reaches its maximum here. The development of a dry grassland also promotes M. cartusiana, Oxychilus hydatinus and B. gigaxii. The rise of Trochulus hispidus, which appeared on the site a little earlier, denotes the maintenance of a certain humidity culminating in level 15. In addition to O. hydatinus, which was introduced to the region during the Neolithic Period, and T. hispidus, whose populations in Provence seem to be recent, we note the arrival of Oxychilus draparnaudi (synanthropic), but also of humid woodland taxa such as Helicodonta obvoluta and M. plicatula. There is a mosaic dominated by dry open habitats, with a turnover that involves three ecological groups: the dry open ground species, the species of various habitats and the woodland species.

Sketch of environmental changes at Le Mirail MIR-5 Le Verger. – Zone MIR-5 I, at the base of the succession, corresponds to a part of the LGI, between 13 589 to 13 346 cal. a BP (level −9) and 12 983 to 12 770 cal. a BP (level 1b). The malacofauna suggests the juxtaposition of a sparsely swampy meadow and a dry grassland or scrubland. Apart from wet meadow species, these assemblages found today could be supra-Mediterranean open habitats. Thermophilic species appear to develop from assemblage -1 dated at 13289 to 13094 cal. a BP. After a hiatus revealed by the <sup>14</sup>C dating of level 2b (8760 to 8425 cal. a BP), zone MIR-5 II indicates an open and dry woodland. Charcoals (Beauvais & Cazorla in Martin 2004) belong to *Ouercus* sp. (deciduous) with heliophile and thermophilic species such as *Rosmarinus*. The tufa then forms in a temporarily flooded *Phragmites* meadow (zone MIR-5 III). The last species remaining from the Lateglacial disappear here. At the same time, we note the presence of the first stenotopic woodland snails. The preponderance of wetlands increases further in zone MIR-5 IV (7592 to 7275 cal. a BP) before a brief shortening (MIR-5 V). It is in zone MIR-5 VI that the marsh malacofauna reaches its maximum. At that time, we faintly perceive the existence of dry open habitats nearby. Woodlands are undetectable. Zone MIR-5 VII (5577 to 5331 cal. a BP) marks a change in the marsh dynamics. The malacofauna is diversifying and includes more species, suggesting concentrated flows. A riparian forest is developing. The swamp then reduces abruptly (zone MIR-5 VIII), and an open and immature woodland develops, associated with dry herbaceous vegetation. During zone MIR-5 IX, the swamp continues its gradual retreat after a short-lived return. A woodland is maintained next to a marshy meadow. It is more mature than that of the previous zone. We then observe (zone MIR-5 X) a succession including an opening of the woodland, then the return of a riparian forest, and finally the last substantial spread of the swamp. At the top of the section, zone MIR-5 XI shows the definitive reduction of the marsh, a considerable increase in open habitats and a taxonomic turnover, the latter two phenomena being certainly attributable to human activities. Level 14 corresponds to a Late Neolithic settlement dated at 5421 to 4989 cal. a BP, while ceramic shards from Late Antiquity are found in the upper levels (16b, 16c).

#### La Thomassine, Manosque

Stratigraphy. – The deposit begins with a remnant of pseudogleyed sandy silts (S1 level; Fig. 2). It is followed by a set of greyish brown silts containing charcoal and heated pebbles. There are three layers in this set. The first layer (S2; 8362 to 8196 cal. a BP) contains calcareous gravels and some C. nemoralis shells. The second layer (S3), more clayey, contains numerous shells of *P. elegans*. These shells are less abundant in the third layer (S4) at the top of which some tufa begins to appear. We can then observe an alternation of compact tufa with plant imprints (levels 1 and 4) and softer, chalky sediments with a few tufa concretions (levels 2 and 3, c.7500 to 7400 cal. a BP). After a rapid transition through a terrigenous tufa (level 5a0), a detrital event interrupts the development of the tufa. It begins with a stony deposit (5a), continues with massive yellow silts (5b; 6834 to 6671 cal. a BP), then with massive grey silts rich in charcoal (6). The next level (7) is a structured tufa with plant imprints, containing chalky inclusions (7a) and a stony layer (7b). The sedimentary succession ends with a terrigenous tufa (8; 4854 to 4656 cal. a BP).

Discreet evidence of human activity has been found at three spots in the stratigraphy. In the S2 level (Late




Fig. 7. La Thomassine molluscan succession. Assemblage characteristics and ecological groups. Plus signs = values less than 1%.

Mesolithic) it is a combination of charcoal, charred fruit fragments and heated stones. A single pottery fragment was then found in level 5a while levels 5b and 6 yielded splinters of burnt bones, heated pebbles, very fresh flint shards, numerous charcoal fragments and rare charred cereal seeds (*Hordeum vulgare* var. *nudum*). These levels correspond to an Early-Middle Neolithic settlement in the neighbourhood. Finally, level 8b gave up charred cereal seeds (*Hordeum vulgare*) as well as flint shards and fragments of rammed earth and pottery that come from a settlement of the Late Neolithic.




Fig. 8. La Thomassine molluscan succession. Percentage histogram. Dots = values less than 1%.

Stratigraphic distribution of molluscs. – Seventeen samples were taken (Figs 2, 7, 8, S3; Table S3).

Zone THOM I (assemblage S1). The open ground species G. variabilis and J. quadridens predominate. Other species in this group are X. geyeri and G. granum, along with rare X. cespitum and B. gigaxii. That is 80% of the assemblage. There is also a share of mesophilic and woodland species such as C. nemoralis, O. clarus, P. pygmaeum, P. elegans, A. aculeata and M. obscura. It is questionable whether at least some of these rare woodland species do not belong to the upper layers, in the same way as the dated charcoal fragments. It is an assemblage of dry grassland, with some trees. Xerocrassa geyeri is a Lateglacial relic that will be present in small numbers as far as zone THOM VI. If the shells of X.

cespitum, B. gigaxii and P. elegans were in place, their presence would argue in favour of a dry but not cold climate.

Zone THOM II (S2, S3 and S4). There is a gradual decline of open ground species in favour of P. elegans whose shells form a concentration in level S3 (422 shells). There are C. nemoralis, a few A. aculeata and large slug plates. However, open-habitat species remain well represented (17–48%). Oxychilus clarus is developing. Marsh (O. elegans, Z. nitidus, C. minimum and V. antivertigo) and hygrophilous molluscs (V. pygmaea, Euconulus sp., P. pygmaeum, C. lubrica and C. tridentatum) begin to develop at the end of this zone, at the same time as the tufa. This is an open woodland that remains dry until S4.

Zone THOM III (1, 2 and 3). Galba truncatula accompanies the development of marsh and hygrophilous species (O. elegans, V. pulchella, C. lubrica and C. tridentatum). Mesophilic snails are also more abundant (O. clarus, P. pygmaeum and Vitrinidae sp. indet.); they often have woodland preferences. The numbers of P. elegans are high, with also many A. aculeata, a stenotopic woodland species. Monacha cantiana is present. This snail is currently common with P. elegans in open woodlands. The proportion of dry open ground snails is still 10–30% (G. variabilis, T. callicratis and M.

cartusiana) but M. cartusiana, occasionally hygrophilous, could indicate here the development of a Phragmites meadow. There is a change in the nature of the woodland, which would be a riparian forest. This evolution began as early as S4, at the end of THOM II.

Zone THOM IV (4b and 5a0). In a first step (4b), the marsh malacofauna increases (G. truncatula, C. minimum, V. enniensis and V. antivertigo) as well as the hygrophilous component sensu lato (Euconulus sp., S. oblonga and V. pygmaea). Monacha cartusiana seems to be related to this change and the existence of a Phragmites meadow. In a second phase the marsh malacofauna declines, unlike the species that can be linked to the riparian woodland (P. elegans, A. aculeata, M. cantiana, V. contracta, O. clarus and C. tridentatum). Vitrea contracta, V. luberonensis and V. pusilla occur at the site for the first time. Dry open-ground molluscs still account for 10-20% of the malacofauna (excluding M. cartusiana because of its ambivalent meaning). There is a mosaic of environments including a moist meadow, a riparian woodland and drier open habitats, components that move spatially or whose proportions vary over time.

Zone THOM V (5a–6). The proportion of dry open ground snails is increasing (40% of assemblage 5b; G. variabilis, J. quadridens, T. callicratis, B. gigaxii and C. unifasciata). The meaning of M. cartusiana is still ambivalent. Woodland snails are declining, but there is a renewal in assemblage 6 with P. elegans and M. cantiana. Actual forest species are accidental (A. aculeata, V. pusilla and V. luberonensis). Mesophilic species and species from various habitats are well represented: O. clarus, P. pygmaeum, Vitrinidae sp. indet. and V. costata. There is a drop in the abundance and

richness of wetland molluscs. The opening of woodland is significant in this zone, which also corresponds to a withdrawal of the marsh. A slight woodland recovery is noticeable in level 6.

Zone THOM VI (7a–8a). The aquatic and marsh fauna reach its maximum. Aquatic molluses culminate in assemblage 8a (Pisidium spp. and G. truncatula). They still characterize temporary waters. Marsh snails account for one-third of the malacofauna in assemblage 7a and this proportion decreases to assemblage 8a (17%). These are O. elegans, Z. nitidus, C. minimum, V. antivertigo and V. moulinsiana. The peak of C. lubrica (7a, 7b) is related to the marsh context. Species with forest preferences are declining, including P. elegans. However, A. aculeata and mesophilic species such as O. clarus and P. pygmaeum persist. They may indicate the presence of a riparian woodland. Dry open-habitat species are also regressing, especially in levels 7a and 7b. Granaria variabilis remains the dominant species in this group along with C. unifasciata and J. quadridens. This zone is characterized by the importance of the marsh, the surrounding environment being hardly visible. As for level 8a, there is at the same time a reinforcement of the aquatic functioning and a decrease in ambient moisture around the stream.

Zone THOM VII (8b). There are almost no marsh species, except O. elegans which lives at the water edges. A species of running water (Ancylus fluviatilis) was found for the first time. Hygrophilous species are rare, as well as species with woodland preferences (P. elegans). It is the dry open-habitat component that is on the rise: M. cartusiana, C. unifasciata, X. cespitum and O. hydatinus, the latter species having been introduced to the region during the Neolithic (Magnin *et al.* 2022). Flows are now concentrated within a drier, more open environment.

Sketch of environmental changes at La Thomassine. - At the base of the section (THOM I; S1), the dominant species reflect a steppe and a temperate climate. A hiatus possibly separates this thin sedimentary remnant from the next layer. An age of c. 9000 cal. a BP is conceivable given what has been described in the Aix-en-Provence region (Magnin et al. 2022). The brown silts of zone THOM II were deposited in a dry open woodland. At their base (S2), a radiocarbon measurement indicates the end of the Mesolithic (8365 to 8193 cal. a BP). The presence of charcoal, charred fruit fragments and heated pebbles suggests an anthropogenic impact. The context becomes wetter in the S4 level which contains the first signs of the tufa formation that will follow. The first tufa (level 1) is dated to the very end of the Mesolithic or the very beginning of the Early Neolithic (8362 to 8196 cal. a BP). Its appearance may simply be a consequence of a lateral migration of the stream. The increase in local humidity leads to a change in vegetation that now resembles a riparian forest associated with a Phragmites meadow (THOM III; levels 1-3). This tufa and associated sediments were deposited very quickly, as shown by the similar dates obtained in levels 1 and 3, c. 7450 cal. a BP. During zone THOM IV, the vertical and lateral variations of facies are related to the evolution of a mosaic comprising a Phragmites meadow, a riparian forest and drier open biotopes. Zone THOM V then marks a radical change in sedimentation and the environment. A detrital deposit is set up in a context of decline of the swamp and of woodland, while dry open environments expand. Nevertheless, an open woodland is soon reconstituted (level 6). Artefacts and other indices in levels 5a-6 indicate a nearby settlement during the Early-Middle Neolithic (6834 to 6671 cal. a BP). There is then a tufa with plant imprints, which develops in a Phragmites-type meadow, possibly together with

a riparian woodland (THOM VI; levels 7a–8a). The formation of this important tufa in the sequence begins c. 6674 to 6496 cal. a BP and continues beyond 6445 to 6309 cal. a BP. The last zone (THOM VII; level 8b) is characterized by a concentration of running water in an overall drier and more open landscape. Small fragments of rammed earth and pottery as well as charred cereal seeds indicate a settlement of the Late Neolithic (4854 to 4656 cal. a BP).

#### Discussion

The Lateglacial snail communities and their environmental significance

Lateglacial deposits are particularly thick in the Mirail valley. Mostly carbonated, including stony layers, they correspond for the most part to the LGI. The two earliest dates would place the base of the MIR-1 succession at the end of the Oldest Dryas. The top of this same succession is probably attributable to the Younger Dryas. The Lateglacial terrestrial malacofauna is rich with 33 taxa to which we can add the amphibious species *G. truncatula*. These taxa can be split into three main clusters (Table 2).

Cluster I is more or less the malacofauna of the loess-like silts ascribed to the Würmian Pleniglacial in the south of the Rhone valley and western Provence (Mazenot 1956; Bourdier 1961; Bonifay 1962; Granier 1976; Magnin 1989, 2014). It is characterized by its low species richness and its homogeneity, except for slight intra-regional variations. It is more xerophilic and, at first glance, more temperate than that of the more northerly loess (Mazenot 1956; Granier 1976; Magnin 1989). As in the north (Limondin-Lozouet & Antoine 2001), the LGM malacofauna of SE France

has suffered a dramatic impoverishment. It has spared only a small number of xerophilic and climate-tolerant species which today have a wide altitudinal distribution. Only two species (*O. annularis* and *X. geyeri*) are nowadays confined to montane refuges. Changes in their geographical distribution, nevertheless, are not a strict and unequivocal response to climate variations (Magnin 1991, 1993a, b). In short, the basis of the Lateglacial malacofauna of the Luberon is a direct legacy of the LGM malacofauna, with a better representation of less xerophilic species that were previously characteristic of the mid-Rhone valley.

Cluster II includes hygrophilic, marsh and amphibious species. It is a substantial group that contains only common species with a wide geographical distribution. Such a component is not determined solely and directly by climate. Local factors can play a significant role. Therefore, it is not easy to distinguish between local factors and climatic fluctuations to explain the increase of wetland species.

Cluster III includes taxa that are rather cold sensitive. More than half of them are of Mediterranean origin. Candidula unifasciata is an exception as it reaches about 2300 m a.s.l. in the Alps (Magnin 1991; Boschi 2011). The other species in this group are thermophilous (X. cespitum, P. elegans, M. cartusiana and B. gigaxii). However, except for *P. elegans*, the case of which will be discussed later, these taxa occur only in the most recent Lateglacial levels of MIR-5, near the major unconformity brought to light in the stratigraphy. Being scarce and often poorly preserved, these shells are probably intrusive Holocene elements. While some succession in Basse-Provence seem to corroborate such Lateglacial ages for several of these species (Magnin et al. 2022), other data would indicate a later development, between 11 500 and 10 000 cal. a BP (Magnin, in prep.).




Fig. 9. Summary of the Lateglacial molluscan succession on the southern slope of the Luberon mountain range (MIR-9 according to Ollivier (2006) and unpublished data).

The growth of the hygrophilic and marsh components (cluster II) is the most distinctive feature of the Lateglacial malacofauna here studied. It probably arises from LGM wetlands, which were certainly very localized, for there are no examples of marsh malacofauna attributable to this period in the region. These hygrophilous species are primarily an indicator of the local moisture budget. Interpreting the gradations observed within the Lateglacial malacofauna in terms of climate and vegetation structure is challenging (Fig. 9).

Oldest Dryas and Oldest Dryas/LGI transition. – The assemblages of at least the first two zones of the MIR-1 succession, with low species richness, including X. geyeri, C. rugosa and A. secale, resemble those of the Pleniglacial loess. Only the presence of hygrophilous species sensulato distinguishes them from the communities that nowadays live on the ridges of Mont Ventoux or Montagne de Lure ~1800–1900 m a.s.l., in dry grasslands and scrublands with stunted Juniperus and Pinus (Magnin 1989, 1991). Although no strict indicator

species can be found, the climate was possibly cold but less arid than during the LGM. The dates obtained on levels 2 and 3d of MIR-1 would place the two malacological zones MIR-1 I and MIR-1 II - or even the beginning of zone MIR-1 III – at the end of the Oldest Dryas. Zone MIR-1 III appears to be a transition, the real change in malacofauna being placed at level 5a. Sedimentary signs of warming related to the LGI – such as pedomorphic traits and the onset of calcareous tufa, as early as level 3a – would therefore precede both the accepted age for the beginning of the LGI (i.e. 14 700 cal. a BP) and changes in malacofauna. In the French Massif Central, Ponel et al. (2016) present two examples in which an increase in lacustrine productivity and an expansion of Juniperus and Salix predate the age of 14 700 cal. a BP. We may have the same situation here. As for the changes in malacofauna in our case, it would not be surprising if they occurred with a delay compared with vegetation and the shift in morpho-sedimentary dynamics. Unfortunately, there is a lack of dating in the middle part of MIR-1 section, especially within zone MIR-1 III.

Allerød. – This is first marked, during zone MIR-1 III, by an increase in species richness. This increase benefits on the one hand a set of rather xerophilic species of open environments, and on the other hand the palustrine and hygrophilous species whose number varies according to local conditions. A small number of species from various habitats also contribute to this enrichment. The malacofauna of northern France similarly shows an increase in species richness, but a shift towards drier conditions, although with regional nuances (Limondin-Lozouet & Antoine 2001). This general trend towards more drought is less evident in the south. Up to 12 700 cal. a BP, the malacofauna is globally richer in hygrophilous taxa than that of the Pleniglacial loess. This assumes at least a high moisture budget and probably more precipitation. However, the variations within the LGI may only have a local basis depending on the hydro-geomorphological context. This is possibly the case for the marsh event MIR-1 IV, which is not found in the MIR-5 succession located further upstream. Several pollen records support the evidence of a general north to south climatic gradient showing a climate steadiness or warming in southern Europe during the Allerød (Combourieu-Nebout et al. 2009; Ponel et al. 2016). The arrival here and good representation of a snail like J. quadridens could be a weak sign of a less severe climate. Such an interpretation has been proposed for older assemblages in Provence that would correspond to climate improvements during MIS 3 (Magnin 1991, 1992, 2014). Nowadays this species is relatively thermophilic (Germain 1930) but there are notable exceptions in the Alps where it can reach 2400 m a.s.l. (Aubry 2003; Boschi 2011). An interpretation of the malacofauna in terms of temperature therefore remains complex. There is little contrast in the observed changes, not necessarily because climate did

not change, but potentially, following the LGM, because of the reduced pool of species both available and in equilibrium with the new environment. Almost all taxa locally available for recolonization during the LGI are climate tolerant. Moreover, the diversity of distributions nowadays observed, from one mountain range to another, highlights the multiplicity and complexity of the drivers of these distributions, which are not restricted to climatic factors (Magnin 1991, 1993a; Aubry 2003; Aubry *et al.* 2005).

In the western Mediterranean area, according to some authors, the LGI would correspond to the development of a deciduous oak forest, with Mediterranean taxa, at the expense of steppe vegetation (Pons & Reille 1988; Combourieu-Nebout *et al.* 2009; Delhon *et al.* 2010; Ermolli *et al.* 2022). Only 50 km SE of the Luberon, the Allerød seems to be characterized by the juxtaposition of several types of vegetation: a riparian forest around the pollen site, a pioneer vegetation with *Pinus* and *Juniperus*, and a mesophilic vegetation including *Quer-*

while abundant cus, steppe taxa remain (Nicol-Pichard 1987). Towards the Rhone Valley, in a less sheltered area, this steppe character remains very pronounced (Triat-Laval 1978). Regarding Mediterranean France in general, Beaulieu et al. (2005) describe the dominant landscape of the LGI as a wooded steppe with abundant Juniperus and Pinus and only scattered stands of deciduous oaks. In our study of the Luberon, the malacofauna seems to show that the vegetation cover staved steppe-like during the entire LGI. No forest species have been added and the species regarded as semiforest, always accidental, are either potentially assignable to other ecological categories (C. nemoralis) or of doubtful origin as is the case with P. elegans, the most common and least demanding woodland-dwelling species in Mediterranean France (Pfenninger 2002). Only a very few residual *P. elegans* shells were recovered from the Lateglacial deposits of sections MIR-1 and MIR-5. These are probably reworked. Indeed, in another section of the Luberon dated on charcoal c. 12 000 uncal, a BP,

this kind of fragment gave a  $^{14}$ C measurement of 43  $100\pm730$  uncal. a BP, much too old to be attributed to a limestone effect (Magnin, unpublished data). Biases that may be related to the presence of residual, worn nepionic shells of *P. elegans* are common (Evans 1972; Carter 1990).

As in England or northern France (Preece & Bridgland 1998; Limondin-Lozouet & Antoine 2001), the climatic improvement of the LGI has not led to any development of woodland snail communities in SE France. This could be due to the distance from refugia and the resultant delay in colonization. The problem is whether the late-glacial malacofauna that we describe strictly contradicts the existence of the forest reconquest described by several authors, or whether it may be transient, disequilibrium communities that can tolerate a certain tree cover. Almost all taxa that make up the basis of the Lateglacial malacofauna are usually classified in open country groups with the exception of several species which belong to the mesic or various habitats group, suggesting that they may be found in woodlands or at least tolerate lightly wooded habitats (Ložek 1964; Puisségur 1976; Juřičková et al. 2014). Near the sections here studied (Mont Ventoux and Luberon; Magnin 1991; Labaune & Magnin 2001, 2002), P. pygmaeum would be a shade-loving species showing a preference for woodlands and a tree cover greater than 25%. Abida secale and C. rugosa tend to have a clear preference for low tree cover (<10%), although they may live in more closed habitats. Several species classified in the open country group, including P. triplicata and V. costata, occasionally colonize more closed habitats (Magnin 1991; Magnin et al. 2022). Even X. geyeri, Pyramidula pusilla, G. variabilis and O. annularis can tolerate a tree cover up to 40% at most. Only *J. quadridens* (and presumably *P.* muscorum, which has not been studied) would not tolerate a tree cover of more than 10% (Magnin 1991). Such adaptability, even at a regional scale, is important to highlight. It shows that the classification in ecological groups of species considered as stenotopic should not obscure their potential plasticity that particular environmental contexts may reveal.

Finally, a strong regional heterogeneity must be considered. In the Pleistocene site of Pont-de-Mirabeau, less than 20 km SE of the Mirail valley, on a north-facing slope, malacological assemblages first attributed to the LGM on the basis of their composition and stratigraphic position (Magnin 1991, 1992) were definitively dated to the Allerød (13 039 to 13 617 cal. a BP, Ollivier *et al.* 2014). Dubar (1983) already noted that the loess malacofauna in the Durance valley varies according to the local geomorphology and topography, which can affect local climate and environment. Magnin (2014) concluded that the physiographic diversity of the region during the LGM prevents the possibility of a reliable biozonation, inter-site variability being possibly greater than intra-site. Such a phenomenon may be valid for the LGI.

Younger Dryas. – Probably referable to the Younger Dryas, zone MIR-1 V, which follows (or includes) a torrential event, reflects a rapid and severe aridification that could be due to a drastic decrease in precipitation. This evolution towards aridity agrees with regional pollen data (Nicol-Pichard 1987). Unlike what has been observed in northern France or in Britain (Preece & Bridgland 1998; Limondin-Lozouet & Antoine 2001), there is no indication of a cooling.

The laborious and incomplete reassembly of Holocene woodland communities

Early Holocene. — At the beginning of La Thomassine succession, the steppe malacofauna of THOM I may be weakly polluted by more recent forest-dwelling species. Otherwise, such an assemblage is compatible with those described at Aix-en-Provence c. 9000 cal. a BP, which would indicate a wooded grassland (Magnin et al. 2022).




Fig. 10. Summary of the Holocene molluscan succession on the southern slope of the Luberon mountain range.

Apart from this poorly dated assemblage, which could correspond to a primary stage of woodland recolonization, the first Holocene assemblages appear to be already established woodland assemblages (2a and 2b for MIR-5 and S2 for La Thomassine). The oldest are those from zone MIR-5 II (c. 8550 cal. a BP) (Fig. 10). Compared to the rest of the MIR-5 succession, they are characterized by their xerophilic nature, by the importance of molluscs of open habitats, and by the development of only two or three species that prefer a woodland cover. Among these species, the importance of *P. elegans* is remarkable. The conditions must have been particularly favourable for its development, with a moderately moist, loose soil and an aerated foliaceous litter. These same conditions may have promoted V. contracta and V. costata, which live in a variety of habitats and are not regularly woodlanddwelling species. In short, only the success of *P. elegans* can be thought of as a woodland development. Despite the length of time between Lateglacial and Holocene deposits, there has been virtually no taxonomic enrichment other than this species which seems to have begun to disperse during the Preboreal (Magnin, in prep.). It is surprising that species that are common in woodlands and potentially available here from the LGI have not benefited from woodland recovery (A. secale, P. pygmaeum, C. rugosa and C. nemoralis).

Middle Holocene. — At La Thomassine, the assemblages of zone THOM II, dated to c. 8000 cal. a BP, characterize an open woodland, a deciduous oak forest as indicated by charcoal analysis. Compared with the Early Holocene assemblages (MIR-5 II), they include, alongside a very abundant population of P. elegans, more strictly woodland species: A. aculeata, M. obscura, C. nemoralis, O. clarus and C. tridentatum. In the Mirail valley, the presence of these species can be observed in zone MIR-5 III, which could be synchronous with zone THOM II, but their presence is almost anecdotal in assemblages for they

are suddenly and durably overshaded by wetland molluscs. A new and final enrichment in woodland species occurred at La Thomassine between c. 7500 and c. 6600 cal. a BP, first at the very beginning of zone THOM III (P. pygmaeum, Vitrinidae sp. indet. (Phenacolimax major?) and M. cantiana) and then at the beginning of zone THOM IV (V. pusilla, V. luberonensis, V. contracta and Euomphalia strigella). In the Mirail succession, it is only at c. 5500 cal. a BP, i.e. at the end of the Atlantic, that O. clarus and M. cantiana appear, and finally we can observe during Late Antiquity the arrival of new, hygrophilic woodland-dwelling species (M. plicatula and H. obvoluta) within an assemblage from open environment whose heterogeneous constitution is the result of a new, complex landscape structure. The two successions of La Thomassine and Le Mirail (MIR-5) thus show phase shifts in the postglacial recolonization by woodland taxa. For the most part, the assembly of woodland snail communities on the southern slope of the Luberon take place during the Atlantic period, between c. 8000 and c. 6600 cal. a BP at La Thomassine, but up to c. 5500 cal. a BP at Le Mirail. This interval does not exclude later adjustments at Le Mirail, but also and

especially on the Ubac site (northern slope of the Petit Luberon), where the most completed woodland assemblages date from the Early Bronze Age, c. 4000 cal. a BP (Martin & Magnin 2002; Martin 2004; Bizot & Sauzade 2015).

Boycott (1934) remarked that woods as such have no characteristic fauna. From an autoecological point of view, woodland species are a heterogeneous assortment, few of which are restricted to woodland (Cameron & Redfern 1972; Evans 1972; Cameron 1978). Our present analysis is based on a broad definition that includes both stenotopic woodland species and those that, living in varied habitats, are nowadays commonly found in woodlands in Mediterranean France. In total, in the two Holocene successions MIR-5 and La Thomassine, there would be at best a dozen stenotopic woodland species, most of them being rather rare. This usual poverty of woodland snail assemblages, which seem immature in view of the classic belief of a primeval high forest during the Mesolithic and part of the Neolithic (Battentier 2022), has already been described in the Aixen-Provence basin (Magnin et al. 2022). This contrasts with diversity hotspots nowadays detected here and

there, but likewise in the Holocene, when they also are observed patchily during unexpected, sometimes late time periods (Renault et al. 1996; Berger et al. 2000; Martin 2004; Bizot & Sauzade 2015). The pattern is thus: large, low-diversity areas vs. local, high-diversity hotspots. In general, woodland malacofaunas vary greatly among themselves, even in the same area, with a nestedness of species distribution at different scales (Cameron & Pokryszko 2004; Hylander et al. 2005; Horsák et al. 2014: Cameron 2016). Most often, the underlined factors relate to the quality of the habitat or the poor dispersal ability of certain species. To this must be added the fragmentation of the species distributions produced by the LGM, then the impact of human activities. This later factor may have slowed down the colonization by forest species from the Neolithic onwards in central Europe (Horsák et al. 2019). It must have been all the more effective in the Mediterranean region where it was early added to other constraints such as summer drought.

At site level, the reassembly of postglacial woodland communities in the Luberon does not follow a linear way. Furthermore, it does not completely coincide with the higher proportion of woodland snail shells in the assemblages, nor with the regional woodland cover optimum as recorded by palaeobotanical surveys. It is likely that the dispersal ability of woodland snails, usually low (Baur & Baur 1988; Pfenninger 2002; Hylander 2011; Cameron 2016; Barbato *et al.* 2020a, b), is responsible for the complexity of the observed patterns. In our diachronic approach, it is probable that we observe situations of non-equilibrium as a consequence of more or less random dispersal in a changing environment.

The postglacial colonization by woodland snails in the Mediterranean region: a parallel history to temperate Europe?

Part of the modern malacofauna of temperate Europe would be influenced by its postglacial spread from traditional southern glacial refugia (Limondin-Lozouet & Preece 2014; Juřičková et al. 2014). So far, a comparison between southern and temperate Europe has been complicated owing to very uneven data sets and a sparse knowledge of mollusc successions of southern (Juřičková Europe etal. 2014). Although southern Europe is characterized by an extraordinary physical and biological diversity, our results concerning the French Mediterranean area can allow to assess the contribution of putative southern macrorefugia to the Holocene dynamics of forest snails in temperate

The first postglacial appearance of woodland snails is informative. It is most often delayed in the French Mediterranean area. *Pomatias elegans* plays a key role in this region as a pioneer woodland species, either

in Holocene successions or along recent secondary successions (Magnin & Tatoni 1995; Magnin et al. 2022). It is a cold-sensitive snail with a Mediterranean and western European distribution. Its extremely discreet presence in the Lateglacial deposits, c. 13 000 cal. a BP, remains to be verified. More certainly its spread started c. 10 000 cal. a BP (Magnin, in prep.). first in a steppe landscape, with populations still reduced c. 9000 cal. a BP (Magnin et al. 2022), then reaching an overwhelming place in open-woodland assemblages from the end of the Boreal period (c. 8550 cal. a BP). Absent in central Europe (Juřičková et al. 2014), P. elegans appears in Holocene successions in Luxembourg c. 9200 cal. a BP (Granai et al. 2020), in Normandy between c. 10 200 and c. 9500 cal. a BP (Limondin-Lozouet & Preece 2004; Limondin-Lozouet et al. 2005) and in Britain c. 8450 cal. a BP (Preece & Bridgland 1998). These dates attest to quasi-simultaneous colonizations between the south and the north. Yet above all, P. elegans was not a pioneer species in temperate Europe, which experienced an earlier colonization by more strictly forest taxa. A first colonization wave happened in these regions c. 11 300 cal. a BP near the Western Carpathian refugium (Juřičková et al. 2018; Frodlová & Horsák 2021) and 1000 years later westwards (Horsák et al. 2020). In all these successions, a sharp increase in the colonizing species occurred at the transition from Preboreal to Boreal periods, i.e. while the malacofauna of the Mediterranean region was still largely steppe-like. At least 70% of all forest species appeared before 8200 cal. a BP in temperate Europe (Horsák et al. 2020) while the forest malacofauna of SE France generally remained poorly diversified at that time. Among the species that contributed to the development of the forest malacofauna during the Early Holocene in the continental and Atlantic regions of temperate Europe (Limondin-Lozouet & Preece 2004; Limondin-Lozouet et al. 2005: Juřičková et al. 2014: Horsák et al. 2019, 2020; Granai et al. 2020), there is a pool of species in common with the malacofauna of Mediterranean France. In this last region, however, such species generally appeared at least 1000 years later (M. obscura) or have remained confined, sometimes until the present day, in sites with propitious conditions (e.g. Discus rotundatus, Aegopinella pura, Sphyradium doliolum). The case of *Discus rotundatus* is revealing. The appearance of this species at the beginning of the Holocene, in the successions of temperate Europe, corresponds to the development of the forest component in the malacological assemblages, between c. 10 200 and c. 9500 cal. a BP (Preece 1997; Meyrick 2001; Limondin-Lozouet & Preece 2004; Limondin-Lozouet et al. 2005; Granai et al. 2020). This common European species, which lives in moist litter under deciduous forests, is absent from the Holocene successions of the Luberon (this paper) and those of Aix-en-Provence (Magnin 1991; Magnin et al. 2022). In the Mediterranean

region, its populations are generally localized, nowadays and throughout the Holocene. This patchy distribution testifies to a difficult colonization or recolonization. This is due to the combination of factors already mentioned: severity of a cold and dry LGM, low dispersal ability, aridity of the Mediterranean bioclimate, age and intensity of anthropization. The case of *D. rotundatus* applies to the majority of strictly forest species in Provence, excepting the more widespread *M. obscura* and *A. aculeata*.

All these observations further weaken the hypothesis of a Holocene colonization of temperate Europe by coldsensitive forest snails from southern - or at least Mediterranean - macrorefugia via the Rhodanian corridor, contrary to the pattern described for other interglacials (Rousseau 1989, 1992; Limondin-Lozouet et al. 2020). They add to the increasing collection of evidence which demonstrates the importance of northern refugia for forest snails (Juřičková et al. 2014, 2014; Horsák et al. 2019, 2020). Furthermore, the Mediterranean region itself has not benefited from the macrorefugia that it would have sheltered or with which it would have been close. As in the case of temperate Europe, local, scattered microrefugia probably largely contributed to its recolonization by forest species. The survival without expansion of Retinella olivetorum in the vicinity of Aix-en-Provence, since the last interglacial (Magnin et al. 2012), is direct evidence of such microrefugia.

#### Evaluating the structure of Holocene woodlands

Evaluating the structure of Holocene woodlands is a critical issue given the difference in perception that may exist between pollen analysis and some other proxies when it comes to reconstructing the structure of Holocene woodlands (Mitchell 2005), particularly in Mediterranean Europe (Grove & Rackham 2001). Fortunately, habitat structure is a key factor to explain land snail distribution and abundance (Magnin 1991; Magnin & Tatoni 1995; Labaune & Magnin 2001; Menez 2007), including that of woodland (Barbato et al. 2020a, b; Gheoca et al. 2023). Assemblages of terrestrial molluscs therefore have a valuable potential to reconstruct the structure of Holocene local stands (Preece et al. 1986; Mitchell 2005), in addition to palaeobotanical data which provide information on vegetation composition (Battentier 2022), often at a larger scale.

At the end of the Boreal (MIR-5 II), the malacofauna indicates an open woodland in a dry context (Fig. 10). Charcoal analysis shows this is a deciduous oak stand (Beauvais & Cazorla *in* Martin 2004). The woodland interpretation of snail assemblages is mainly deduced from the abundance of *P. elegans*. It is difficult to determine whether the absence of stenotopic woodland species is due to the open structure of the vegetation or to the delayed assembly of the woodland snail communities

on site. It is therefore, above all, the importance of open ground snails – potentially the anti-woodland species of Boycott (1934) - that may indicate the degree of openness. However, it would be necessary to determine to what extent the species assigned to the open ground category are really anti-woodland species. This category is dominated by G. variabilis, a species common in the loess of Provence and abundant in the Lateglacial deposits of Le Mirail. It is clearly a saxicolous and xerophilous snail, not sun-sensitive (Germain 1930: Welter-Schultes 2012). Nevertheless, as already noted, it sometimes tolerates a significant tree cover (i.e. woody plants > 2 m), up to 30 or 40% (Magnin 1991). In this zone MIR-5 II, the peak of abundance of *V. costata*, another recognized open ground snail, which occasionally lives in woodland (Evans 1972), coincides with that of P. elegans and therefore is probably linked to the presence of a woodland. In addition, there does not appear to be a significant herbaceous cover, otherwise species such as C. unifasciata or X. cespitum (and even X. geyeri) would be better represented.

At the beginning of the Atlantic (c. 8000 cal. a BP), the woodland at La Thomassine - always a deciduous oak woodland - appears progressively more closed and moister. Granaria variabilis still dominates the open ground component, but the diversity of woodland species is greater. This reflects a more advanced recolonization but also, most likely, a complex habitat structure. This development is still increasing in zone THOM III corresponding to the Early Neolithic. Holocene assemblages are then comparable with those that can be observed nowadays, downstream from the site, in the thalweg occupied by a mosaic of complex woody stands (i.e. 30–40% high woody plants; 15–20% low woody plants) and narrow Phragmites meadows (Magnin, unpublished data). It is during this period, c. 7500 to 7400 cal. a BP, that the woodland cover appears to reach its greatest complexity, even if the canopy does not seem to be very closed. On the northern slope of the Petit Luberon, the optimum was reached c. 7880 cal. a BP with an open woodland, which became even more open and drier from c. 7570 cal. a BP (Martin & Magnin 2002; Martin 2004). This same woodland optimum is found further south, in Aix-en-Provence, between c. 8000 and c. 6700 cal. a BP (Magnin et al. 2022). In these sites, the successions are comparable with those of the Luberon, but the assemblages included, as early as 7000 cal. a BP, rare shells of xero-thermophilic and synanthropic Mediterranean snails (e.g. Cernuella virgata). After this optimum, at La Thomassine, despite the growth of the swamp, we can observe a decrease in woodland cover which proceeds in fits and starts. In the Mirail tufa (MIR-5), on the other hand, it is impossible to describe the structure of the woodland during the maximum development of the swamp. It is only from zone MIR-5 V, at the end of the Atlantic period, that we can attempt to glimpse it. Malacological assemblage 11b

(c. 5470 cal. a BP) dominated by P. elegans, C. unifasciata and V. costata evokes an immature woodland, of the park-woodland type, sufficiently open to promote a good cover of herbaceous vegetation. This depleted assemblage has similarities to those of the Late Boreal, but the praticolous C. unifasciata here replaces the saxicolous G. variabilis. After this stage, snail assemblages first show the return of a riparian woodland, i.e. a wetter habitat with a more complex structure. It is then substituted by a drier and more open park-woodland vegetation, with a dominant herbaceous layer (base of zone MIR-5 X). To some extent, it is a reproduction of zone MIR-5 VIII, but with a more open horizontal structure. The discrete reappearance of a riparian woodland then constitutes, c. 5000 cal. a BP, the last woodland occurrence in the MIR-5 succession.

Our results correlate well overall with those accumulated over decades by palaeobotanists (Battentier 2022). In terms of structure of the woodlands at their optimum, they provide some clarifications and things to consider. If the beginning of the Early Holocene, before 8500 cal. a BP, is represented in the successions here studied, it can only be at the base of La Thomassine section (THOM I) whose assemblage indicates a more or less wooded steppe vegetation consistent with the anthracozone 1b of Heinz and Thiébault (1998). This period, characterized by a sandy-silty sedimentation, is better represented elsewhere in Basse-Provence where it predates pre-forest stages (Magnin et al. 2022). The Late Boreal oak woodland (MIR-5 II) stays open and immature. To qualify it, open woodland seems more appropriate than forest, which some authors use in the sense of primeval forest, i.e. mature forest (Battentier 2022). Later, between c. 8000 and c. 7400 cal. a BP, woodlands reached their optimum at the end of a succession promoted by a more humid environment. This result confirms the evolution described in the Aix-en-Provence area (Magnin et al. 2022). It is consistent with regional palaeobotanical data (Triat-Laval 1978; Thiébault 1997; Delhon 2005; Delhon et al. 2010; Battentier et al. 2018; Battentier 2022). Surprisingly, however, even during this optimum, the canopy is quite open, with probably less than 50% cover.

## Identifying imprints of human activities on snail communities and habitats

Land snails are sensitive to changes induced by human activities. They are first indirectly affected by the modification of their habitats at the station scale (Evans 1972; Magnin & Tatoni 1995; Labaune & Magnin 2002; Hylander 2011; Douglas *et al.* 2013) but also by changes at the landscape level (Magnin *et al.* 1995; Aubry & Magnin 2005). Furthermore, community composition can be directly modified by the development of synanthropic species whose passive dispersal is facilitated, and which are often introduced either

intentionally or accidentally (Magnin & Martin 2012; Nurinsiyah et al. 2016). In Holocene successions, the causal relationship between environmental change and anthropogenic disturbance may be difficult to establish (Preece et al. 1986). This can be considered in two ways: (i) when malacological assemblages indicate changes in the structure of plant formations that cannot be explained by the known amplitude of climatic variations (Magnin & Martin 2008); and (ii) when introduced or clearly synanthropic species develop. In both cases, the presence of archaeological data or other evidence of human activities is a corroborating argument.

In the Mirail (MIR-5) and La Thomassine successions, snail communities and their habitats seem to be impacted by human activities on several occasions (Fig. 10). The open and immature features of woodlands during the Late Boreal and Early Atlantic raise questions. On the one hand, the malacological assemblages could express the logical proceedings of a succession influenced by a climatic trend from dry to wetter conditions between c. 8550 and 8000 cal. a BP. The woodlands of zone MIR-5 II, particularly open and dry, seem to be the succession stage following the steppe landscape that persisted in Basse-Provence until c. 9000 cal. a BP (Magnin et al. 2022). As for zone THOM II of La Thomassine, it would represent the woodland optimum we have described. However, the related sediments are rich in charcoal (deciduous Quercus dominant) and contain heated pebbles and reddened soil aggregates that evoke fires or the emptying of hearths. The possibility of a local human impact must be considered. Even if the impact of Mesolithic huntergatherers on the landscape has long been controversial (Roberts et al. 2018) and is generally considered to be minimal, this hypothesis should not be completely rejected. It could partly explain the relatively open structure forest stands at their optimum. Elsewhere in Provence, at Tourves, a human impact has been detected by pollen analysis at 7880 cal. a BP, while beetle assemblages do not record it (Nicol-Pichard 1987; Andrieu-Ponel & Ponel 1999). Several studies have revived the debate in continental Europe and Great Britain (Innes & Blackford 2003; Bishop et al. 2015; Dietze et al. 2018; Heidgen et al. 2022). On SE Iberian Peninsula, Sánchez-García et al. (2024) suggest, from the coincidence of the highest charcoal accumulation rates with Late Mesolithic activity, even during periods of predominance of oak forest, that hunter-gatherer communities transformed the landscape by burning woodlands. Further investigations are needed to assess this hypothesis in Provence.

At La Thomassine, the first signs of woodland opening attributable to anthropization appear at the end of zone THOM III (during the Early Neolithic, c. 7450 cal. a BP). They continue in zone THOM IV. The impact of human activities becomes conspicuous in zone THOM V during which a clear decline in woodland coincides with a

detrital accumulation containing uncountable charcoal fragments, together with some artefacts and other evidence of human activities. This episode is attributable to the Early-Middle Neolithic, 6834 to 6671 cal. a BP. Open woodland vegetation then quickly regenerates (level 6). In the Mirail valley (MIR-5), it is only from the Late Neolithic, c. 5470 cal. a BP, that the malacological signal of anthropization becomes clear, but it is also at the moment when the reduction of the swamp area begins, allowing the observation of a wider environment. Earlier assemblages already included a few snails indicating the existence of open, dry habitats at the edge of the swamp. This presence of a xerophilous malacofauna in the Atlantic may be an indication of anthropization. Although discontinuous, the progress of *C. unifasciata* from zone MIR-5 VIII to the end of the succession is a much more significant element, this species being nowadays dominant in the dry grasslands of the Grand Luberon below 900-1000 m a.s.l. (Labaune & Magnin 2002). The development of C. unifasciata occurs in three increasingly pronounced pulses. Initially (zone MIR-5 VIII), we probably are in the presence of a parkwoodland with an abundant herbaceous layer. This episode shortly preceded the appearance of the first shards of Neolithic pottery. During the next pulse (zone MIR-5 X), anthropization interrupts the return of the riparian woodland for a while. Anthropization is even clearer after a Late Neolithic settlement dated at c. 5160 cal. a BP. In the same way, the Late Neolithic period at La Thomassine is characterized, c. 4800 cal. a BP, by a progression of species from dry open environments, including O. hydatinus, a species introduced to Provence during this period. Finally, in the Late Antiquity assemblages of the Mirail section, open ground snails account for more than 75%. With this last stage (zone MIR-5 XI) a threshold is crossed. The artificialization of the landscape and its heterogeneity are suggested by the miscellaneous nature of the malacofauna, which includes synanthropic species (O. draparnaudi), humandispersed mesophilic species (T. hispidus), open ground species (introduced O. hydatinus), and even some stenotopic woodland snails. This pattern has already been described in the Aix-en-Provence region (Bonnet et al. 2020; Magnin et al. 2022).

In the two successions studied here, anthropization stages highlighted by the malacofauna are in line with the regional evolution described by palaeobotany (Battentier *et al.* 2018; Battentier 2022). Anthropization remained discrete and difficult to characterize during the Early Neolithic. In the Middle Neolithic, a major erosive event associated with a significant opening of woodland is highlighted at La Thomassine. From the Late Neolithic period, in the two sites, human impact is evident. It coincides with changes in the composition of snail communities. In the Tourves wetland, 50 km SE of the Luberon, it was also during the Late Neolithic that human impact led to a drastic environmental change

recorded by beetle assemblages (Andrieu-Ponel & Ponel 1999). However, there are substantial differences, regarding the malacofauna, between the sites in Haute-Provence and those of Basse-Provence, only 40 km further south. Around Aix-en-Provence, malacofauna reveals a more marked anthropization of the landscape from 7000 or 6500 cal. a BP (Magnin et al. 2022). In addition, most of the synanthropic species so characteristic of anthropization and landscape opening in Basse-Provence and Languedoc (Martin 2004; Martin et al. 2005; Magnin & Martin 2012; Magnin et al. 2022), are absent from the Luberon successions. This is the case of *C. virgata*, an emblematic synanthropic species that has been present near the coast (Châteauneuf-les-Martigues) since the Early Neolithic (7227 to 7165 cal. a BP), and which appears at Aix-en-Provence at the same time (7336 to 7247 cal. a BP). These regional differences may be explained by a lower intensity of human impact in the Luberon during the Neolithic. They are also due to a less Mediterranean character, the regional malacofauna being affected by a strong biogeographical gradient towards the SW (Magnin & Tatoni 1995; Kiss et al. 2004). The singular palaeoenvironmental dynamics reported at Martigues from the Early Neolithic onwards thus represent an extreme situation in which the climatic and edaphic conditions near the coast of western Provence would not have allowed the deciduous oak forest to become dominant (Battentier et al. 2020; Battentier 2022).

#### Conclusions

Study of these three mollusc successions, on the edge of the southern Alps, fills a gap in our knowledge of the Quaternary malacofauna of the French Mediterranean region. The Lateglacial malacofauna is described for the first time. Its most prominent feature, compared with Pleniglacial, is the important development of hygrophilic communities. Despite an increasing species richness and some signs of warming and increasing humidity, interpreting climate variations from the malacofauna is challenging. The same applies to the evolution of vegetation cover. Changes are not contrasting and the impoverished communities, mainly inherited from the LGM, may be transient and unadjusted. Nevertheless, even in the hypothesis of nonequilibrium communities, it is not conceivable to interpret LGI assemblages as compatible with the deciduous oak woodland mentioned by some authors. They are, however, compatible with a patchy steppe landscape with some restricted wetlands. Younger Dryas would reflect a severe aridification without cooling.

The reassembly of forest snail communities has been laborious throughout the postglacial. It did not take advantage of the glacial refugia that the Mediterranean region sheltered. Compared with northern Europe, the first strictly forest species appeared 1000 years later.

Their number first increased c. 8000 cal. a BP, then several times until the beginning of the historical period. This recolonization was affected by temporal shifts between sites and a great spatial heterogeneity. This resulted in a pattern of large, low-diversity areas vs. local, high-diversity hotspots still observed today. Early anthropization and Mediterranean aridity have been added here to other constraints already recognized in temperate Europe, e.g. impoverishment and fragmentation of communities owing to the LGM, distance to refugia, low dispersal ability and variations in habitat quality.

Regarding woodland cover during the Holocene, our results correlate well overall with the timing obtained by palaeobotanists. However, the structure of these woodlands seems to have remained quite open, even at their optimum c.7500 to 7400 cal. a BP.

Likewise, anthropization stages pointed out by the malacofauna are in line with the regional evolution described by other proxies. A local impact of Mesolithic hunter—gatherers should not be rejected pending further evidence. Anthropization was low in the Early Neolithic but became more evident during the Early-Middle Neolithic, and more extensive from the Late Neolithic. The consequences of human activities on snail communities and vegetation are less pronounced in the Luberon than in Basse-Provence (Magnin *et al.* 2022), possibly owing to a reduction in aridity. The high variability of the Mediterranean region makes further studies on the Alpine and eastern borders of the French Mediterranean region essential.
